UNEA and OECPR Basics

- * Responds to the call made at Rio+20 to strengthen and upgrade UNEP as the "leading global environmental authority"
- Highest political forum for global environmental issues
- * First session on 23-28 June 2014 at UNEP HQ in Nairobi
- OECPR being held as the PrepCom to the UNEA
- OECPR to advance negotiation of decisions for adoption by UNEA
- * UNEA HLS themes: "SDGs and the Post-2015 Development Agenda, including Sustainable Consumption and Production"; Ministerial dialogue on "Illegal Trade in Wildlife and Timber"
- Registration: 97 countries (34 without missions in NBO); 278 participants (147 from outside NBO)

OECPR mandate (paragraph 9, Decision 27/2)

- (a) Contributing to the preparation of the agenda of its governing body;
- (b) Providing advice to its governing body on policy matters;
- (c) Preparing decisions for adoption by its governing body and overseeing their implementation;
- (d) Convening thematic and/or programmatic debates
- (e) Promoting effective ways and means to facilitate participation of the non-resident members of the Committee, particularly from developing countries
- (f) Performing any other functions delegated to it by its governing body;
- () Mandate given by 19/32

United Nations Environment Assembly (UNEA)

- Universal membership
- Meets biannually starting in June 2014
- Concludes with a 2-day high-level segment

Committee of Permanent Representatives (CPR)

- Subsidiary organ of GC in 1997 mandated given by 19/32
- Subsidiary inter-session body of the UNEP's governing body to perform functions of the GC decision 27/2

UNEA Functions (GC 27/2)

- (a) Setting the global environmental agenda;
- (b) Providing overarching policy guidance and defining policy responses to address emerging environmental challenges;
- (c) Undertaking policy review, dialogue and exchange of experiences;
- (d) Setting the strategic guidance on the future direction of the United Nations Environment Programme;
- (e) Organizing a multi-stakeholder dialogue.

UNEA in 2014

- * First UNEA session to set the tone for subsequent sessions
- Issue a powerful message to the world on behalf of all Ministers of Environment
- Inform the discussions in UN HQ in New York on the Post-2015 Development Agenda and SDGs development – to ensure the integration of environmental dimension and integrated approach
- * Highlight the environmental costs of illegal trade in wildlife and timber, an issue that is witnessing increasing global attention and action
- * Discuss issues of critical environmental significance (i.e. green economy and rule of law) with diverse actors

Expected outcomes of UNEA-1

Decisions:

- * on budget and programme of work for 2016-2017 (revision for 2014-2015)
- on preparation of UN system wide strategy on environment (strategy ready by 2016)
- on starting the process of midterm review of the Montevideo Programme IV (review ready by June 2015)
- on preparation of Global Gender and Environment Outlook 2016
- * on preparation of international water quality guidelines for ecosystem services by 2016, omnibus chemicals decision
- outcomes of HLS on the Post-2015 Development Agenda /SDGs and on illegal trade in wildlife
