Highlights from the First Day

- Great commitment initiation project. Key involvement Gov. China (MEP –NERC– & MIIT), National Quality Supervision Testing Center for Paint & CNCIA
- Steps-steps manner: baseline situation and awareness raising with gradual phase out of lead in paint at all industry levels and participation of different ministries
- Good understanding Project & its components. Linkages
 Lead Paint Alliance (phase out of lead paint by 2020) and its
 tools e.g. documents, toolkit, UNEP's ref. docs, etc.
- Existing legally binding controls (GB) and 13th 5-year industry plan (1016-2020)
- Presentations of some challenges of the elimination of lead paint e.g. paint industry, lack of knowledge and public awareness
- Chinese Coatings Industry: Significant contribution (28% to the Global coating industry total volume 2015 and its growth). Lead replacement already taken place


Highlights from the First Day (Cont.)

- Recognition of some lead contained coatings produced (mostly concentrated in SME that could be accounting for ~ 50% (?)
- Excellent laboratory facilities, analysis control (soluble/total) and QA
- Suggested visit of the international expert (Component 1)
- Project workplan adjustments to be further discussed (Components)
- Further discussion on what a "strategy" (Component 2 & 3) could include
- Linkages and lessons learn from current GEF African project and south-south key cooperation and exchange of information
- Complementary support & participation: UNEP (3 Divisions) and BCRC
- Upcoming possible opportunities for GOVs –including China- to discussed C & W issues, including Pb and Pb in paint (UNEA2 – May 2016), 11th ICWMT11 (Oct. 2016) and LPA's international week of action




Group Discussion: Path Forward on Project Activities (Component 1)

- National market survey (paint categories, brands, locally manufactured in China, province distribution, uses –domestically?, variety of paints produced by industry and SMEs (brands/manufactures)
- Site survey: identification of mix-paint industry productions, including SMEs (Linkages with Component 2: Target 10 paint manufacturers)
- Market analysis and sample testing (define brands, paint categories, colors, testing method(s) soluble vs. total lead content, workplan for testing and budget considerations, reporting (90,600, 1000 ppm)
- Suggested guidance from international expert
- Survey & technical report (including QA)






Group Discussion: Path Forward on Project Activities (Component 2)
