- Establishing a national program.
- Make the law.
- Establishment of national working group.
- Promotion of awareness creation of hazards of lead paint.
- Will form a working group and an action plan on how to incorporate SMEs into the programme.
- Try to adopt the tool out to the country.
- Follow up on discussions with various individuals/organizations.
- Find a way to keep up-to-date on discussions/actions of the Global Alliance to Eliminate Lead Paint Advisory Committee.
- Produce guidance of sensibilization for BEP/BET.
- Certificate the manufacturers of the paints.
- Awareness of the consumers for the paints.
- Develop draft standards for test of lead in paint.
- Revise the lead level of 100 ppm and soluble lead to 90 ppm total lead.
- Become a partner in Lead Paint Alliance.
- Engage paint industry in assessing lead levels in the paint in order to eliminate in the paints.
- To oversee that the East African community.
- Awareness raising stakeholder involvement.
- More data collection.
- Engage policy makers and implementers so that they can play their roles.
- Survey on paint companies to assess levels of lead in the paints produced in the country.
- Awareness of the public on the dangers of lead in paint.
- National laws follow up.
- Increase awareness to political leaders, parliamentarians especially.
- Start and/or increase dialogue with industry.
- Work with the EAC country partners to establish a standard for lead in paint.
- Engage my government to ensure that the issues of lead are incorporated in the draft chemicals regulation.
- Advocate for clear limit of 90 ppm in all paints.
- More awareness raising among decision makers based on additional source economic, health and environmental benefit of action from this workshop.
- Inventory to identify the level of lead in paint placed in local market.
- Sensitizing the decision makers about the health and environment impact of lead paint.
- Sensitize authorities to the basis of the information received.
- Utilize the toolkit.
- Initiate the development of regulation.
- Giving awareness about the impact of lead in paint in my living compound.
- Give advice about the environmental clubs awareness about lead in paint.
- Creating a form for court to develop laws, regulations, and follow up its implementation by different stakeholders.
- Develop country level strategic plan.
- Encourage regional workshops in S. America and Asia.
- Awareness raising at different level with different stakeholders such as decision makers/manufacturers/NGOs/media on impact on health, impact on the environment.
- Data and information collection (on paint, industry, if any cases).

- Identifying SMEs and engaging them by personalizing the issue because they are not known and do not have any trade unions.
- De-briefing the government/focal point and forging ahead from there.
- This workshop will only be fully successful if it leads to action at the sub-regional and national level to facilitate follow up actions and resources.
- Engage various stakeholders including policy makers, industry, and the media to dialogue awareness revising.
- Improve upon the feasibility by testing more samples.

10. Please suggest any additions or comments on the Lead Paint Alliance Regulatory Toolkit.

- Leaded paints are real danger that it is necessary to take urgent action.
- Guidance handbooks should be made available for easy understanding.
- To improve on the financial mechanisms to assist countries.
- Establish mechanism for people to suggest changes/additions etc. to parts of the toolkit.
- Add brief summary of countries with lead paint content restrictions, when they become effective, whether paint sampling since effective date had been performed and results.
- Produce the guidance of reference and integrate the certificate.
- Lack of a model draft law.
- Include website for any possible donors of lead.
- I think it's a very useful tool for gathering information on lead as most countries may not know where to start
- The toolkit is almost comprehensive it only requires piloting to test the validity in the country of use.
- Have not used it.
- Awareness examples.
- Sample regulation.
- Regulation model that will help for harmonization of regulations at regional or sub-regional level
- Monitoring and evaluation component needs to be incorporated in the toolkit.
- Develop a module on the management of decommissioned lead paints and lead pigments through industry voluntary action or entry into force of a national law.
- The toolkit was good but I think it will be more useful if it is in a form of manual or guidelines because more information can be written than just having a power point format. It covers all important aspects of lead paint.
- The toolkit should be a major document of eliminating lead in paint in each countries.
- Additional case studies needed to reflect broader regional efforts and a diversity in approach.
- It's satisfactory.

11. Please suggest any improvements that you would suggest to the sub-regional Workshop agenda if a similar workshop were to be conducted again in future.

- Provide copies of the texts relating to the eliminations lead paint.
- Structure and operationalizing national working groups understanding the need for resources and personnel to initiate sustainable.
- The logistical arrangements to be done on time.
- Some session chairs seemed to not control time used in sessions with open-ended topics. This may have resulted in other sessions being pressed for times.
- The workshop can be in USA, Australia, or Philippines for where existing case studies and visit the BET/BEP on manufacturers products the paint without lead limits 90 ppm 100 ppm.

- Have enough time to the group discussion.
- The agenda is very heavy, too much to learn for three days.
- Include many stakeholders as possible.
- Testing labs should have been invited to attend.
- More discussion time on country activities to learn from each other.
- Probably key stakeholders from each region should be represented. Otherwise the participation is excellent.
- Timely information on travel, letters to help acquire visa on entry; DSA to be ready in good time.
- Future workshops should consider organising a field activity to paint facturing industry or industries to enable or to facilitate a hands on experience.
- More discussion time allocated.
- An outcome summary distributed to participants at the end of the workshop.
- Include some lawyers or legal officer of environmental departments to have the real potential per country to push for a quick regulation to establish.
- More country representation should be considered.
- Bring a model legislation/regulation/standard as benchmark.
- Proposal for regional legal frame work prepared by two or three countries should be in place during the
 workshop for discussion by participant. If this happens, it will be a practical step towards having regional
 legal frame work.
- Making court to be strong on law formation and implement it at each redaction in lead in paint factory.
- Solicit region-specific presentations with a focus on actions that have been or will be taken.
- Agenda number wise very condense for two days and this type of workshop is very important as it is both technical, and experience sharing.
- Leave time to consolidate outcomes supported by all meeting participants. This workshop did not spend time summing up common elements of the group discussion and developing an "agreed meeting outcome".
