Introduction

- 1. In accordance with the Procedures and Mechanisms on Compliance under the Barcelona Convention and its Protocols and the Rules of Procedure of the Compliance Committee, the 14th Meeting of the Compliance Committee of the Barcelona Convention and its Protocols will be held in Athens, Greece, on 27-29 June 2018.
- 2. Documentation will be provided in English and French. As per practice, pre-session documentation will not be distributed on paper. Participants are encouraged to download the documentation on their computers in advance of the session.

- 5. Agenda item 4: Cooperation with other Compliance Procedures and Mechanisms of Multilateral Environmental Agreements

- 9. To strengthen cooperation with the Compliance Procedures and Mechanisms established under other Multilateral Environmental Agreements, representatives of the London Convention, the General Fisheries Commission for the Mediterranean (GFCM) and the Basel Convention Compliance Committees have been invited to present the work of their Committees, including work in dealing with national reporting.
- 10. The Compliance Committee is expected to **take note of** the information presented and **comment**, as appropriate.

- 11. The Secretariat will introduce the status of reporting under Article 26 of the Barcelona Convention (UNEP/MED CC.14/4). The Compliance Committee is expected to **consider** progress made and **provide guidance** on how to further support Contracting Parties in fulfilling their reporting obligations under Article 26 of the Barcelona Convention.
- 12. At the recommendation of the Compliance Committee at its 13th Meeting, the Secretariat, together with the relevant MAP components, prepared an updated version of both the synthesis analysis (UNEP/MED CC.14/5) and general status of progress (UNEP/MED CC.14/Inf.5). This is complemented by the assessment of the information contained in both documents as regards the Barcelona Convention and the Protocol concerning Specially Protected Areas and Biological Diversity in the Mediterranean (UNEP/MED CC.14/Inf.4), as carried out by a Member and an Alternate Member of the Compliance Committee. The key findings of the assessment are presented in document UNEP/MED CC.14/6.
- 13. The Secretariat will introduce the updated synthesis analysis, thus setting the framework for the presentation of the key findings by Ms. Selma Osmanagić-Klico and Ms. Milena Batakovic.
- 14. The Compliance Committee is expected to **examine** the updated synthesis analysis together with the key findings and **provide guidance** on how to progress work on this matter.

- 15. In preparation for the 13th Meeting of the Compliance Committee, three Members of the Compliance Committee and two Alternate Members tested the draft Guidelines for the Preliminary Assessment of Reports to Identify Actual or Potential Cases of Non-Compliance against three national implementation reports corresponding to the reporting period 2014-2015.
- 16. The results of the testing, as presented to that meeting, are re-submitted in document UNEP/MED CC.14/7, as well as the tests carried out intersessionally, which are compiled in the information documents UNEP/MED CC.14/Inf.6 and UNEP/MED CC.14/Inf.6/Add.1. In addition, the Draft Guidelines for the Preliminary Assessment of Reports to Identify Actual or Potential Cases of Non-Compliance are presented in document UNEP/MED CC.14/Inf.7 for reference.
- 17. The Secretariat will present the results of the testing of the draft Guidelines. The Compliance Committee is expected to **consider** them and **advise** on any additional action to take.
