INTRODUCTION

The proposed programme budget is built on the achievements and lessons learnt of the programme of work implemented during the current biennium, medium term sectorial strategies adopted by the Contracting Parties to implement different protocols, activities related to the mandate of the Secretariat, the implementation of decisions expected to be adopted by the 16th Meeting of the Contracting Parties in November 2009 as well as recent development in the regional and global context relevant to MAP. It also takes into account the need for adaptation to new developments of MAP relevance in the region.

The overall programme of work focuses on established priorities. The programme budget is organized in sections that reflect activities of the Secretariat and the components contemplated by the provisions of the Barcelona Convention and its Protocols as well as tasks undertaken by the Secretariat in accordance with the decisions of the Meetings of the Parties. The presentation follows the proposed template set out in the Governance paper (Decision IG 17/5) and Decision IG 17/18 on the Programe of work and budget 2008-2009.

The focus during the next biennium will be in the following directions:

- Strengthening the overall governance system of MAP in order to make the work of the Coordinating Unit, the ECP, MEDPOL and the RACs more effective and integrated
- Moving further from a piecemeal to a more integrated, coherent and strategic approach with regard to regional cooperation policies of MAP and its components by identifying and formalizing cost-effective cooperation and partnership with key and strategic partners
- Strengthening the role and impact of the MCSD and MSSD implementation in the region.
- Further implement the Almeria Declaration by assisting the Contracting Parties to anticipate
 the effects of climate change in the Mediterranean region and to promote adaptation and
 mitigation measures.
- Making fully operational and effective the established compliance procedures and mechanisms with a view to assisting and encouraging the Contracting Parties to address to the Compliance committee any difficulties arising during the implementation of the Convention and its Protocols.
- Assist Contracting Parties in their efforts to de-pollute the Mediterranean, and halt biodiversity
 loss by implementing pollution reduction actions and hot spots elimination, as well as
 measures to protect endangered species and their sensitive ecosystems. Further work will be
 carried out to identify potential sites on the high seas that may meet the requirement to be
 proposed as SPAMIs.
- Assist the Contracting Parties to prepare the grounds for the implementation of the new ICZM protocol expected to enter into force in 2010.
- Promote the implementation of sustainable production and consumption policies practices and tools in the region in the field of the application of the Convention and its protocols as well as MSSD.
- Implementing activities envisaged in the new GEF Strategic Partnership project that are
 expected to offer greater opportunities for more integration with the work of the Secretariat
 and MAP components as well as for sufficient assistance to the Contracting Parties to achieve
 sustainable and concrete results.
- Improving the efficiency of the system by rationalizing and prioritizing expenditures

To compliment the proposed programme of work, the Secretariat and the Components have been successful in mobilizing important external resources from GEF, AZAHAR, FEEM and the EC.

The ordinary contributions to the MTF have not increased in the last two bienniums. The effects of the continued contributions freeze in the MAP system, if further maintained, may seriously threaten its ability to comply with its current and future obligations. Three main reasons underlie this opinion.

Firstly, new responsibilities have been entrusted to MAP. Most recent commitments by the Contracting Parties expanding the MAP Programme of Work which increase the responsibilities of the

Secretariat include, amongst others: enlarging the cooperation on integrated coastal zone management by adopting a new legal instrument; the entry into force of the amendments to the LBS protocol; adoption of compliance procedures and mechanisms; implementation of the MSSD; improving integration among MAP components and the whole MAP system governance aiming at enhancing actions on the ground. Properly addressing these challenges require new resources.

Secondly, the budget freeze dilutes MAP components cooperation precisely at a time that the Contracting Parties are expecting greater integration and coordination in the implementation of the MAP Work Programme. The lack of resources forces each and all MAP Components to individually look for external sources of funding which weakens the MAP global joint approach sought by the Contracting Parties through the establishment of a "healthy and strong Mediterranean Trust Fund (MTF)" and further emphasized in decision IG 17/5 on the MAP Governance adopted by the Contracting Parties in Almeria.

Thirdly, the erosion in the value of contributions has led to the use and depletion of the operational reserve for implementation of regular activities under the approved Programme of Work as observed by the OIOS report. Increases in the cost of living during these seven years have already absorbed the value of the 2003 contributions raise due to the change of currency of reference from Dollars to Euros. This is illustrated, inter-alia, by annual inflation rates which vary every year from 2 to 10% in the Mediterranean countries, a 12% increase in personnel cost and an average increase by 45% in the overall cost of meetings since 2004.

In conclusion, the improvement of the financial situation of MAP requires an increase in the ordinary contribution of the Contracting Parties at least by 5 %, the adjustment of contributions in accordance with annual inflation rate and the maintenance of a trust fund operational reserve.

I. COORDINATING UNIT

I.1 Legal framework

Mandate: The Secretariat functions as provided for in articles 17 and 14 of the Barcelona Convention, MAP Phase II, Governance Paper and other Decisions of the Meetings of the Contracting Parties.

Goal:

To ensure that the 1995 Barcelona Convention and its seven Protocols are further strengthened as an effective legal basis for cooperation and actions by the Contracting Parties towards sustainable development in the Mediterranean in the framework of the Mediterranean Action Plan of UNEP

Objectives:

- To achieve widespread ratification by the Contracting Parties and entry into force of the Barcelona Convention and its Protocols;
- 2. To facilitate the operation of MAP, the Barcelona Convention and its Protocols, its Secretariat, the Meeting of the Contracting Parties and its organs in a manner consistent with the provisions of the Convention and its Protocols and with rules of procedures
- 3. To facilitate the provision of assistance to Contracting Parties upon their request in pursuance of the implementation of the Convention and legal and administrative aspects of the implementation of the Protocols, as provided for in the mandate of the Coordinating Unit, decision IG.17/5 on the "Governance Paper"
- To enhance compliance by the Contracting Parties with their obligations under the Barcelona Convention and its Protocols:
- 5. To enhance the capacity of the Contracting Parties to take measures with regard to the legal, administrative and enforcement aspects of the implementation of the Barcelona Convention and its Protocols as well as the MAP Guidelines on Liability and Compensation adopted by the 15th Meeting of the Contracting Parties, 2008.

Entry into force

The existing delay in the process of ratification of some Protocols results in a complicated legal situation that may directly affect progress on the whole process of implementation of the Barcelona Convention and its Protocols.

There is also a need to further promote the Convention and its Protocols and related achievements in order to encourage the Parties to ratify and implement them, in particular the new ICZM Protocol.

The Secretariat will also disseminate information on activities carried out under the Convention and its Protocols as a tool to further promote their implementation on the regional and national level.

Compliance

With the expected adoption of the rules of procedure for the Compliance Committee, the Compliance Committee will become fully operational during the forthcoming biennium.

Funds will be provided for the convening of at least one meeting per year of the Compliance Committee, starting in 2010, to facilitate the participation of all members and/or alternates, when necessary, and to provide support to the Committee in order to carry out the following functions and activities:

- a) Provision of assistance to the concerned Contracting Parties in implementing the recommendations of the Committee and/or the Meetings of the Contracting Parties, in order to facilitate compliance;
- b) preparation of studies, assessments, criteria, analyses and any other working and/or information documents which would enable the Committee to carry out its functions, to apply

- its rules of procedure and to suggest recommendations and means to the concerned Contracting Parties and the Meetings of the Contracting Parties;
- Publication of the draft guide brochure on compliance procedures and mechanisms under the Barcelona Convention and its Protocols in Arabic, English and French for the general public;
- d) Preparation of the MAP webpage on compliance and implementation in close cooperation with the MAP information Unit at Coordinating Unit and the concerned components.

Reporting on implementation

With a view to implementing decision IG 17/3 of the 15th Meeting of the Contracting Parties on reporting and complementing it with reporting on the effectiveness indicators expected to be approved by the 16th Meeting of the Contracting Parties in November 2009, the following activities are proposed for the forthcoming biennium:

- (a) A regional assessment report including the legal, administrative and enforcement aspects of implementation of the Convention, its Protocols and recommendations and decisions of the Meeting of the Contracting Parties will be prepared on the basis of the information and technical data provided by the Contracting Parties in their 2006-2007 and 2008-2009 national reports. MAP components will participate in and contribute to the preparation of such an assessment.
- (b) The Secretariat will communicate and disseminate the main findings and achievements related to implementation by means of different tools, in particular the MAP website. This initiative will also help to raise the profile and the visibility of MAP and its legal instruments and their added value for the protection of the marine environment and sustainable development in the Mediterranean region.
- (c) Further work is needed to put in place and further upgrade the online MAP reporting system in the framework of the MAP Info System and to develop a full and complete electronic database on the information provided by the Contracting Parties through their national reports on the implementation of the Convention and its Protocols and decisions of the meeting of the Contracting Parties. As reported in the progress report, the on line MAP reporting system is undergoing a testing period. The Focal Points have made pertinent suggestions with a view to making the system more user-friendly, adding new functions and improving some of its technical aspects. INFO/RAC is expected to work with full support from the Secretariat in this direction in order to upgrade and improve the whole system and hence meet the needs of the Contracting Parties.

The reporting format for the implementation of the ICZM Protocol will be finalized by establishing and working in thematic working groups as suggested by the meeting of the PAP/RAC Focal Points. The activity will be jointly coordinated by the Secretariat and PAP RAC and the draft format will be submitted for approval to the Meeting of the Contracting Parties in 2011.

Assistance to Contracting Parties in implementing the Convention and the decisions of the Meetings of the Contracting Parties:

In accordance with Article 14 of the amended Convention, assistance will be provided to Contracting Parties upon request to develop national legislation implementing the Convention and its Protocols. Such assistance will be provided on the basis of:

- The recommendations of the Compliance Committee;
- The recommendations of the regional assessment report on implementation of the Barcelona Convention and its Protocols for the 2004-2005 and 2006-2007 bienniums;
- The specific needs and requests of the Parties.

As reported in the Progress reportthe third meeting of the Working Group on Guidelines for the Determination of Liability and Compensation for Damage resulting from Pollution of the Marine Environment in the Mediterranean Sea Area that was convened in Athens on 22 and 23 January 2009 approved a mid-term programme of action for the implementation of the Liability and Compensation Guidelines.

The information available on the national situation with regard to the implementation of the Guidelines shows the wide gap between countries in terms of the provisions adopted and institutional and other capacities. In view of this situation, a gradual and step-by-step approach is needed for the implementation of the Guidelines, allowing for the necessary transition period to build the required capacities, where necessary. In accordance with the step-by-step approach, concerted action should now be taken to commence the implementation of the Guidelines as follows:

- (a) Further research with regard to: the international instruments on liability and compensation that are most relevant to the situation in the Mediterranean; the constraints that have prevented countries from ratifying them more widely; and the areas that are not covered by such instruments, but which lie within the scope of the Barcelona Convention and its Protocols and should therefore be covered by a Mediterranean liability and compensation regime;
- (b) the development of means to ensure effective access to information by the public;
- (c) the evaluation of the products available on the insurance market; and
- (d) a feasibility study for a Mediterranean compensation fund.

I.2 Institutional governance

I.2.1 Main institutional meetings, coordination, strategic planning, executive direction, implementation and monitoring, resource mobilization

Mandate:

The Secretariat's functions as provided for in articles 17, 18, 20 and 27 of the Convention, rules of procedures for meetings and conferences of the Contracting Parties, decisions of the Meetings of the Contracting Parties.

Goal

To formulate, implement and deliver, under the overall direction of the Meetings of the Contracting Parties and its Bureau, the biennial and five-year MAP programmes of work in an efficient, timely and effective manner through effective coordination and integration among MAP components under the guidance of the Secretariat.

Objectives

- 1. To provide appropriate facilities, logistics and substantive support to ensure that the 17th Meeting of the Contracting Parties, the meetings of the Bureau and the meetings of other bodies established under the Convention and MAP are conducted effectively;
- 2. To ensure efficient, effective and timely delivery of the programme of work of MAP for the 2010-2011 biennium and to contribute to the five-year programme of work
- 3. To increase the positive feedback from the Contracting Parties and other partners on the substantive and organizational support provided by the Secretariat;
- 4. To bring about better coordination among the Secretariat, the RACs and MEDPOL with a view to effective implementation of the programme of work;
- 5. To ensure long-term planning and preparation of a realistic and sustainable programme of work for the 2012-2013 biennium and a five-year rolling programme of work 2013-2018.

(a) Preparation and delivery of the 17th Meeting of the Contracting Parties and its organs

According to Articles 17, 18 and 20 of the Barcelona Convention and the chapter on institutional arrangements of MAP Phase II, the Secretariat has the responsibility of organizing the Meeting of the Contracting Parties every two years as well as the meetings of the subsidiary bodies of the Convention including the meetings of the Bureau. The 17th Meeting of the Contracting Parties is scheduled to be held in 2011 and will address issues in line with the provisions of Article 18 of the Barcelona Convention. Other institutional meetings which are the responsibility of the Secretariat, include:

- 1. Meeting of the MAP Focal Points in 2011;
- 2. Three meetings of the Bureau of the Contracting Parties at six-monthly intervals;
- Four meetings of Executive Coordination Panel (ECP) to ensure better coordination between the Secretariat and the MAP components as indicated in the Governance Paper and the ToRs of the ECP approved by the Bureau of the Contracting Parties.

Implementation of the Governance Paper

The implementation of the requirements and provisions of the Governance Paper adopted by decision IG 17/5 of the 15th Meeting of the Contracting Parties and of draft decision IG 18/3 on the mandates of the RACs and MED POL represents a real challenge for the Secretariat and the other MAP components. In this respect, a number of activities will be undertaken by the Secretariat and MAP components, under the guidance of the Bureau of the Contracting Parties.

As outlined in the "Progress Report by the Secretariat for the 2008-2009 biennium" (UNEP(DEPI)/MED WG.337.3) a financial and management audit of MAP was carried out during 2008-2009. The recommendations of the audit report require the Secretariat to undertake important measures to improve the financial management of MAP in several areas.

In the light of the above recommendations and of the requirements of the Governance Paper, a number of activities are being proposed for implementation during the forthcoming biennium through the ECP, such as:

- Drafting a Resource Mobilization Plan,
- Elaborating a methodology to prioritize the programme of work and budgeting for MAP components
- Preparing the programme of work for the 2013-2014 biennium and the five-year rolling programme of work
- Monitoring implementation of the programme of work
- Establishing procedures and resources to ensure the implementation of the MAP programme
 of work in a cost-efficient and timely manner.

Other coordination activities among MAP components

There is a need to define clear tasks for each MAP component with regard to the implementation of the ICZM Protocol which, as worded for in the Protocol, are the responsibility of the Organization (Coordinating Unit). This process will facilitate MAP's work in making better use of the integrated approaches and tools provided for in the ICZM Protocol for the implementation of the other Barcelona Convention Protocols addressing pollution prevention and control and biodiversity conservation in the coastal zone.

In order to make optimal use of the limited human resources of the Secretariat and the components for supporting the work of the Compliance Committee in accordance with the compliance procedures and mechanisms and the Committee's rules of procedure, there is also a need to establish clear internal consultation procedures and division of labour among the Coordinating Unit and the components in charge of different Protocols.

Other important activities entrusted to the Coordinating Unit but implemented by PAP/RAC are the final CAMP conferences, which are recognized as an important policy instrument for MAP because of the high level and multi-sectoral participation from national, regional and local governments as well as the donor community in the countries. All MAP components are expected to contribute to the implementation of CAMPs.

I.2.2 Application of the ecosystem approach

Goal: To enable MAP to implement the ecosystem approach as an effective management tool to ensure integrated sustainable policies for the protection and development of the Mediterranean Sea area including its coastal zone.

Objective

- To implement the roadmap for the application of the ecosystem approach by the whole MAP system
- 2. To define the ecological objectives of the Mediterranean

At its first meeting held in September 2009, the Bureau welcomed the shift from a sectoral to a horizontal approach for the application of the ecosystem approach under the responsibility of the Secretariat.

The Bureau also considered that further efforts were needed to this end, in particular by ensuring that socio-economic dimensions were fully taken into account in the delivery of marine and coastal ecosystem services.

In this regard, a meeting of all MAP components organized by the Coordinator was held in Split in September 2008. The conclusions were endorsed by the third ECP meeting. A number of activities were agreed upon and will be implemented in 2009 with EC funding. The agreement for financing these activities between MAP and the EC has been signed.

During the Split ECP meeting, decisions were taken regarding the distribution of work and the budget among MAP components. The decisions appear in the report of the 3rd ECP meeting. More specifically:

- (a) The agreed table of contents for the preparation of the assessment documents was discussed and work shared between MAP components by chapters. Work methodology was also agreed. Contracting Parties will designate an expert who will coordinate activities within the country. All experts will be invited to a kick-off meeting where the table of contents will be discussed and explained, and work methodology and responsibilities will be agreed upon. The budget for this activity will come from the EC/MAP project and has been agreed as follows: Meeting (2 days, including conference services) €46,250; consultants €70,000.
- (b) The leading MAP component for the socio-economic analysis will be Blue Plan. The budget will increase as follows: BP will receive €67,100 from the EC project and €10,000 from the 2009 ECAP budget.
- (c) The leading MAP component for the communication and public awareness planning document will be INFO/RAC. For this purpose an amount of €10,000 will be allocated from the 2009 ECAP budget.
- (d) Coordinating Unit, with the help of a consultant, will take care of the ECAP planning document using the 2009 ECAP budget.
- (e) The case study will be undertaken by Coordinating Unit using the 2009 ECAP budget.
- (f) The third meeting of government-designated experts will be covered by the EC project for €61.700.
- (g) PAP/RAC will undertake the compilation of assessment methodologies.

More recently, the Secretariat, assisted by experts, initiated an activity to apply the approved roadmap to a selected number of ecological objectives, as far as possible common to all four areas, and falling under the competence of MED POL and SPA/RAC. This activity, held in December 2008, was a brainstorming exercise on the case study for the application of the ecosystem approach roadmap, with the participation of the concerned MAP components and the MAP Consultant.

I.3 <u>Cooperation and partnership with United Nations Agencies, EU, regional initiatives</u> and civil society

Goal

Broad and solid cooperation and synergy with relevant international and regional organizations and with civil society for the effective implementation of the programme of work and for ensuring coordinated and complementary development and delivery of technical assistance to Contracting Parties on common issues, as appropriate.

Objectives

- 1. To strengthen cooperation and complementarity as appropriate with the relevant United Nations bodies and convention secretariats (Biodiversity, Basel, Ramsar, Stockholm, Climate Change, etc.) in fields of common interest.
- 2. To consolidate cooperation with the Union for the Mediterranean, the EC and EEA with a view to updating and implementing the joint programmes of work and in particular activities within the Horizon 2020 initiative project;
- 3. To ensure NGOs' participation in MAP activities and enhance their contribution to the achievement of MAP objectives with a particular focus on the implementation of the Barcelona Convention and its Protocols of the MSSD;
- 4. To further cooperate with GEF, WB, EIB, FFEM and other funding agencies and the private sector in order to mobilize the necessary financial resources for the implementation of the Barcelona Convention and its Protocols.
- 5. To promote regional cooperation.

Over the years, MAP has established close working relationships with United Nations bodies and Programmes, MEAs, EU institutions, other important regional initiatives and global and regional conventions addressing environmental, marine and coastal protection and sustainable development issues.

With a view to further strengthening and developing cooperation and synergy on issues of common interest, the Secretariat will continue to undertake a number of activities in 2010-2011 in cooperation with the RACs, including MEDPOL.

With a view to achieving synergy and joining forces to promote sustainable development of the Mediterranean, special attention will be paid by the Secretariat, in consultation with the ECP, to the MAP"s cooperation with the Union for the Mediterranean at governance and policy levels to RAC and MEDPOL cooperation at project levels. Of paramount importance is MAP/EC partnership and MAP/EEA cooperation and synergy for the successful implementation of the Horizon 2020 initiative project of the Union for the Mediterranean.

Contacts will also continue to be strengthened with other regional conventions, regional seas programmes and the secretariats of multilateral environment agreements.

In the coming biennium, MAP will continue to exchange experience with OSPAR and HELCOM especially with respect to the application of the ecosystem approach. The intention is also to continue working together with regard to ensuring synergy with the EU Marine Strategy Directive, as appropriate.

Concrete areas of collaboration have been identified with the Secretariat of the Basel Convention in addressing pollution from hazardous waste within the framework of both the Barcelona and Basel Conventions. A comparative legal analysis of both Conventions and in particular of the Izmir Protocol has already been made to identify synergies in the legal instruments for addressing the issue of the trans-boundary movement of hazardous waste.

The Secretariat, in view of the excellent spirit of cooperation during the implementation of the joint MAP/EC programme of work, will continue to work closely with the European Commission, considered an important and strategic partner and EEA. Two major projects funded by the EC will be further implemented during the forthcoming biennium (on SPAMIs and the ecosystem approach). The joint programme of work signed in 2005 is expected to be updated in order to reflect new developments and priorities as appropriate.

Having in mind the need to ensure synergy and effective collaboration of MAP components with partner institutions and programmes in the region, the Secretariat also intends to update its current agreement or joint programme of work and/or sign new agreements with EEA, IUCN, Basel Convention Secretariat, Bern Convention Secretariat, CBD Secretariat, WB, Stockholm Convention Secretariat, MEDWET, etc.

I.3.1 GEF Strategic Partnership

The Regional Component of the GEF Project "Strategic Partnership for the Mediterranean Large Marine Ecosystem" (UNEP GEF Med LME project) was endorsed by the GEF Chair Executive Officer (CEO) in April 2008, and officially began implementation in October 2008, following signature of an internal legal agreement between UNEP/MAP and UNEP DGEF.

The objective of the Mediterranean Sea LME Strategic Partnership is to leverage reforms and catalyze investments that address transboundary pollution reduction and marine and coastal biodiversity conservation priorities identified in the Strategic Action Plans (SAP-BIO and SAP-MED) for the Mediterranean basin. This is a partnership consisting of two components: an Investment Fund implemented by the World Bank (WB) and the regional component implemented by UNEP, UNEP/MAP and partners.

The objective of the proposed Regional Component is to promote and induce harmonized policy, legal and institutional reforms and fill the knowledge gap aimed at reversing marine and coastal degradation trends and living resources depletion, in accordance with priorities agreed by the countries in the SAP MED and SAP BIO, and to prepare the ground for the future implementation of the ICZM Protocol. Participating countries are Albania, Algeria, Bosnia and Herzegovina, Croatia, Egypt, Lebanon, Libya, Morocco, Montenegro, Syria, Tunisia and Turkey, The Palestinian Authority. Funding is through GEF with 11,891,000 USD and co-financing of 35,597,700 USD. UNEP/MAP is responsible for the coordination of the project and executing partners include UN agencies: UNESCO/IHP, FAO, WB; MAP's regional activity centers: PAP/RAC, CP/RAC SPA/RAC and NGO's: GWP-Med, WWF-MedPo and MIO-ECSDE. UNIDO also participates in a separated implemented and executed project on the transfer of environmental sound technology (TEST). The project consists of 4 components:

- Component 1.Integrated Approaches for the Implementation of the SAPs and NAPs: ICZM, IWRM and Management of Coastal Aquifers (UNESCO/IHP, PAP/RAC and GWP-Med);
- Component 2. Pollution from Land-based activities, including POPs: Implementation of SAPMED and related NAPs (MEDPOL, UNIDO and CP/RAC);
- Component 3. Conservation of Biological Diversity: Implementation of SAP-BIO and related NAPs (WWF, SPA/RAC and FAO)
- Component 4. Project Coordination, Replication and Communication strategies, and Management and M&E (UNEP/MAP, MIO-ECSDE and MEDPOL)

All documents are available on the www.unepmap.org web site.

Goal: To ensure the overall effective management and coordination of the Strategic Partnership as well as the Regional Component (Component 4.1 of the UNEP GEF Med LME project).

UNEP/MAP and the projects PMU will implement activities related to the SP project coordination and management, M&E activities and the involvement of stakeholders in project activities and demonstrations. It will establish effective project implementation and coordination at both regional and national levels to ensure that the projected outputs are delivered and the overall objectives achieved. Not included in this are the activities to be implemented by all the partners mentioned.

Objectives:

- 1. To facilitate and foster synergies between the two components (WB and UNEP) of the project and ensure that the Strategic Partnership as a whole is implemented in parallel;
- To oversee and assist all co-executing agencies in the implementation of their activities, as detailed in the agreements signed with each partner (UNESCO/IHP, FAO, WB; PAP/RAC, CP/RAC SPA/RAC, GWP-Med, WWF-MedPo and MIO-ECSDE)
- 3. To ensure country ownership of partnership processes and all activities;
- 4. To ensure policy reforms in participating countries, through the use of existing and well established Barcelona Convention and MAP structures and mechanisms:
- 5. To ensure effective monitoring and evaluation throughout the lifespan of the project; and

I.3.2 Cooperation with MAP civil society partners

Over the years, MAP has established fruitful cooperation with civil society and in particular with NGOs. For this purpose, a partnership has been established on the basis of principles and strategic directions and criteria adopted in Barcelona in 1995, Malta in 1999 and Monaco in 2001. Assistance is provided to MAP partners to build and strengthen their capacities, to participate in MAP events and meetings and to implement projects focusing on the implementation and achievement of MAP objectives.

The programme of work is intended to:

- (a) increase the capacities of MAP partners from the southern and eastern part of the Mediterranean;
- (b) assist MAP partners in implementing projects which are relevant to the Barcelona Convention its Protocols and related strategies;
- (c) support their contribution to MAP events and meetings and activities as appropriate.

In terms of governance, the Secretariat, assuming that the 16th Meeting of the Contracting Parties will approve the new updated admission criteria and procedure for MAP partners from civil society organizations, will undertake a review of the current 80 partners for consideration by the Bureau meetings and endorsement by the 17th Meeting of the Contracting Parties.

I.4 <u>Mediterranean Strategy for Sustainable Development</u>

Goal

The overall objective of the programme is to support MSSD implementation through complementary and coordinated initiatives at the regional, subregional and national levels as indicated in the MSSD Implementation Plan.

The programme will contribute to the implementation of MSSD by:

- integrating social, economic and environmental dimensions of sustainable development policy-making at the regional and national levels;
- effectively involving civil society, major groups and other related stakeholders in the implementation process;
- encouraging cross-sectoral approaches to sustainable development;
- providing targeted technical assistance to support developing countries to implement MSSD;
- developing cooperation and information exchange with United Nations agencies, the European Commission and other international and regional organizations working for sustainable development in the region;
- contributing to monitor, evaluate and report on the implementation of sustainable development at the national and regional levels;
- contributing to a broader understanding of sustainable development through information and communication.

The programme is structured by three interrelated components:

- 1. Mainstreaming sustainable development issues in national policies
- Increasing MCSD visibility and creating awareness, developing synergies with existing or potential subregional initiatives towards sustainable development
- 3. Assessing the implementation of the MSSD and organization of regular MCSD meetings.

The proposed activities are in line with the decisions of the Contracting Parties and consistent with the multi-year thematic programme of work for the MCSD (2005-2011) as approved by the Contracting Parties in Portoroz, 2005. The proposal pertains to MSSD implementation with a focus on policy processes addressing cross-sectoral issues.

The proposals are based on experience gained and stock-taking of what was achieved against activities planned for 2008-2009 as indicated in the progress report. Due consideration has been given to the UNCSD Programme of Work (UNCSD PoW 2010-2016), the Johannesburg Plan of Implementation and the Millennium Development Goals.

The results of the activities described here will directly feed into the 14th Meeting of the MCSD. The activities build upon the previous work of the MCSD and all converge towards the implementation of the MSSD. Due consideration has been given to climate change and sustainable production and consumption issues, which featured prominently in the Almeria Declaration, and to other international policy dialogues.

Mainstreaming sustainable development issues in national policies, including national strategies for sustainable development (NSSDs)

Objective

Foster the inclusion of "climate change" and "sustainable production and consumption" considerations in national policies, instruments and institutions, beyond those of dedicated agencies and multilateral agreements.

In previous bienniums, the programme has successfully supported the formulation of NSSDs in pilot countries. Experience has shown that in order to be more effective, take the lead and move towards appropriate and sustainable change, the MCSD programme has to be more responsive to the needs of the countries and solution-oriented.

The activities under this objective are intended to support national policy processes as well as subregional positioning to address two major sustainable development challenges that constitute thematic clusters of the CSD implementation cycle 2010-2011:

- i. mitigation and adaptation to climate change; and
- ii. sustainable production and consumption (SPC).

The activities will be undertaken at national and regional levels.

In the four to six pilot countries, the programme will support national process aimed at increasing convergence and coherence of the policies, legal frameworks, economic instruments and institutional frameworks that pertain to climate change or Sustainable consumption and production.

The experience gained in the pilot countries will be shared throughout the region. For this purpose, one working session on "challenges and opportunities for mainstreaming SD issues in national policies" will be organized in 2010, enabling the pilot countries that are supported by UNEP/MAP to exchange experience with those previously involved in NSSD formulation. This working session will also be the opportunity to discuss how to address subregional and national commonalities. In addition, a regional workshop on "preparation and implementation of mainstreaming SD issues" will be held in late 2010 / early 2011 as a follow-up to the working session that will involve participants from the entire region and stakeholders representing all interest groups of the MCSD.

The success of the proposed activities will depend on the good and coordinated collaboration between the concerned MAP components and with the other major players in the region.

Increasing MCSD visibility and creating awareness

Objective

To further enhance awareness about the MCSD and MSSD as regional governance structures for sustainable development in the Mediterranean

The MCSD is a unique forum for the region, as it involves all the different actors from the public and private sectors. It thus gives the different segments of society the opportunity to discuss issues on an equal footing and share their different perspectives. By doing so, the MCSD helps to raise the consensus level and thereby give policy decisions a broader basis and ultimately a better chance of being effectively implemented. Whereas the MCSD's role and functioning is familiar to the MAP components and members, it remains largely unknown in other forums or international policy dialogues.

The activity under this objective is intended to increase the visibility of the MCSD throughout the region and beyond, in particular among decision-makers involved in the newly emerging initiatives or programmes that pertain to sustainable development in the region. The MCSD leaflet (2001) will be updated on the basis of the MCSD mandate approved in Almeria and a specific MCSD Brief will be prepared for decision-makers, in particular those outside the ministries of the environment. This activity will be carried out in close consultation with the Information office of the Coordinating Unit.

Assessing the implementation of the MSSD and organization of the 14th MCSD meeting and MCSD Steering Committee meetings

Objectives:

- To ensure an effective operation of the MCSD and assessment and monitoring of the MSSD implementation
- To ensure efficient, effective and timely delivery of the programme of work of the MCSD for the biennium

In depth assessment of the MCSD

In accordance with the MCSD programme of work approved by the Contracting Parties in 2005, an overall review of the MSSD should be carried out during the 2010-2011 biennium. The MSSD itself calls for an indepth assessment every five years. The first of such assessments falls due during the 2010-2011 biennium and is intended as a special assessment for the Third World Summit on Sustainable Development. The organization of this review has been discussed by the MCSD Steering Committee and the ECP.

The assessment will be carried out by an external entity.

The MCSD, through the Steering Committee, will be involved throughout the process.

Organization of the 14th MCSD meeting and the MCSD Steering committee meetings

During the biennium, two Steering Committee meetings will be organized and the 14th meeting of the MCSD will take place.

The MCSD secretariat will develop closer and more continuous interactions with the Steering Committee, thus engaging the Committee further. Instituting a regular dialogue between the Steering Committee and the MCSD secretariat will contribute to:

- improving the functioning of the MCSD between two sessions
- developing synergies between the MCSD and other regional and international initiatives and processes
- identifying and structuring issues that cannot emerge in a one-off meeting, and possibly deciding on the topics and the way of addressing them during the biennial MCSD meetings.

The content of the MCSD meeting will largely build upon the outputs of the activities in this proposal and upon recommendations emerging from different sustainable development forums and meetings.

I.5 Communication and Public Information

a. Goal

The general public and partners are aware and better informed about MAP activities and achievements within the framework of the Barcelona Convention and its Protocols for the promotion of sustainable development in the Mediterranean.

b. Objectives

In order to achieve the overall goal, the following objectives are to be met:

- 1. To enhance the environmental awareness of the population;
- 2. To enhance visibility of MAP and the Contracting Parties in the effort to implement the Barcelona Convention and its Protocols as well as the MSSD
- To launch and Implement coordinated information campaigns and special activities on environmental protection, directed towards decision-makers, as well as children, students, teachers and tourists, underlining the importance of public participation in their conservation and management;
- 4. To continue and expand publication and distribution of brochures, leaflets, posters, reports, newsletters and other information material, as well as the use of the media in all its forms;
- 5. To enhance and strengthen the exchange of information and experience on environmental problems of the region, and to develop cooperation and networking in this field.

All the activities proposed by the Coordinating Unit for the 2010-2011 biennium have been identified in line with the objectives listed in the MAP Phase II document (section 2.4) about public awareness and participation as well as the Information Strategy adopted by the Meeting of the Contracting Parties in 1999 in Malta, and decisions of the meeting of the Contracting Parties in Catania and in Portoroz.

The key objective for the forthcoming biennium is the elaboration of a revised Information and Communication Strategy. Such framework will allow MAP and its components to define and develop ad hoc communication activities that will serve the reviewed needs of the organization.

Such strategy will have to complement the new communication and information strategy that both UNEP and DEPI are currently developing, and respond to the arising challenges and issues witnessed in the Mediterranean region.

The revised strategy will be developed following the findings and analysis of the external evaluation of MAP's outreach activities conducted in the course of the current biennium.

It will have to provide all MAP components with the appropriate analytical elements to identify the tools and communication activities that should be prioritised in order to accomplish the goals of the organisation.

It is crucial that MAP and Contracting Parties' expertise is translated and adapted in communication tools that can reach international, regional, national and local communities, in particular sectors of the Mediterranean society which are less exposed to relevant environmental information.

The objective is to build on the existing internal communication, to develop an effective and targeted external communication plan, addressing external stakeholders and target groups, and strengthening MAP's voice in the international political arena.

In particular it should ensure the consolidation of awareness and information at local and national, as well as regional, levels in addition to ensuring the rapid circulation of scientific research results. In close coordination with the regional activity centre for information and communication, importance will also be given to the dissemination of available data by various means, including the media, concerning the state of habitats and populations and the threats affecting them.

It is crucial that policy and communication activities complement each other, and are therefore developed hands-in-hands following the same vision and objectives. In particular communication tools must be developed to support the political objectives and therefore find their *raison d'etre* in the political strategy.

II. COMPONENTS

II.1 Land-Based Pollution (MED POL)

Sub-programme 1: Implementation of the LBS, Dumping and Hazardous Wastes Protocols

GOAL

To facilitate the implementation of the LBS Protocol and the Strategic Action Programme (SAP), the Dumping Protocol and related guidelines according to Article 6.2 and the Hazardous Wastes Protocol, and their entry into force.

Objectives

- 1- To facilitate the financing of National Action Plans (NAPs)
- 2- To develop a methodology for the quantification of inputs from diffuse sources in the framework of the GEF Strategic Partnership
- 3- To implement a mechanism for a differentiation approach in the pollution reduction process of the NAPs
- 4- To launch policy reform demonstration projects in the framework of the GEF Strategic Partnership (SP) related to tanneries, lubricating oils, batteries and fertilizers
- 5- To provide technical assistance to countries to facilitate the implementation of the Dumping Protocol and its guidelines in cooperation with IMO
- 6- To contribute to and facilitate the implementation of the action plan to combat the illegal traffic of hazardous wastes in Arabic countries
- 7- To implement demonstration projects for the management and disposal of PCBs in the framework of the GEF Strategic Partnership.

As a result of the endorsement by the Contracting Parties of National Action Plans (NAPs) to address land-based pollution, MED POL will continue to work closely with national and regional initiatives (EU Directives, European Investment Bank (EIB), Union for the Mediterranean, EU Horizon 2020 initiative), and with international financial institutions (GEF and World Bank) to ensure the financing of the priority actions of the NAPs.

In addition, with the assistance of regional experts, the Secretariat, within the framework of the GEF SP will review the state-of-the-art quantification of inputs into the marine environment from diffuse sources, in order to identify a reliable process which could be used to assess the magnitude of inputs of pollutants from diffuse sources and to develop an appropriate regional policy to address this issue.

During the 2008-2009 biennium MED POL developed, through a region-wide consultation process with representatives of Contracting Parties, stakeholders and NGOs, a differentiation mechanism based on Emission Limit Values (ELVs) to be applied in the revision of NAPs and the development of regional plans and programmes including legally binding measures and timetables required by Article15 of the LBS Protocol. During the biennium, in consultation with the Parties, the Secretariat will continue to work on the finalization of a document describing the process of implementation of the adopted differentiation mechanism with a view to having it adopted by the Contracting Parties in 2011.

MED POL will continue the formulation of the regional plans/programmes required by Article15 of the LBS Protocol. During the biennium the Secretariat will prepare draft plans for a priority substance (Mercury), a priority sector (food sector) and the chemicals included in 2009 in Annex A of the Stockholm Convention. The regional plans/programmes would be prepared on the basis of the differentiation mechanism and through a region-wide consultation process with national authorities and stakeholders.

MED POL was not able to launch the implementation of its related activities in the framework of the GEF Strategic Partnership on account of some delays in its actual launch. MED POL therefore expects to launch, during the 2010-2011 biennium, five pilot projects in Turkey, Algeria, Lebanon and

the Syria in four industrial sectors (tanneries, lubricating oils, batteries and fertilizers) that will be replicated through the overall GEF replication strategy and also a pilot project for the development of ELVs and Environmental Quality Standards (EQS).

MED POL, in close cooperation with the Secretariat of the London Convention and the relevant national authorities and stakeholders, will continue to provide legal, institutional and technical assistance to facilitate the implementation of the guidelines developed under Article 4.2 of the Dumping Protocol. The Secretariat will start providing assistance to the Contracting Parties for the establishment of National Threshold Limit Values (NTLVs) to assess the toxicity of dredged materials to be used by national authorities as an element of the permitting system on the basis of the guidelines which are expected to be reviewed by the NFPs. In addition MED POL will publish a regional map exhibiting the sites of dumping of ammunitions for the use of maritime agencies, port authorities, fishermen, local communities, etc. Finally, MED POL will continue to work closely with IMO to promote the implementation of the guidelines on waste management developed by the London Convention.

As a follow-up to the risk assessment on Co₂ sequestration in the geological substructure of the sea which is under preparation with the assistance of the Spanish Government, negotiations will be carried out with the Contracting Parties with a view to possible amendment of Article 4.2 of the Dumping Protocol. If funds are made available, a meeting of government-designated experts could be held to discuss the result of the assessment and to decide on the next steps.

In cooperation with the Basel Convention Secretariat and its Regional Centres in Bratislava and Cairo, MED POL will finalize the regional assessment on the management of e-waste prepared in 2009 in order to propose to the Contracting Parties in 2011 a regional action plan in line with Basel Convention provisions.

In cooperation with the Basel Convention Secretariat and its Regional Centre in Cairo, MED POL will assist in the implementation of the strategy and an action plan for the control of illegal traffic of hazardous wastes in the Arab countries which was developed in 2009. In particular, the proposed activities which MED POL would support are as follows:

1-Development of a database of internationally banned hazardous chemicals and wastes and a methodology to detect them,

2-Preparation of a training manual for customs and port authorities to detect smuggling and illegal trade of internationally banned hazardous chemicals and wastes. In this context, MED POL will extend the mandate of the Mediterranean Network on Compliance and Enforcement of Legislation to include coordination between port authorities/inspectors to build their capacity in preventing and combating illegal transboundary movements of hazardous wastes. This issue will be included in the agenda of the next meeting of the Network scheduled for November 2009.

As part of the activities of the recently approved GEF Strategic Partnership, MED POL, in cooperation with CP/RAC, will launch five demonstration projects for the environmental management and disposal of PCBs in Albania, Egypt, Syria, Libya and Lebanon. The projects aim at the implementation of a national capacity- building programme on how to perform a disposal process (selection, confinement, authorization, shipment and disposal) for oils and equipment contaminated with PCBs in selected demonstration sites together with a nation-wide capacity-building programme for stakeholders and the public on the environmental and health issues involved in the management of PCBs. As a result of the five-year project, it is expected that 800 tons of PCBs will be disposed through the implementation of the demonstration projects. The activities on PCBs as part of the SP are considered a concrete contribution to the implementation of the NAPs and the NIPs of the Stockholm Convention.

Sub-programme 2: Assessment of the implementation of LBS, Dumping and Hazardous Wastes Protocols

GOAL

To monitor the effectiveness of national measures taken to implement the Protocols

Objectives

- 1- To develop effectiveness indicators
- 2- To assist countries in formulating and establishing national monitoring programmes in compliance with Article 12 of the Convention and Article 8 of the LBS Protocol
- 3- To assess the state of marine pollution in the Mediterranean and determine its trends
- 4- To assess the level of reduction of inputs from point sources
- 5- To develop a comprehensive set of marine pollution indicators

During the 2008-2009 biennium, in close cooperation with Coordinating Unit and the relevant RACs, MED POL developed a set of indicators to assess, in accordance with Article 26(b) of the Convention, the effectiveness of the implementation of the LBS, Dumping and Hazardous Waste Protocols and the related programmes of measures. In the current biennium, in cooperation with MED POL, the countries will assess the relevance and the feasibility of such indicators on the basis of data available . As a result of the assessment, a set of indicators will be proposed to Contracting Parties for adoption in 2011.

According to Article 12 of the Barcelona Convention all Contracting Parties shall establish monitoring programmes and designate the competent authorities responsible for pollution monitoring. In addition, Article 8 of the LBS Protocol stipulates that these monitoring programmes should aim to systematically assess, as far as possible, the levels of pollution.

The monitoring activities in MED POL Phase IV are designed on the basis of the above and with the following specific objectives:

- to determine temporal trends of some selected contaminants in the coastal waters and specifically in hot-spot areas in order to assess the effectiveness of policy measures and actions taken;
- to undertake periodical assessments of the state of the environment in hot spots and general coastal areas (needed to provide information for decision makers on the basic environmental status of the areas which are under anthropogenic pressures), and
- to control whether there is compliance with national / international regulatory limits.

As Contracting Parties are responsible for establishing national monitoring programmes that would include state and trend monitoring, compliance monitoring and monitoring of loads (NBBs), during the 2010-2011 biennium every effort should be made to complete the full geographical coverage of the region with appropriate programmes and the provision of data and results. In particular, an assessment will be made by the Secretariat of the current monitoring strategy with the aim of improving it and streamlining it, ensuring the provision of data and contributing to the revision of its objectives.

Financial assistance will be provided by the Secretariat to those countries that are still in need, according to the availability of funds. In addition, every effort will be made to seek additional funds through external sources for capacity- building and technical assistance, also taking account of the additional efforts that countries will have to make as a result of the expected implementation of the adopted regional plans.

Contracting Parties are encouraged and assisted to also undertake biological effects monitoring and eutrophication monitoring, as appropriate. Baseline studies will continue in cooperation with ongoing projects to cover the South-eastern Mediterranean.

Data Quality Assurance (DQA) is vital to ensure reliable and good quality data. IAEA will continue to be responsible for chemical contaminants (trace metals and organics) in biota and sediments, by organising intercalibration exercises and hosting training courses for Mediterranean scientists. Increased efforts will be made to ensure the follow-up of DQA in the participating laboratories, through

additional training and visits, as needed. Nutrients and chlorophyll-a data intercalibration will be organized using QUASIMEME services, and the University of Alessandria (Italy) will be responsible for biomarkers intercalibration. MED POL will assist laboratories in participating in the DQA activities. Specifically, for biological effects, a joint workshop with be organized with the participation of laboratories from MED POL, OSPAR and HELCOM, to discuss the results of the intercalibration and to seek possible harmonization of methodologies and assessment criteria.

The process for updating the reference methods for monitoring and analysis will continue in 2010 with the support of IAEA taking into consideration the importance of harmonizing methodologies.

As was indicated in the approved MED POL Phase IV programme, compliance monitoring will focus mostly on the monitoring of inputs of loads of pollutants which could reach the marine environment directly or indirectly from point sources in administrative region(s) and at national level. Accordingly, in the 2010-2011 biennium MED POL will assess the level of reduction of pollution between 2003 and 2008 on the basis of the results of the new updated NBBs and produce a document related to compliance monitoring. This work will facilitate and improve the assessment of loads from industrial point sources

The regional and national assessments of the status of the generation of data and information to assess marine pollution indicators (MPIs), which were performed by regional and national experts, will continue in order to prepare "fact sheets" to be used by the countries. The Secretariat will continue its efforts to harmonize the generation of data and information in order to have a consolidated, comprehensive and reliable set of indicators which would be used at a later stage to develop the DPSIR indicator-based State of Environment (SoE) report. To this end, MED POL will continue to work closely with EEA, JRC and Blue Plan to harmonize activities and will provide technical and financial assistance to national institutions responsible for the monitoring programmes.

Sub-programme 3: Use of implementation tools

GOAL

To build the capacity of national authorities for reporting, information gathering, transfer of technology, inspectorate systems and monitoring.

Objectives:

- 1- To make the MED POL information system operational
- 2- To promote the transfer of technology
- 3- To implement PRTRs
- 4- To ensure proper implementation of monitoring
- 5- To assist countries in strengthening their inspectorate systems

As a result of the close cooperation between MED POL and INFO/RAC, it is expected that the MED POL information system will be fully operational in 2010. It will comprise two modules: an intranet which would improve communication between the MAP Secretariat staff, the Contracting Parties and stakeholders, and an online reporting system for trends and compliance monitoring.

Facilitating and enhancing the transfer of technology and know-how among Mediterranean Countries is an important tool to ensure the effective implementation of NAPs. In this context, MED POL will continue to cooperate with CP/RAC to implement specific activities related to the transfer of know-how and clean technology.

PRTR is gaining more and more importance as an efficient tool for the sound management of industrial pollution and management of chemicals at global and regional levels. MED POL will continue to provide technical and financial assistance to Turkey to finalize the full-size project, to the Syria to expand the PRTR system to cover additional coastal environmental directorates, and to Morocco to expand the pilot project into a full-size project. As a result of a change in priorities leading ICS-UNIDO to interrupt its contribution to the implementation of the PRTR activities, MED POL undertook constructive contacts with ED –DG Environment and Italy to ensure partial sponsorship for the implementation of its PRTR programme. The full implementation of the proposed programme is therefore subject to the availability of funds and technical assistance from potential partners.

IAEA-MESL will continue to organize training courses related to the analysis of heavy metals and organics for monitoring. MED POL will conduct a survey in the countries to determine whether new or additional training courses are required, taking into consideration the implementation of the ecosystem approach by the Contracting Parties, as well as the need to ensure harmonization with the EU Member States' monitoring programmes to be developed in the framework of the Marine Strategy Framework Directive and the Water Framework Directive.

National training courses on wastewater treatment plants operation and management and re-use of the treated effluents will continue to be organized, also serving as a contribution to mitigation of climate change effects. Regarding the strengthening of inspectorate systems in the countries, the regular meeting of the Network on Compliance and Enforcement will be held in 2011; it will highlight the specific needs of the countries in using the compliance and enforcement indicators and will suggest specific activities for the implementation of the indicators. Assistance for technical, institutional and organizational issues will continue to be provided to countries upon request. As mentioned earlier, at the meeting of the Network to be held at the end of 2009, MED POL will review the possibility of extending its mandate to cover port inspectors and include activities related to the control of illegal transboundary movements of hazardous waste.

The activities related to inspection systems included in the GEF Strategic Partnership have been delayed on account of the late launching of the project, now expected in mid-2009. As a result, the following countries will benefit from the activities: Albania, Bosnia and Herzegovina, Croatia, Lebanon, Montenegro, Morocco, Syria and Turkey. The activities in each country are expected to last for one and a half years, while the whole project will last five years to cover all countries. It is expected that during 2009-2010, two countries will participate in the activities. The work will include the formulation of plans of action for permitting, compliance and inspection, the training of national inspectorates through workshops and the drafting of amended national legislation in relation to inspection systems. Therefore, an initial meeting to consider the existing legislation will be organized at national level, followed by a national workshop and, at the end of the one-and-a-half-year period, a final meeting with the aim of proposing potential amendments to existing legislation.

Sub-programme 4: Physical alteration and destruction of habitat

GOAL

To reduce the impact on the marine environment of litter and sea water desalination plants

Objectives

- 1- To prepare a targeted awareness campaign on impacts of desalination plants
- 2- To develop a regional action plan for litter management

The issue of marine litter in the region has two origins: inadequate coastal solid waste management (mostly in the southern and eastern countries) and lack of awareness of sea users such as beach-goers, tourists, maritime traffic, fishermen etc. In this framework, MED POL with the assistance of regional expert(s) and in coordination with UNEP RS launched in 2009 the process aiming at developing a regional action plan for litter management. A draft strategy for the reduction of marine litter in the Mediterranean was prepared and it will be further refined during the biennium 2010-2011 and completed by a feasibility study including the costs of its implementation. The strategy will be submitted to the Contracting Parties for consideration at their meeting in 2011.

The need for desalting sea water is becoming more and more pressing in the Mediterranean, where water needs are constantly increasing. It is estimated that by 2010 water demands in the region will increase by 32% at least for the southern and eastern countries. As a result, during the 2010-2011 biennium the Secretariat will carry out a survey of the current status and expected developments of desalination in the region that will be shared among all countries. In addition, MED POL will continue to assist the relevant national authorities and stakeholders on issues related to planning for desalination plants, siting, EIA and capacity- building programmes.

Sub-programme 5: Public health

GOAL

To assess and reduce sewage pollution reaching the Mediterranean and to improve the quality of bathing and shellfish-growing waters and reduce health risks form tourist establishments

Objectives

- 1- To assist countries in the better management and operation of municipal wastewater treatment plants and use of treated water.
- 2- To assist countries in the implementation of monitoring of bathing waters and shellfish-growing areas.

The Mediterranean and its coastal areas constitute the receiving body for a number of wastes generated on the coast, and thus the main recreational amenity provided by the sea for local populations as well as millions of tourists who visit the area annually is seriously threatened. One of the overall objectives of MED POL Phase IV is the assessment of all point sources and loads of pollution reaching the Mediterranean and the magnitude of the problems caused by the effects of contaminants on living and non-living resources, including human health, as well as on amenities and uses of the marine and coastal regions. Therefore, the draft guidelines on coastal bathing waters will be presented in their final form taking into consideration the results of the implementation of the pilot projects related to the preparation of bathing waters quality profiles with a view to approval by the Contracting Parties in 2011. The guidelines will also provide input to the preparation of a number of bathing waters profiles in countries willing to do so and according to the proposed methodology. The implementation of the guidelines in their final form, including the profiles, will be discussed along with shellfish-growing areas' activities at a consultation meeting to be held during the biennium. A blind intercalibration exercise will be organized during the biennium for health-related monitoring activities. The methodology consists in analysing prepared samples sent to the laboratories and in discussing the results at a meeting. The discussion will lead to the adoption of the proposed guidelines.

The methodology for the preparation of action plans related to health risks in tourist establishments will be finalized, with the purpose of preparing appropriate guidelines for the hotel industry.

For the implementation of the Millennium Development Goal concerning sanitation and the work on river basin management, a list of wastewater treatment plants in cities with more than 2,000 inhabitants discharging in rivers that flow into the Mediterranean has been prepared. Taking into consideration that the assessments of the treatment plants in Mediterranean cities discharging directly or indirectly into the sea were prepared in the year 2000, an updating of the situation is necessary and will be made during the biennium along with the estimation of trends for the decade. As a further contribution to the climate change issue, a set of compliance indicators for the operation and maintenance of wastewater treatment plants will be prepared, so as to safeguard the re-use of the treated effluents. In addition, contingency planning will be developed for the purpose of providing guidance in extreme weather events, especially in flooding situations, within the framework of adaptation to climate change. For the implementation of the guidelines on the reuse of treated wastewater, it is expected that at least three national training courses on the subject will be held, as some countries have already expressed their interest in the subject. The training material will be translated into several languages (as required) to satisfy the needs of the different courses.

Sub-programme 6: Institutional arrangements and cooperation including Stakeholder involvement and public outreach

GOALS

- 1- To better coordinate MED POL activities with national authorities
- 2- To achieve broad and solid cooperation with all relevant international, regional and national actors to further improve the results of the MED POL programme for the benefit of the countries
- 3- To facilitate the implementation of NAPs at national and local levels through stakeholder participation
- 4- To improve and widen knowledge of MED POL activities and achievements

Objectives:

- 1- To maintain and strengthen cooperation with the scientific community
- 2- To maintain and improve cooperation with the relevant United Nations bodies and Convention secretariats
- 3- To further cooperation and launch joint activities with RACs
- 4- To consolidate cooperation with EU and EEA
- 5- To ensure participation of NGOs in MED POL activities
- 6- To further cooperation with GEF, World Bank, EIB, FFEM and other relevant international and regional stakeholders
- 7- To maintain close cooperation with national authorities through meetings and contacts
- 8- To facilitate the involvement of national and regional stakeholders including the private sector in the implementation of NAPs
- 9- To establish a MED POL information system and implement the MAP strategy in relation to the MED POL activities

The ongoing work of the Mediterranean scientific community on marine pollution monitoring and assessment, such as CIESM and JRC, and on operational monitoring and observation systems, such as MOON and MED GOOS, will be closely followed up and cooperation will be strengthened.

Cooperation will also continue with WHO participation on a full-time basis, with IAEA and all other United Nations agencies/bodies carrying out work relevant to the various components of MED POL, with global and regional Convention secretariats and international and intergovernmental organizations. In this context a joint workshop with ICES (OSPAR) and HELCOM will be organized in 2010 on biological effects monitoring with the aim of harmonizing methodologies.

Cooperation will also be strengthened with RACs on the basis of their respective fields of competence and in the framework of the implementation of the ecosystem approach according to the adopted roadmap. Especially relevant for Phase IV of MED POL will be efficient and concrete cooperation with the European Commission in view of the relevance of its initiatives such as the Water Framework Directive, the Marine Strategy Framework Directive and the Horizon 2020 initiative.

Close cooperation will be maintained with all the relevant regional actors in the field of reporting to facilitate the efforts of the countries with different reporting obligations. In this connection, the successful work initiated with the European Environment Agency (EEA), in the framework of the signed joint work programme, will be continued and a formal protocol for the regular exchange of data will be proposed and discussed.

NGOs will continue to play a critical, key role in participating in the planning and implementation of MED POL activities. NGOs will be invited to attend MED POL meetings as appropriate and specific partnerships will be established to facilitate the implementation of specific activities at the local level. A constructive role by NGOs is also expected in the long-term implementation of the NAPs, as they were successfully involved in the formulation of the NAPs in a large number of countries.

Contacts and operational links will be intensified with regional and international donors and banks, such as the World Bank and the European Investment Bank, since their involvement could facilitate the implementation of the NAPs by the countries. As in the past, long-term partnerships will be sought with GEF and FFEM for projects and initiatives that could promote the implementation of MED POL

activities. As part of the GEF SP, an environmental economist will be recruited as a bridge between countries and donors and to assist countries in identifying the appropriate source of funding for the implementation of the NAPs.

As part of the process of preparation of regional plans/programmes, a meeting of government-designated experts will be held to examine additional draft regional plans/programmes before their submission to Contracting Parties as well as a new draft of the document describing the process of application of the differentiated approach that will be prepared by the Secretariat.

A proposal to establish permanent committees on programmes and measures and on monitoring will be made to the next Meeting of the Contracting Parties. During the biennium, the Secretariat will prepare draft mandates for both committees that will be reviewed by the MED POL Focal Points.

A number of meetings will be organized to facilitate coordination and improvement of the MED POL programme. Specifically, a meeting of MED POL Focal Points will be organized, as will a meeting to review monitoring activities.

The MED POL database will be properly managed and data will be made available for regional assessments. The MED POL Information System will also facilitate the dissemination of information throughout the region.

Finally, MED POL will continue to assist Mediterranean scientists to participate in relevant training courses and meetings.

As stakeholders have been actively involved in the process of the preparation of NAPs, MED POL, in cooperation with the Horizon 2020 initiative, GEF, WB and the appropriate NGOs, will provide assistance to national authorities for the organization of meetings to inform stakeholders about the status of the implementation of NAPs and promote the involvement of stakeholders about the follow-up and evaluation process. In addition, MED POL, in close cooperation with CP/RAC, will address regional associations of industry and business such as ASCAME, EUROCHLOR and other relevant associations to promote the implementation of NAPs in their field of action. Specific partnerships will be established, as appropriate.

MED POL, in cooperation with INFO/RAC, will implement the MAP information strategy and a system to increase the visibility of MED POL. In addition, it will assist national authorities in preparing national websites on MED POL.

II.2 Sea Based Pollution (REMPEC)

Goal

Five-year vision:

The primary goal for the activities proposed for the next five years, part of which are expected to be implemented during the 2010-2011 biennium, is to facilitate the effective implementation of the 2002 Protocol Concerning Cooperation in Preventing Pollution from Ships and, in Cases of Emergency, Combating Pollution of the Mediterranean Sea ("Prevention and Emergency" Protocol), which was adopted on 25 January 2002 and entered into force on 17 March 2004, and of the Regional Strategy for Prevention of and Response to Marine Pollution from Ships (hereunder referred to as the "Strategy"), adopted by the 14th Ordinary Meeting of the Contracting Parties to the Barcelona Convention (Portoroz, Slovenia, 8-11 November 2005), which is expected to be fully implemented in five years' time (by 2015). Some of the activities envisaged are related to the five-year indicative work programme of MAP, in particular with the cross-cutting issue of climate change.

Biennium objectives:

The general orientations of the Centre for the 2010-2011 biennium are reflected in the following specific objectives:

Objective 1.

Facilitate the ratification, implementation and enforcement of international conventions, rules and regulations related to pollution from ships. The Centre will focus its efforts, during the biennium 2010-2011, on the ratification, implementation and enforcement of the International Convention for the Prevention of Pollution from Ships, 1973 (MARPOL), including MARPOL Annex VI (air pollution), and in line with the MAP 5-year indicative programme on climate change. The Centre will also implement a number of activities related to the ratification, implementation and enforcement of the International Convention for the Control and Management of Ship's Ballast Water and Sediments, 2004 (BWM), particularly those activities planned for 2010-2011 under the GloBallast Partnerships Project, which REMPEC is currently conducting in the Mediterranean in close cooperation with SPA/RAC. This objective will be achieved by providing to the Contracting Parties general and specialized knowledge, technical expertise and advisory services as well as by facilitating exchange of experience.

Objective 2.

Maintain and develop the level of preparedness and capacities to respond to marine pollution emergencies in the region. A number of activities, carried out in cooperation with the IMO Integrated Technical Cooperation Programme (ITCP), will also be directed towards preparing Mediterranean coastal States to respond efficiently to marine pollution incidents, and the oil industry will be associated to the extent possible with the implementation of such activities. This objective will be achieved by providing the Contracting Parties with expertise and updated knowledge aimed at revising, completing or updating national and subregional strategies, operational agreements and emergency plans.

Objective 3.

Strengthen governance and provide for information and communication tools. Action to strengthen governance will be taken through two types of activities: participating in overall projects which aim at enhancing the governance of the Mediterranean Sea (application of the ecosystem approach, developing marine protected areas in the high seas) on the one hand and, on the other, following the implementation of the Governance Paper which aims at improving the internal governance of MAP. This will be achieved by improving the accessibility of relevant information and decision support tools for the Contracting Parties and through the organization of the Meeting of REMPEC Focal Points and the holding of one or two meeting(s) of the Executive Coordination Panel (ECP) at the premises of the Centre.

Biennium expected outputs:

Objective 1 output: Capacities of the Contracting Parties strengthened with respect to

ratification, transposition and enforcement of major international regulations to prevent, reduce and control pollution of the marine

environment from ships.

Objective 2 output: Contracting Parties preparedness to respond to accidental marine

pollution incidents at national, subregional and regional level

enhanced.

Objective 3 output: Governance and exchange of information on technical, scientific,

legal and administrative matters facilitated.

II.3 Cleaner Production (CP/RAC)

Sustainable Production and Consumption

Goal:

Foster the application of mechanisms leading to sustainable patterns of production and consumption and the sound management of chemicals in the Mediterranean countries.

Objective 1. Identify and take action on priorities and areas of production and consumption having the greatest impacts on the Mediterranean environment and posing a major environmental and health risks due to chemical pollution.

Objective 2. Greening the Mediterranean market and riding it of chemicals: boosting green competitiveness as a tool through which managers and industrialists drive Mediterranean SMEs to succeed in the global market, and providing technical assistance to the public and private sector of Mediterranean countries to reduce land-based pollution and assure the sustainable management of chemicals.

Objective 3. Creating partnership and synergies: creating a Mediterranean network for SCP, bringing MAP closer to the UNEP's and the EU objectives on SCP and building cooperation between MAP components and relevant agents and initiatives in the Mediterranean.

Background and rationale

For over 30 years, MAP has coordinated the joined efforts of the Mediterranean neighbouring countries to protect the environment's region from the pressure and pollution of human activities. In this sense, many successful projects have been implemented to control and prevent pollution from urban and industrial development and to protect the region's natural areas and biodiversity.

However, Blue Plan's prospects on a continuous increase of resource consumption, waste generation, climate change and pollution trends reflect a worsening of the environmental degradation. Likewise, the same prospects warn that the rise of population and the evolving globalization process in the region, accelerated by the progressive entering into force of the Euro-Mediterranean Free-Trade Area (EMFTA), will worsen the unsustainable trends and create adverse effects on the *Millennium Goals* related to poverty, health and environment. The critical impact of the EMFTA on the region's sustainability is also identified by the SIA-EMFTA Study *Sustainability Impact Assessment of the Euro-Mediterranean Free Trade Area* which warned on the greater consumption and depletion of resources that is expected from the entering into force of the EMFTA.

Basing on that, Blue Plan identifies the creation of new production and consumption patterns as a main challenge for the Mediterranean countries in order to better manage limited space, finite natural resources, a growing population, new constraints- such as climate change- and ongoing inequality.

In this context of increasing environmental challenges, the inadequate use and management of chemicals poses a special risk to both the environment and the health of human population (*Priority issues in the Mediterranean Environment. EEA*,2006). In this respect, pollution from chemicals are in many cases the consequence of both former and current unsustainable patterns of production and consumption. For example, many years of irresponsible management practices have resulted in the existence of stockpiles of obsolete chemicals while current unsustainable uses of chemicals in production processes and products are implying the unintentional generation of dioxins and furans and the existence of pesticides residues in goods for human consumption (e.g. food products).

Likewise, the mentioned SIA-EMFTA study warns, for example, on the greater agro-chemical pollution that will accompany the greater intensity of production leaded by increasing competitive pressures due to free trade.

Out of the chemical substances, the so-called Persistent Organic Pollutants (POPs) are identified by the LBS Protocol as priority substances in the development and implementation of national programmes to fight against pollution. The need to urgently address the elimination and reduction of POPs is common to all Mediterranean countries which are signatories to the Stockholm Convention, the global treaty to protect human health and the environment from those substances.

According to the mentioned above, shifting to Sustainable Consumption and Production and tackling pollution from chemicals are two priority areas to attain sustainable development in the Mediterranean. While SCP refers to an integrated approach to decouple the increasing industrial and economic development of the region from environmental pollution and resource consumption, the elimination and sound management of chemicals constitutes a major challenge in the application of the SCP.

SCP constitutes a turning point in the way MAP tackles sustainable development in the Mediterranean as it doesn't only address the question of what and where pollutant emissions and environmental degradation take place but also why those are generated. The SCP approach involves (1) analyzing the way Mediterranean countries produce and consume goods and services, (2) identifying how and why those patterns of production and consumption contribute to the environmental degradation of the Mediterranean's ecosystems and the generation of environmental and health risks due to chemical pollution and (3) implementing technical, policy, market, economic and information mechanisms through which shifting to SCP.

Implementing SCP involves a range of actions in which measures addressed to minimize the environmental impacts associated to the "production side" - i.e. cleaner production, energy efficiency, sound chemical management, etc - are to combine with the progressive implementation of mechanisms, such as sustainable public procurement or eco-labelling schemes, that integrate sustainable criteria within the value chains and the circle consumer-producer.

In order to involve the Mediterranean private sector in SCP MAP must work in triggering a change in attitude in Mediterranean companies and industries from a reactive to a proactive approach to environmental management of chemicals and hazardous waste and creating the conditions for them to move towards green competitiveness. In doing that it is essential to enhance the Best Available Techniques (BAT), Best Environmental Practices (BEP) and Cleaner Production (CP) as methods enabling industries to reduce pollution emissions and implement an environmentally sound management of water, material and energy flows. Likewise, it is necessary that governments create the appropriate regulatory and institutional frameworks to encourage and enable companies to adopt those mechanisms. In this respect, the Integrated Pollution Prevention and Control (IPPC) approach has showed to be an effective mechanism through which countries can progressively introduce BAT, BEP and CP as element in the authorization process for the most polluting industrial installations in order to achieve a high level of protection for the environment as a whole.

On the other hand, MAP actions promoting the technical improvement of production processes in industries are to be accompanied with the progressive establishment of mechanisms that favour the market conditions encouraging businesses to shift to SCP and increasing consumers' awareness and choice towards sustainable products. In this respect, the implementation of ecolabelling schemes plays a key role in increasing the visibility in the market of companies respecting environmental criteria while it gives reliable information for consumers to identify environmentally friendly products. Likewise, the application of Sustainable Public Procurement (SPP) by public organizations is becoming a crucial tool through which integrating environmental and social concerns in the supply change management of companies and organizations.

Tackling SCP provides MAP with an added value to enhance new patterns of human and institutional behaviour and innovative productive and social practices and values that enable economic development, environmental protection and an equitable distribution of wealth among countries of the region. In doing so, it is key the role to be jointly played by MAP jointly with the Mediterranean civil society in strengthening education and awareness raising on SCP as important and useful levers to facilitate the needed changes in attitudes, behaviours and knowledge. Indeed this is the right momentum to act. In this sense, nowadays, after overcoming the new millennium, people are progressively taking conscience of their own responsibility and capacity to act against the environmental degradation through their lifestyles and consumption choices. In few years, the environment has passed from being a specialized-sector matter to become a transversal issue, introduced into government's priorities, businesses, TV advertisements, curricula in schools.

In the same line, the recommendations of last UNEP International Conference on Education for Sustainable Development (Bordeaux, October 2008), underlined the need to inform and educate citizens and consumers, in order to make them aware of their fundamental rights, being able to have conscientious participation in public debates and markets; the need to enhance the integration of education for sustainable consumption in sustainable development strategies and processes at different levels and the need to provide educators with the means to act and build networks on teaching and learning experiences. In order to achieve that, it is essential to design, widely diffuse and ensure the effectiveness of good communication/informative tools and products.

At the Mediterranean level, the First Mediterranean Roundtable on Sustainable Consumption and Production highlighted the importance of education on SCP within the civil society and private sector as well as the key role of the media and public institutions to disseminate information among Mediterranean citizens. In that regard these general recommendations came out in most of the discussion groups of the Roundtable; they clearly highlighted the relevance of a Regional centre like INFO/RAC to meet these needs.

To sum up, these two relevant meetings show clearly the leadership that education and communication to general population, industries and institutions acquires in order to tackle sustainable development issues. According to that, it is clear that the Mediterranean Action Plan can not maintain its activities hidden behind a heavy institutional framework. Today, more than ever, there is a need to effectively target the civil society, private sector and educational institutions.

In this respect, MAP, through INFO/RAC as communication platform, can provide an added value by disseminating already existing products and tools addressing education on SCP (refer to Annex I) as well as by creating new ones, boosting new mechanisms of diffusion, designing new Mediterranean events and working together with Mediterranean communication channel with a view to effectively inform on SCP issues and give to the different targets the means to act in their respective fields.

II.4 Conservation of Biodiversity (SPA/RAC)

I. General objective of the work programme for the conservation of marine and coastal biodiversity

Five-year vision

As reliable data on species and natural sites are the basis of development and implementation of conservation programmes, the SPA/BD and MAP Phase II stressed the necessity of making inventories of the constitutive elements of Mediterranean marine and coastal biodiversity. Even though great efforts have been deployed there are still knowledge gaps and in the next five years to come, priority should be given to making inventories and/or increasing the store of knowledge.

Actions for the conservation of habitats, species and sensitive sites constitute the very backbone of the SPA/BD Protocol and capacity-building in the countries as this is one of the ways to ensure sustainability and actions like these can only be envisaged in the medium or long term. These actions are part of the biennium work programme and should be maintained so that during the next five years an ecosystem approach can be adopted and evaluation measures should be set up to test the efficacy of the training.

A more detailed evaluation of the impact of threats on biodiversity and means to reduce them are one of the major challenges in the medium term. Such actions have already been programmed for this biennium (work group on the sustainability of biodiversity, joint activities to reduce the impact on threatened species and sensitive sites), and should be further strengthened in line with the recommendations of the Almeria Declaration and extended to other types of threat.

It is clear that with reference to the themes dealt with by SPA/RAC, the Centre's future actions should take into account the decisions stemming directly from our field of competence and which will be adopted within the framework of international conventions (Convention on Biological Diversity, Convention on Climate Change in particular).

The present budgets available are inadequate for the implementation of the action plans adopted by the Contracting Parties (Monk Seal Action Plan or the Coralligenous Action Plan for example) and for fulfilling adequately the mission as an information centre on biodiversity and scientific watch (specific staff). Thus additional funding needs to be mobilized and partnership with the bodies concerned strengthened.

Biennium objectives

For the 2010-2011 biennium the objectives are as follows:

Objective 1. complete the inventories on the distribution of key-habitats in the Mediterranean and to develop monitoring systems of marine and coastal biodiversity

The Centre wishes to continue with its inventory work initiated during the 2008-2009 biennium, to complete and update it with the support of the Parties and scientists concerned. It also wishes to define and to set up surveillance systems which would make it possible to detect as quickly as possible any disturbance in the priority marine ecosystems so as to envisage measures to control and to reduce the causes responsible for any of the disturbances.

Objective 2. Promote the conservation of threatened species and to set up effective and adapted protection for sensitive sites

SPA/RAC with the help of its partners and the Contracting Parties want to set up real synergy so as to create new Marine Protected Areas and to strengthen the existing areas and also to seek new approaches for more targeted management and conservation. The aim is to work together to initiate a

network of Protected Areas which would respond to the expectations of the local communities in terms of sustainable development and which would also make it possible for endangered species to find sites of refuge where their populations could flourish.

Objective 3. Propose measures to reduce the threats to biodiversity

The threats must be better identified and practical and suitable measures are to be proposed to reduce them, with particular reference to climate change, accidental pollution with hydrocarbons and the non-sustainable exploitation of marine resources.

Objective 4. Improve knowledge-sharing on marine biodiversity and access to information at a regional level.

SPA/RAC wishes to strengthen exchanges between the different regional actors for better dissemination of scientific knowledge in the domains within its sphere of competence by continuing to set up the specific bibliographical database on line and by strengthening the scientific watch function.

Objective 5. Strengthen the competence of national stakeholders and improve awareness creation

The Centre intends to promote training workshops for those involved in the conservation of biodiversity and also a partnership between the Parties and an exchange of experience, and also to set up evaluation tools to ensure that the training provided is truly effective.

II.5 Priority Action Programmes (PAP/RAC)

Main goal:

The overall goal of the Priority Actions Programme is to support the implementation of the Barcelona Convention and its Protocols, which aims at protecting the environment and contributing to the sustainable development of the Mediterranean Sea area. PAP/RAC is specifically concerned with sustainable development of coastal areas and coastal regions of the Mediterranean basin, by promoting integrated coastal zone management (ICZM) as a major tool to achieve the Convention's goals. More specifically, the goal in the coming biennium is to carry out the preparatory activities for the implementation of the ICZM Protocol, which was signed in January 2008. These activities are to be carried out in the interim period before the Protocol enters into force.

The implementation of the Priority Actions Programme in the 2008-2009 biennium is carried out through activities organized in two major groups:

- Sustainable management of coastal zones; and
- Integrating development and environment.

Sustainable management of coastal zones

Objective 1:

To carry out the preparatory activities for the implementation of the ICZM Protocol (signed on 21 January 2008). These activities are meant to be carried out in the interim period before the Protocol enters into force, and are based on the previous activities and conclusions of the Expert Meeting on the Action Plan for the Implementation of the ICZM Protocol (Split, 17-18 June 2009).

Expected Outputs:

- Questionnaire for the stocktaking report of the state of the art of ICZM in the Mediterranean countries including stocktaking of existing diverse national / local experience in determining a setback
- Stocktaking report of the state of the art of ICZM in the Mediterranean
- Explanatory guide on ICZM Protocol
- Reporting format and effectiveness indicators
- Awareness-raising and training activities

Medium-term prospects:

It is expected that in the medium-term the ICZM Protocol will enter into force, i.e. that at least six countries will ratify it. It is crucial that the above activities are undertaken in order to be ready for the implementation of the Protocol when it enters into force. It is expected that the Protocol will become binding in the second part of this medium-term period.

Objective 2:

To assist the Mediterranean coastal States in implementing integrated coastal zone management (ICZM) through development and implementation of appropriate ICZM tools, improved exchange of information, increased capacity-building, and implementation of concrete projects (Coastal Area Management Programme – CAMP).

Expected Outputs:

- CAMP Morocco: Completion of the project (final activities reports, final conference)
- CAMP Italy: Feasibility Study, Project Agreement, Inception Workshop, implementation of the project
- CAMP Spain: Implementation of the project

- CAMP Montenegro: Project Agreement, Inception Report
- CAMP France: Feasibility Study, Project Agreement
- Training courses and workshops in CAMPs
- Capacity-building initiatives and participatory programmes in CAMPs
- Report on the current state of the spatial planning systems (maritime and terrestrial) in Mediterranean countries
- Workshop to propose measures to improve spatial planning in the Mediterranean countries
- Synthesis report of thematic studies on landscape management prepared in the previous biennium
- Workshop to introduce various methodologies for landscape management
- Outputs of activities envisaged by the project documents of PEGASO and GEF LME projects
- Preparation of the Coast Day celebrations
- MedOpen basic course (internet-based) on ICZM

Medium-term prospects:

The above activities are designed as assistance to countries in the implementation of ICZM, and also preparation for the implementation of the ICZM Protocol and its implementation once it enters into force. They include support to and promotion of various ICZM tools and methodologies, and carrying out local-level ICZM initiatives, such as CAMP projects, which are bound to become a crucial component of the integration of the Protocol provisions into "real-life" situations on the ground. CAMP is becoming increasingly designed as a tool for practical application of the Protocol in specific coastal areas in the Mediterranean.

Integrating development and environment

Objective 3:

To assist the Mediterranean States in implementing the Mediterranean Strategy on Sustainable Development (MSSD), in particular Chapter 2.7 related to coastal zones, and to help them develop tools for the integration of priority sectoral objectives into development policies.

Expected outputs:

- Assessment reports on vulnerability of coastal zones to risks
- Preparation of specific plans for sustainable development of islands
- Urban management plans, green belts/ecological corridors plans
- Promotion of tools for integrating environmental concerns into policies, programmes and projects
- Workshop to present the Guidelines on Integrated Coastal Urban Water System Planning in Coastal Areas of the Mediterranean (English and French)
- Workshop to present the Beach Management Guidelines for the Mediterranean (English and French)

Medium-term prospects:

The activities under this objective are all focused on the implementation of the MSSD, in particular its chapter 2.7. Most of them are more sectoral, such as urban management in coastal areas, beach management, water resources and the like, but integrated with wider coastal sustainable development strategies.

II.6 Environment and Development (Blue Plan)

The proposed programme of activities for the next biennium is in line with the content of the Strategic Intervention Framework (SIF) adopted by the Blue Plan focal points meeting in Palermo in June 2007 and feeds the 5-years programme elaborated by the MAP. It is based on four main programmes aiming at:

- Improving governance of sustainable development
- Anticipating the effects of climate change
- Adapting production and consumption patterns
- Resource and ecosystems conservation.

It also takes account of progress made under the programme submitted for 2008-2009.

1. Improving governance of sustainable development

The 2010-2011 biennium will be marked first and foremost by an assessment of the activities conducted under the aegis of the MCSD, particularly those related to the follow-up of the Mediterranean Strategy for Sustainable Development (MSSD). It will also be an opportunity to update the MSSD regarding, on the one hand, progress made on the implementation of its provisions and, on the other, new initiatives which have emerged in the region, with the Union for the Mediterranean in the forefront.

The Blue Plan is responsible for documenting the main MSSD indicators on a regular basis and is involved in the activities relating to climate change, water, energy, tourism, promoting sustainable agricultural and rural development and transport. As such, it intends to provide input to the planned evaluation work and to contribute to the updating of the strategy from its own corner and within its own field of competence. This will be achieved by setting aside a given number of man-hours per month to draw up an assessment of the activities conducted and to organise and (alongside the appropriate experts) conduct the discussions which will fuel the strategy.

In addition and in line with its terms of reference, the Blue Plan will document the MSSD's 34 priority indictors and will endeavour to assess the progress made by the states in its implementation both at global level and under the various thematic chapters. This work will provide material for the second report on the environment and development, planned for 2011. It will also be made available to Blue Plan's partners through a web interface drawn up in conjunction with Info/RAC within the framework of a new Information System on the Environment and Sustainable Development, compatible with similar instruments available at European level in particular.

2. Anticipating the effects of climate change

As far as climate change is concerned, following up on the work of the seminar held in Marseilles in October 2008 as well as the recommendations from the 13th MCSD, the Blue Plan will strive to specify the nature and scale of the expected impact, particularly in the key sectors of water, energy and tourism To this end, it will propose a set of specific indicators to be documented.

It will also start work on identifying sticking points and potential leverage within states' policies at both national and local level, in order to make progress on adapting to climate change, particularly in the building and water management sectors. In the energy sector, it will highlight the costs (investment needs, training), the benefits or the additional cost of an alternative scenario adapted to climate change compared with a trend scenario, as well as the associated socio-economic changes and the benefits (economic growth, jobs, infrastructure development, local and global pollution, quality of life) of the lines proposed in the building sector

Finally, the Blue Plan will be instrumental in leading the work of the various MAP components on this theme.

3. Adapting production and consumption patterns

Following up on the recommendations from the meeting of water ministers held in Jordan in December 2008, the Blue Plan will be instrumental in drafting the Strategy for Water in the Mediterranean, to be finalised in 2010. Drawing on the latest available data on the state of the resource and a trend scenario on evolving demand it will in particular strive to propose a regional water savings objective for the year 2025. It will subsequently study the relevance thereof, using economic information based largely on cost-benefit studies of various water management options, including short and long term environmental and social objectives.

These economic analyses should also make it possible to estimate the financial savings potentially to be made by implementing WDM policies- through comparing with supply-based policies- and serve as a basis for improving inter-sectoral water efficiency.

In the energy sector and drawing on the results of the analyses conducted in 2007 and 2008 on the theme of « energy and climate change in the Mediterranean » (Annex 7), the Blue Plan will strive to:

- Achieve a clear and precise vision of the region's energy efficiency situation, using common indicators which can be compared between states.
- Completely overhaul the Blue Plan's regional « energy » and « water » scenarios, including the issues of adaptation to climate change, European policies and the Bali roadmap.

Based on a prospective study for 2025 for the international transport sector, which distinguishes three scenarios drawn up according to growth hypotheses, the cost of energy and taking account of differentiated environmental concerns, the Blue Plan will address the impact of maritime transport on the environment, paying particular attention to the development of port infrastructure. It will also consider the consequences for Mediterranean traffic of the opening up of new shipping routes in the Arctic Ocean.

Following the work initiated on urban mobility and the distribution of a recommendations guide on the subject, the Blue Plan will initiate a discussion process on the sustainable city in the Mediterranean (Annex 9). The aim will be to help translate the provisions of the MSSD's « urban » chapter into action plans, highlighting examples of good practice relating in particular to land management, local governance and the funding of local services. This approach could foreshadow the drawing up of a « plan for sustainable urban development in the Mediterranean area ».

In the area of tourism and in accordance with the lines established at a July 2008 seminar on « Promoting sustainable tourism in the Mediterranean », the Blue Plan intends to undertake three main issues:

- Energy management: air transport and tourism
- Training and human resource management,
- Yachting and cruising: facilities and infrastructure, pollution and waste.

Blue Plan will also start systemic and territorial work allowing the destination to be addressed as the basic unit for tourist development.

In accordance with the CSD's programme of work and in conjunction with the MAP components, the Blue Plan intends to address the issue of waste management, household waste in particular. Based on a sample of case studies the production, nature and flows of waste produced in the Mediterranean-household waste in particular- will be better defined, the various processing channels analysed and proposals made as to how product life cycles can be better taken into account in modes of production and consumption.

4. Resource and ecosystems conservation

In conjunction with SPA/RAC and MEDPOL, the Blue Plan will initiate work intended to produce an estimate of the economic value of the ecological services (ES) provided by the ecosystems which comprise the Mediterranean large marine ecosystem. The estimates of the values of the various ESs will be based on the Total Economic Value (TEV) methodological framework.
