# ANNOTATED PROVISIONAL AGENDA

#### Introduction

## Agenda item 1: Opening of the meeting

- 3. The meeting will be opened at 09:30 hrs on Thursday, 17 October 2002, by the President of the Bureau, H.E. Mr Bernard Fautrier, Minister Plenipotentiary in charge of International Cooperation for the Environment and Development of Monaco.
- 4. It is expected that the Bureau will tackle all items of the Provisional Agenda during its two days meeting including the adoption of a list of decisions. It is envisaged to close the meeting of the Bureau at 17:00 hrs on 18 October 2002. The report of the meeting will be prepared at MEDU by the Secretariat and distributed to the members for their comments.
