Meeting of Experts of the Technical Implementation of the Protocol for the Protection of the Mediterranean Sea against Pollution from Land-based Sources.

Athens, 9-13 December 1985

PROVISIONAL ANNOTATED AGENDA

The Protocol for the protection of the Mediterranean Sea against pollution from Land-based Sources adopted at Athens on 17 May 1980, entered into force on 17 June 1983. At present nine Parties to the Barcelona Convention have ratified the Protocol (Algeria, Egypt, France, Italy, Monaco, Spain, Tunisia, Turkey and the EEC) and several other states have indicated that their instruments of ratification or accession will be deposited with the Depositary in the near future.

The Parties agreed to "elaborate and implement, jointly or individually, as appropriate, the necessary programmes and measures" in order to "eliminate pollution of the Protocol Area from land-based sources by substances listed in Annex I" of the Protocol (Article 5) and "to strictly limit pollution from land-based sources in the Protocol Area by substances or sources listed in Annex II" of the Protocol (Article 6).

The Parties also agreed to "progressively formulate and adopt, in co-operation with the competent international organisations, common guidelines and, as appropriate, standards of criteria" (Article 7) necessary for the effective implementation of the Protocol.

In order to facilitate the formulation and progressive adoption of programmes, measures, guidelines, standards and criteria referred to above, the third Meeting of Contracting Parties (Dubrovnik, 28 February - 4 March 1983) decided that the Secretariat should convene this Meeting of experts on the technical implementation of the Protocol (UNEP/IG.43/6, para. 87).

The following annotations to the provisional agenda for the Meeting have been prepared by the Secretariat to assist the Meeting's deliberations.

Agenda Item 1. Opening of the Meeting

The Meeting will be opened at 10.00 hours on Monday, 9 December 1985, in the Conference Room of the Co-ordinating Unit for the Mediterranean Action Plan, Athens, by the representative(s) of the Executive Director of UNEP. All Contracting Parties to the Convention for the Protection of the Mediterranean Sea against Pollution and its Related Protocols have been invited to nominate representatives to attend the Meeting. FAO, UNESCO, IOC, UNIDO, EEC, WHQ, WMO, IAEA and IMO have also been invited to designate observers to attend the Meeting.

Agenda Item 2. Rules of Procedure

The rules of procedure adopted for Meetings and conferences of the Contracting Parties to the Convention for the Protection of the Mediterranean Sea against Pollution and its Related Protocols (UNEP/IG.43/6, Annex VI) will apply, mutatis mutandis for the Meeting.

Agenda Item 3. Election of Officers

The Meeting will be invited to elect a Chairman, two Vice-Chairmen and a Rapporteur.

Agenda Item 4. Adoption of the Agenda

The Provisional Agenda, as proposed in document UNEP/WG.125/1 will be proposed for adoption by the Meeting.

Agenda Item 5. Organisation of the Work

It is proposed that the Meeting works only in plenary sessions, with the exception of any <u>ad hoc</u> working or drafting groups which may be formed in connection with any specific issue. Simultaneous English-French interpretation will be available for the plenary sessions of the Meeting, and the Meeting's documentation will be available in these two languages.

Agenda Item 6. General principles for the progressive implementation of the Protocol

The Secretariat will introduce document UNEP/WG.125/3, prepared in collaboration with the relevant international organisations. The document will contain proposals for the general principles for progressive implementation of the Protocol, including proposals for the mechanisms which may be used for the elaboration of the programmes, measures, guidelines, standards and criteria required by the Protocol. Also, this document in its Annex contains a proposed summary workplan and timetable for the formulation of programmes and measures in terms of Articles 5, 6, 7 and 13 of the Protocol. The Meeting will be invited to examine the contents of the document and to advise the Secretariat on the suitability of the proposed general principles, workplan and timetable. Documents UNEP/WG.118/Inf.23, UNEP/WG.118/Inf.23, UNEP/WG.125/Inf.4 will be at the disposal of the Meeting for background information.

Agenda Item 7. Proposals for the elaboration of programmes and measures for the elimination of pollution from land-based sources by substances listed in Annex I (Article 5)

The Secretariat will introduce document UNEP/WG.125/4 prepared incollaboration with the relevant international organisations and containing proposals for the elaboration and implementation of necessary programmes and measures for the elimination of pollution from land-based sources by substances listed in Annex I, required according to Article 5 of the Protocol. Also, this document in its Annex contains a proposed workplan and timetable for the formulation of programmes and measures in terms of Article 5 of the Protocol. The Meeting will be invited to examine the contents of the document and to advise the Secretariat on the suitability of the proposed principles as well as on the workplan and timetable proposed for their elaboration and implementation. The Meeting will be invited to examine the contents of the document "Draft Glossary of terms appearing in Annexes I, II and III to the Protocol" (UNEP/WG.125/9), prepared in co-operation with the relevant international organisations, with a view to its adoption.

Agenda Item 8. Proposals for the elaboration of programmes and measures for limiting pollution from land-based sources by substances or sources listed in Annex II (Article 6)

The Secretariat will introduce document UNEP/WG.125/5 prepared in collaboration with the relevant international organisations and containing proposals for the elaboration and implementation of suitable programmes and measures for limiting pollution from land-based sources by substances or sources listed in Annex II, required according to Article 6 of the Protocol. Also, this document in its Annex contains a proposed workplan and timetable for the formulation of programmes and measures in terms of Article 6 of the Protocol. The Meeting will be invited to examine the contents of the document and to advise the Secretariat on the suitability of the proposed principles as well as on the workplan and timetable proposed for their implementation. The Meeting will be invited to examine the contents of the document "Draft guidelines for the issue of authorisations for the discharge of liquid wastes into the Mediterranean" (UNEP/WG.125/7), prepared in co-operation with relevant international organisations, with a view to its adoption.

Agenda Item 9. Draft recommendations for the formulation of common guidelines, standards and criteria

The Secretariat will introduce document UNEP/WG.125/6 prepared in collaboration with relevant international organisations and containing proposals for the formulation and application of common guidelines, standards and criteria which may be used in the implementation of the Protocol, required according to Article 7 of the Protocol. Also, this document in its Annex contains proposed workplan and timetable for the formulation of common guidelines, standards and criteria in terms of Article 7 of the Protocol. The Meeting will be invited to examine the contents of the document and to advise the Secretariat on the suitability of the proposed programme for the formulation of common guidelines, standards and criteria as well as on the principles, workplan and timetable proposed for its implementation. The Meeting will be invited to examine the contents of the document "Draft guidelines for the computations concerning marine outfall systems for liquid effluents" (UNEP/WG.125/8), prepared in co-operation with relevant international organications, with the view of its adoption.

Agenda Item 10. MED POL monitoring and research activities relevant to the Protocol (Articles 8 and 9)

An oral presentation on results of monitoring and research activities obtained to date will be made by the Secretariat and documents UNEP/WG.118/3 and UNEP/WG.118/9 will be available to the Meeting as reference documents containing information on the latest developments in MED POL. The Meeting will be invited to take note of the fact that research activities "B", "C" and "E", which are directly related to the implementation of the Protocol, have been held in abeyance pending the results of the present Meeting. The Meeting will be invited to make recommendations regarding monitoring and research requirements relevant to the Protocol, in addition to those already specified under other Agenda items.

Agenda Item 11. Other business

Any other subject relevant to the technical implementation of the Protocol which might be brought to the attention of the Meeting by its participants or by the Secretariat, will be discussed under this Agenda item.

Agenda Item 12. Adoption of the report

A draft report of the Meeting will be submitted to participants for adoption.

Agenda Item 13. Closure of the Meeting

The Meeting is expected to be closed by the Representative(s) of the Executive Director of UNEP at 18.00 hours on Friday, 13 December 1985.
