Introduction

- 1. Following the recommendations of the 14th Meeting of the Contracting Parties held in Portoroz in November 2005, the Secretariat has prepared a proposal on a new reporting format of MAP on the basis of the criteria agreed by the Parties. It was decided that the new reporting format should be prepared by the Secretariat in close consultation with the CPs and regional and international competent organizations. Since the CP meeting in Portoroz, the Secretariat, in close cooperation with all MAP components, has developed a new reporting format. In order to review the approach and the proposed new format, the Secretariat will convene a meeting with experts on reporting. The meeting will be held at the Club Hotel Loutraki (48 Posidonos Street, 20300 Loutraki, Greece; Tel: +30-27440-60300; Fax: +30-27440-60400).
- 2. The following annotations to the provisional agenda were prepared by the Secretariat to assist the meeting in its deliberations.

Agenda item 1: Opening of the meeting

- 3. The meeting will be opened at 09:30 hrs on Thursday, 7 December 2006, by the MAP Coordinator.
- 4. It is expected that the participants will tackle all items of the Provisional Agenda during the two-day meeting. It is envisaged to close the meeting at 18:00 hrs on 8 December 2006. The recommendations of the meeting will be prepared by the Secretariat and will be submitted for adoption at the end of the meeting. The report of the meeting will be circulated to participants for adoption at a later stage.

- 7. The meeting will review and adopt the Provisional Agenda. Simultaneous interpretation in English and French will be available for all sessions.

- 11. The meeting is expected to review the proposed new reporting format and undertake an exchange of views providing the Secretariat with inputs and recommendations, with a view of further elaboration and improvement of the format, where appropriate.

12. The Secretariat will briefly present the development of this exercise. The meeting is expected to provide any related information.

Agenda item 6: Discussion and next steps

13. The meeting will discuss proposals on the next steps to be taken for the improvement of the reporting format taking into consideration the practice followed by other organizations and conventions.

14. The Secretariat will submit for adoption a set of recommendations. The report of the meeting is expected to be adopted by circulation at a later phase.
