Introduction

- 1. Following the recommendations of the First Meeting of the WG on Implementation and Compliance, held in Athens on 8-9 November 2004, a first draft document on the main elements for a possible compliance procedure under the Barcelona Convention and its protocols has been prepared by the Secretariat. A second meeting of the WG has been proposed to address also a comprehensive draft of the report on the implementation of the Barcelona Convention on the regional level for the biennium 2002-2003. The meeting is expected to propose a set of recommendations on the future steps.
- 2. The following annotations to the provisional agenda for the meeting were prepared by the Secretariat to assist the meeting in its deliberations.

Agenda item 1: Opening of the meeting

- 3. The meeting will be opened at 9:30 hrs on Monday 11 April 2005, by the MAP Coordinator Mr. Paul Mifsud.
- 4. It is expected that the participants will tackle all items of the Provisional Agenda during the one and a half day meeting. It is envisaged to close the meeting at 13:00 hrs on 12 April 2005. The recommendations of the meeting will be prepared by the Secretariat and will be submitted for adoption at the end of the meeting. The report of the meeting will be circulated to participants for adoption after the meeting.
