c) Mid-term evaluation of the implementation of SAP/NAPs,

The Secretariat will introduce the draft report on NAP/SAP implementation evaluation UNEP(DEPI)/MED WG.379/6. This evaluation was carried out in conjunction with the ongoing evaluation of the NAPs investment components and H2020 projects snapshot as mandated by the Barcelona Convention COP 17 and H2020 SC respectively. It is expected that that the UfM and EIB will provide information at the meeting on the results achieved so far and future planning.

The Meeting is expected to review the major findings and or preliminary results and provide guidance to the Secretariat on the way forward.

d) Issue paper on implementing pollution reduction and prevention policies and measures in coherence with ecosystem approach

The Secretariat will introduce document UNEP(DEPI)/MED WG.379/7. The purpose of the issue paper is to trigger the discussion of focal points on ways and means to further enhance the relevance of pollution reduction and prevention policies in the Mediterranean, measures and programmes carried out in the framework of UNEP/MAP MED POL, to ensure coherence with ECAP process and outcome as well as synergies with other relevant partners, initiatives, programmes and projects. The representatives of CP/RAC will present the recommendations of document UNEP (DEPI)/MED WG. 379/Inf.15, addressing the drivers of the Mediterranean ecosystem degradation and the SCP approach.

The meeting is expected to provide guidance to the Secretariat related to key priorities for MED POL and generally pollution reduction and prevention policies during the next biennium and beyond.

The expected outcome of this Joint Session of EcAp pollution and litter COR GEST and MED POL FPs is an updated draft list of GES and targets, with identification of EO(s)/targets, indicators, where data is available and the work undertaken makes it realistic to have an agreement/adoption of the selected GES/targets at COP18. Once cleared by the EcAp Coordination Group in September, the outcome will be submitted to COP 18.
