- Secretariat for the General Assembly processes on oceans and the law of the sea


### **DOALOS** as Secretariat to UNCLOS

- Provides information and advice on the uniform and consistent application of the Convention

- Annual resolutions on oceans and the law of the sea and sustainable fisheries
- United Nations Open-ended Informal Consultative Process on Oceans and the Law of the Sea (ICP)
- Ad Hoc Open-ended Informal Working Group to study issues relating to the conservation and sustainable use of marine biological diversity beyond areas of national jurisdiction (BBNJ)
- Regular Process for Global Reporting and Assessment of the State of the Marine Environment, including Socio-economic Aspects


