### Agreements between IOC and UNEP

- MoU between IOC and UNEP Regional Seas Programme (1984) and its Conventions and Action Plans
  - UNEP RS: primarily cooperation on marine pollution research and monitoring
    - CPPS (2003-2007, renewed)
      - Joint IOC-WMO-CPPS working group on ENSO, GOOS, ICAM, IODE
    - PERGSA (1991)
      - Implementation of regional action plan, scientific seminars and training, monitoring and assessment activities, and data collection, system of indicators for ICZM under development
    - ROPME (2001-2003, under renewal)
      - IOCINDIO, HABs, MAMCOMP, ODINCINDIO, adaptation to climate change in the coastal zone under consideration



#### **IOC Sub-Commissions**

- IOCARIBE collaboration with CEP
  - Example: "The Know Why Network" to improve knowledge and capacity building for the implementation of the LBS Protocol, also in the context of WW2BW initiative
- WESTPAC collaboration with COBSEA

#### The Mediterranean

# Core undertaking: AoA

- UNEP and IOC jointly leading the Assessment of Assessment phase of the Regular Process for Global Reporting and Assessment of the State of the Marine Environment, to be completed at the end of 2009
  - 18 regions for the AoA Regional assessments are based on the contribution of all Regional Seas Conventions and Action Plans
