Ecological Restorations collaborates and associates with other organizations with the same mind to help in the elimination of harmful chemicals such as mercury.


Ecological Restorations is a member of the International NGO, **IPEN**. With this association, Ecological Restorations takes effective part in most activities of IPEN when called upon.
