2. Context

In the lead-up to the G7 Summit, UN Environment in partnership with the Italian G7 Presidency/ Italian Ministry of Environment, Land and Sea will organize on 21 February a Global Open Dialogue and Press Briefing entitled *"Environmental Security in a Changing World"*. The event will shed light on the top environmental issues proposed for the G7 Agenda in the context of global environmental priorities, growing challenges, and multi-lateral obligations -- from the Paris Agreement to the 2030 Global Goals.

Participating in the event will be 130 eminent scientists and government representatives from more than 40 countries, members of the scientific panel responsible for producing the sixth edition of the UN flagship Global Environment Outlook – (GEO 6). The Outlook is an authoritative assessment of the state of the global environment that provides an evaluation of environmental trends, challenges, policy interventions and proposes policy options.

Gian Luca Galleti, Minister of Environment, Italy, also representing G7 Presidency has a background in regional government, and is a former mayor of Florence. He was a city councilor in Bologna from 1990 to 2009, and from 2003 to 2005 he also served on the regional assembly for the Emilia-Romagna region. He was elected to the national Italian parliament in 2006, serving on the finance committee. .



Jacqueline McGlade is Director of the Science Division at the UN Environment (UNEP). Her work at UNEP focuses on keeping the state of the environment under review through live open data monitoring with focus on air pollution, climate change, health and the development of UN-wide SDGs environmental indicators. Previously, she was Executive Director of the European Environment Agency between 2003 and 2013.



Paul Ekins, GEO 6 Co-Chair, is Professor of Resources and Environmental Policy, Director of the UCL Institute for Sustainable Resources, and Director of Research at the School of Sustainable Resources and Energy at University College London. He is Co-Director of the UK Energy Research Centre, in charge of its Energy Systems theme and leads UCL's involvement in research on Hydrogen and Bioenergy. Professor Ekins provides leadership and guidance in the areas of sustainable resource use, energy and environmental policy.



Joyeeta Gupta, GEO 6 Co-Chair is professor of environment and development in the global south at the Amsterdam Institute for Social Science Research of the University of Amsterdam and UNESCO-IHE Institute for Water Education in Delft. She is lead author in the Intergovernmental Panel on Climate Change which shared the 2007 Nobel Peace Prize with Al Gore. Professor Gupta leads the GEO teams in the areas of environmental sustainability and governance.
