Dear Global Mercury Partnership Representatives,

Through this letter, I would like to convey to you this communication in support of, and intention to join, the UNEP Global Mercury Partnership, both the Waste and Storage Partnership Areas, and to show you that we are committed to supporting the achievement of its objectives.

I take this opportunity to send you a brief review of our history where you can appreciate our concern for the care of the environment and our constant investment to make our country aware of the importance of the proper disposal of the solid waste of industries.

Tower and Tower S.A. is a 100% Peruvian company with more than 20 years of experience in the care and protection of the Environment, reflected in the management of Treatment and Recovery of lubricant bases for its energy reuse, Integral Management of Solid Waste: Collection, Transport, Characterization, Storage, Treatment and Final Disposal of hazardous and non-hazardous solid waste from the Non Municipal area.

Tower and Tower S.A. begins its operations taking care of the main shareholder's concern for the care of the environment, seeking for this purpose, the reuse of oils, generating a business through the recovery of burnt oils achieving this reuse of oils, and reducing, in the process, CO2 emissions to the environment. Subsequently, approximately 10 years ago, our General Manager and principal shareholder of Tower and Tower SA, decided to invest in a new area that has as a priority to seek the reuse of discards from the different Industries, generating a business that allows the evaluation of solid waste and re-enter the productive system all the products that could have been rescued in this evaluation process and we created our security padding in Chincha to be able to give, not only this service to rescue products that are still useful, but additionally, the final disposal of non-reusable products was offered, in an efficient and adequate manner and in a place duly conditioned for this purpose. Despite the time and money invested in this project, this service began operating only 4 years ago due to the excessive delays of the state in providing authorizations for its operation.

As a complementary service and counting on the experience and specialization in product management and hazardous waste, as well as knowledge in the handling of chemical inputs in general, Tower and Tower decided to implement the first warehouse of hazardous materials and chemical inputs inspected in its main local located in Lurín, offering to provide this service a storage area and administrative offices of 5,300 m2, in the industrial zone of the district, with all the authorizations to offer this new service since 2014, reiterating that we are the only warehouse that can offer this service with specific licenses authorized for it.

We are currently in full development of our Moquegua project, which consists of the installation of a security landfill that has 4000 hectares and is located at Km. 1132 of the Panamericana Sur - Moquegua region. At this moment the environmental impact study is being completed and all the studies attached and supporting to obtain the governmental authorizations to start operating as a Security Landfill.

In May the construction of the road to the landfill will start, from the Pan-American to the security cells and all the necessary infrastructure. The project must be finished within a calendar year, projecting it to be inaugurated in April 2019


Another development that has had great impact is the one we started in 2014 to achieve a methodology for the stabilization of mercury-containing waste, arriving to install in our Chincha Landfills the first pilot plant to provide this service throughout Latin America. This project is finished, the plant is already working and we are waiting for the governmental authorizations to be able to offer the service to our clients.

Tower and Tower S.A is investing in human capital and infrastructure executing Projects for the protection of the Environment, also develops innovative and efficient technological solutions for the management of all types of waste in industries and public and private institutions throughout the national territory.
