The Department of Revenue & Customs, Ministry of Finance, Bhutan observed the World Ozone Day on 18th September 2018

Theme: "KEEP COOL and CARRY ON..."

Bhutan acceded to the Vienna Convention for the Protection of Ozone Layer in 2004 and ratified the Montreal Protocol on Substances that Deplete Ozone Layer in the same year. Since then, the mission to phase out ODS started and is still in progress with support from National Environment Commission of Bhutan, UN Environment, UNDP and Multilateral Fund Secretariat.

The UN General Assembly proclaimed September 16 each year as the International Day for the Preservation of the Ozone Layer, commemorating the date of signing of the Montreal Protocol on Substances that Deplete the Ozone Layer. Rest of the communities in the world celebrated the day on September 16, 2018 with the theme, "Keep Cool and Carry on... Protecting our Ozone Layer and Climate on the World Ozone Day". However, with the ongoing election of the Government in Bhutan, the celebration had to be deferred by two days and marked the day on September 18, 2018 with the above theme.



Each year Customs has been actively participating in the celebration of World Ozone Day. This year too, the day was observed in six regional offices which are directly involved in regulating import and export of ODS.

The following celebrations were undertaken in the following regional offices under the Department of revenue & Customs:

<u>Paro International Airport, Regional Revenue & Customs</u> Office, Paro

To mark the day, the representatives from the various stakeholders like industrialist, hoteliers, security officials, officials from Department of Air Transport, officials from Royal Bhutan Police, officials from both the airline companies and the Dzongkhag Environment Officer were invited to witness the day. The ODS Focal Person comprehensively explained to the participants on the



importance of protecting ozone layer and the harmful effect, if it is depleted.

In addition to above, the Customs officials were briefed on their roles as an enforcement official and their responsibility in identifying ODS and examining documents related to it at every entry points.

The Customs officials and the other participants were also informed on the recent amendment in Montreal Protocol called the Kigali Amendment held in Kigali, Capital of Rwanda in December 2016, where the parties agreed to phase out the production and consumption of HFCs which is most commonly used substitute for HCFCs.

The participants were also made aware on the "Regulation on Control of Ozone Depleting Substances, 2008. Further, the licensing system on the import and export of ODS and penalties for illegal import were also briefed to the participants.

Regional Revenue & Customs Office (RRCO), Gelephu

The program included awareness workshop covering key issues like importance of the protection of the ozone layer, negative effect of the ozone layer depletion on humans, animals and the environment. The participants were invited from Bhutan Food Regulatory Authority, Department of Forest, Royal Bhutan Police, Immigration, Customs Brokers and Customs Officials.




As a part of the program, the team from customs also distributed the ODS awareness pamphlets to the hoteliers and automobile workshops.

Regional Revenue & Customs Office, Samtse



The Customs and Excise Section RRCO Samtse, conducted the World Ozone Day sensitization by visiting major importers of ODS targeting the Industrialist/Hoteliers and Automobile Workshops by sharing pamphlets and visiting their respective factories/office/hotels etc. and guiding them on impact of Ozone Depletion.

The pamphlet depicts the information regarding; "Importance of Ozone Layer, How the ODS depletes the Ozone Layer, impact of Ozone Depletion and what can we do to protect our Ozone Layer" along with the list of substitutes of ODS.

The visit schedule began from 7:30 am and concluded at 11.30 am. The day was ended by conducting in-house workshop to RRCO officials and the Clearing Agents (about 30 participants) by making presentations on the ODS issues and emerging challenges.

The following Industries, Hotels and the Automobile Workshops in two areas; proper Samtse and Gomtu (Pendenling) were identified for creating awareness:

The main reason for targeting these importers is because they are considered as the major importers of Air Conditioners, Chillers, and Refrigerating Equipments etc.... in the region.

The procurement sections of the targeted importers were sensitized on the ODS issues and the annual consumption quota. The key message passed to them was to import those ozone friendly equipments as listed in the substitute schedule of the pamphlets.



World Ozone Day Celebration, Bhutan

Regional Revenue & Customs Office, Thimphu

The day was observed in Regional Revenue and Customs Office, Thimphu by inviting hoteliers in addition to officials of the office. The participants attended were sensitized on the following:

- i. Different kinds and impact of ODS on human and environment
- ii. Use and Identification of ODS
- iii. Role of NEC and customs &
- iv. Quiz on ODS was also initiated



The outcome of the World Ozone Day was worth a million as all the participants could learn and take back something important in order to protect the ozone layer. It was also stressed on sharing the knowledge with the colleagues at work and family members at home.
