REPORT OF THE MEETING

Background

- 1. The Action Plan for the Protection, Management and Development of the Marine and Coastal Environment of the Northwest Pacific Region (NOWPAP) and three Resolutions were adopted at the First Intergovernmental Meeting (Seoul, 14 September 1994; UNEP (OCA)/NOWPAP/IG.1/5) by the States in the Northwest Pacific region: People's Republic of China, Japan, Republic of Korea and Russian Federation (hereinafter referred to as China, Japan, Korea and Russia respectively). Resolution 1 identified five areas of priority for implementation of the Action Plan, one of which was NOWPAP/1: Establishment of a Comprehensive Database and Information Management System.
- 2. The Second NOWPAP Intergovernmental Meeting held in Tokyo, Japan (20 November 1996) adopted the Program Document describing the implementation of NOWPAP projects. Regarding NOWPAP/1, Intergovernmental Oceanographic Commission (IOC) of UNESCO was designated as the implementing agency to prepare the project proposal for the second phase of the implementation.
- 3. Subsequently, the proposal for the second phase of the implementation for NOWPAP/1 was adopted at the Fourth NOWPAP Intergovernmental Meeting held in Beijing, China (6-7 April 1999). The Meeting also decided to establish a network of Regional Activity Center (RAC) for the implementation of the Action Plan.
- 4. In December 2000, the Data and Information Network Regional Activity Centre (DINRAC) hosted by the Environmental Information Center of State Environmental Protection Administration of China (SEPA) was established in Beijing based on the Resolution 2 of the Fourth NOWPAP Intergovernmental Meeting (ANNEX VI OF UNEP (WATER)/NOWPAP IG.4/7). DINRAC was designated to function as two secretariats for NOWPAP/1 and the NOWPAP/1 Coordinating Working Group (CWG) and took on the responsibilities as defined in its Terms of Reference.
- 5. Resolution 1 adopted at the Fourth NOWPAP Intergovernmental Meeting also requested the NOWPAP Members to designate necessary members for participation in the NOWPAP/1 CWG. Following up on the nomination and designation of the members of the CWG, the NOWPAP/1 CWG was established. The First Meeting of the Coordinating Working Group for the Establishment of a Comprehensive Database and Information System (NOWPAP/1) was held in Beijing (23-25 May 2001). The meeting approved the workplan and budget for DINRAC for 2001-2003 and identified ten priority fields of activities developed by DINRAC.
- 6. The Seventh NOWPAP Intergovernmental Meeting held in Vladivostok, Russia (20-22 March 2002) approved the recommendations of UNEP that a network of Focal Points (FPs) for DINRAC has to be established by re-arranging the title, organization and the responsibilities of

the existing Coordinating Working Group in order to improve the implementation of NOWPAP/1. The Seventh NOWPAP Intergovernmental Meeting also requested NOWPAP National Focal Points to nominate the DINRAC Focal Points for their respective countries.

- 7. Upon decision by the Seventh NOWPAP Intergovernmental Meeting, the CWG and the CWG Meeting for NOWPAP/1 evolved into the NOWPAP DINRAC Focal Points and the NOWPAP DINRAC Focal Points Meeting respectively as the institutional arrangement. The Focal Points Meeting would be organized once a year, starting with the First NOWPAP DINRAC Focal Points Meeting in 2002.
- 8. The First NOWPAP DINRAC Focal Points Meeting (FPM) was held in Shanghai, China (25-28 November, 2002). The meeting presented the NOWPAP DINRAC Report of activities 2001/2002 and reviewed the progress made by DINRAC for specific tasks agreed at the First CWG Meeting and also approved the activities and budget for NOWPAP DINRAC for 2002-2003 (UNEP/ NOWPAP/ DINRAC/ FPM1/13 ANNEX 3).
- 9. The Second NOWPAP DINRAC Focal Points Meeting was held in Sanya, China (29 October-1 November 2003). Besides the routine DINRAC activity report 2002/2003, the meeting mainly discussed and reviewed the General NOWPAP Policy on Data and Information Sharing and Guidelines (Activity D) and the Establishment of Principles and Guidelines for NOWPAP Meta-database Management System (Activity E). The meeting also approved the workplan and budget for NOWPAP DINRAC for 2004/2005 (UNEP/NOWPAP/DINRAC/FPM2/15 ANNEX 7).
- 10. The Eighth NOWPAP Intergovernmental Meeting held in Sanya, China (5-7 November 2003) approved the workplan and budget of NOWPAP for 2004/2005, including the budget of \$150,000 for DINRAC activities (UNEP/NOWPAP/IG.8/11 Annex I Resolution). The meeting also approved the Terms of Reference for the NOWPAP DINRAC Focal Points Meeting.
- 11. The Third NOWPAP DINRAC Focal Points Meeting was held on 26-28 October, 2004 in Busan, Korea. The meeting mainly discussed new suggested specific activities and mechanisms for implementation of DINRAC activities. The draft ToR for NOWPAP experts group and workplan and budget for NOWPAP DINRAC for 2004/2005 were also revised and agreed by the meeting. The Activity I on the Framework for the Creation of NOWPAP DINRAC Meta-database, Activity J on the Existing GIS-type Products from within and outside of NOWPAP regions and Activity K on the Compilation of National Reports and Regional Report on Coastal and Marine Biodiversity Data and Information were also agreed to be put into the DINRAC workplan for the biennium of 2004/2005.
- 12. In the Ninth NOWPAP Intergovernmental Meeting held on October 30-November 2 in Busan, Korea, the proposal for NOWPAP RACs evolution and direction change was put forward by UNEP for discussion. With regard to specific technical aspects, the proposal for RACs evolution and the Activity K of DINRAC was postponed until the NOWPAP Intersessional Workshop in 2005. The Activity I and Activity J were approved by the IGM to be

implemented in 2005.

- 13. In accordance with the recommendations of the First Intersessional Workshop of NOWPAP held in Seoul, Korea, 25-26 July, 2005, data resulting from other NOWPAP RACs activities (oil spill, HABs, atmospheric and river inputs of contaminants, etc.) and biodiversity data could be also included into DINRAC database. Contributions towards implementation of global biodiversity conventions (CBD, CITES, CMS, RAMSAR, etc.) and joint work with MERRAC on marine invasive species were also suggested for future DINRAC activities.
- 14. The Fourth NOWPAP DINRAC Focal Points Meeting was held on 27-28 September, 2005 in Dalian, China. The meeting mainly reviewed progress of the Activity I on the Framework for the Creation of NOWPAP DINRAC Meta-database and the Activity J on the Existing GIS-type Products from within and outside of NOWPAP regions. The meeting also discussed and approved the proposed DINRAC workplan and budget for the 2006/2007 biennium (UNEP/NOWPAP/DINRAC/FPM 4/17 ANNEX VI).
- 15. The Fifth NOWPAP DINRAC Focal Points Meeting was held on 10-11 May, 2006 in Shenzhen, China. The meeting mainly discussed DINRAC's newly proposed activities and revised proposed workplan and budget for the biennium 2006/2007 based upon the decision of the 10th Intergovernmental Meeting on NOWPAP. The meeting also agreed to submit "General NOWPAP Policy on Data and Information Sharing" to the 11th IGM on NOWPAP for final approval.
- 16. The Sixth NOWPAP DINRAC Focal Points Meeting was held on 24-25 May, 2007 in Beijing, China. The meeting mainly reviewed progress of the Framework and Further Development for the Creation of NOWPAP DINRAC Meta-database (Activity I), Compilation of the National Report and Regional Report on Marine and Coastal Biodiversity Data and Information in the NOWPAP Region (Activity K), Development of DINRAC Switchboard Accessing National Website of NOWPAP Members (Activity L), Establishment of the Database of Marine and Coastal Nature Reserves in the NOWPAP Region (Activity M) and Compilation of the Regional Overview of Legal Aspects of the Protection and Management of the Marine and Coastal Environment of NOWPAP Region (Activity O) The meeting also discussed and approved the proposed DINRAC workplan and budget for the 2008/2009 biennium (UNEP/NOWPAP/DINRAC/FPM 6/22 ANNEX VI) and agreed to submit the workplan and budget for the 2008/2009 biennium to the 12th IGM on NOWPAP for final approval. During the meeting a letter of cooperation (LOC) between YSLME PMO and NOWPAP RCU was signed on building up a Yellow Sea partnership for protection of marine and coastal environment in the Yellow Sea. The LOC encourages among others, sharing data, information and expertise.
- 17. Based upon the agreement of the Sixth NOWPAP DINRAC Focal Points Meeting, the Seventh NOWPAP DINRAC Focal Points Meeting was held on 13-14 May, 2008 in Beijing, China. The Data and Information Network Regional Activity Centre (DINRAC) acted as secretariat for the meeting. The participants of the meeting included DINRAC Focal Points and

experts from NOWPAP Members: China, Japan, Korea and Russia as well as RCU representatives. The directors and representatives of the Special Monitoring & Coastal Environmental Assessment Regional Activity Centre (CEARAC), the Marine Environmental Emergency Preparedness and Response Regional Activity Centre (MERRAC), the Pollution Monitoring Regional Activity Centre (POMRAC) and the UNDP/GEF Yellow Sea Large Marine Ecosystem (YSLME) Project, COBSEA and PICES also participated in the meeting as observers (UNEP/NOWPAP/DINRAC/FPM 7/4).

Agenda item 1: Opening of the meeting

- 18. The Meeting was opened at 9:10 a.m. on May 13, 2008 in Beijing, People's Republic of China by Mr. Jianguo WANG, Director of DINRAC. Mr. Jianguo WANG expressed his welcome to all the participants and announced the opening of the meeting. In his opening remarks, he also thanked NOWPAP RCU and NOWPAP Member Country FPs for their kind support and contributions to DINRAC activities.
- 19. Mr. Xiaodong ZHONG, Deputy Coordinator of NOWPAP RCU, delivered an opening speech to the meeting on behalf of NOWPAP RCU. He first expressed his greetings to the participants of the Meeting. He noted that DINRAC served as a sound platform for information exchange of NOWPAP member countries and hoped that all the FPs could contribute more time and efforts to the tasks assigned to them. Finally, he expressed his sincere appreciation to the Ministry of Environmental Protection of China for continuous support for DINRAC and NOWPAP and also to DINRAC for their hard work in preparation of the meeting.
- 20. The delegates from Korea, Russia, China and Japan expressed their thanks to DINRAC for hosting the Meeting and hoped the Meeting would be fruitful and successful.

Agenda item 2: Organization of the meeting

Agenda item 2.1: Election of the officers (Chairperson, Rapporteur)

21. According to the Terms of Reference for the NOWPAP DINRAC Focal Points Meeting (UNEP/NOWPAP/DINRAC/FPM 3/17), the Meeting unanimously elected Dr. Igor ROSTOV, Russian Focal Point, as the Chairperson, and Dr. Xiangbin PEI, Chinese Focal Point, as the Rapporteur respectively.

Agenda item 2.2: Organization of work

- 22. The Meeting agreed to apply mutates mutandis the rules of procedures for the Meeting in line with the provision in the Terms of Reference of the NOWPAP DINRAC Focal Points Meeting (UNEP/NOWPAP/DINRAC/FPM 3/17).
- 23. The Director of DINRAC presented a provisional list of documents.

Agenda item 2.3: Adoption of the agenda

- 24. Upon the invitation of the Chairperson, the Director of DINRAC, Mr. WANG made a brief introduction to the Provisional Agenda (UNEP/NOWPAP/DINRAC/FPM 7/1) with the Annotated Provisional Agenda (UNEP/NOWPAP/DINRAC/FPM 7/2). He stressed that meeting should especially focus on the discussion of progress reports on DINRAC activities in 2007, proposal for new DINRAC activities and proposal for the DINRAC's workplan and budget for the 2008/2009 biennium.
- 25. The Meeting unanimously adopted the agenda.

Agenda item 3: RCU's presentation on the implementation of NOWPAP

26. Mr. Xiaodong ZHONG, Deputy Coordinator of NOWPAP RCU, presented to the Meeting a report on the implementation of NOWPAP since the 6th DINRAC focal points meeting, in which brief introduction to current activities of CEARAC, MERARC and POMRAC was made and other NOWPAP activities including implementation of the decisions of 12th IGM, building partnerships, public awareness raising, evaluation of RACs and Marine Litter Activity (MALITA). The issue regarding the strengthening of cooperation with partners and among different RACs is also noted.

Agenda item 4: Overview of the progress made in the intersessional period after the Sixth NOWPAP DINRAC Focal Points Meeting

Agenda item 4.1: Report on the implementation of DINRAC Activities in 2007

27. The Director of DINRAC, Mr. Jianguo WANG, presented the report on the DINRAC activities implemented in 2007 (UNEP/NOWPAP/DINRAC/FPM 7/6-1). In his presentation, the specific activities implemented by DINRAC since the 6th NOWPAP DINRAC Focal Points Meeting were introduced briefly. Finally, he called for continuous support from DINRAC FPs and RCU to DINRAC projects.

Agenda item 4.2: Report on the annual expenditure of DINRAC budget for 2006/2007 biennium

28. The Director of DINRAC, Mr. Jianguo WANG, subsequently presented the report on the annual expenditure of DINRAC budget in 2006/2007 (UNEP/NOWPAP/DINRAC/FPM 7/6-2). He then suggested that the use of the unspent budget for Activity I be discussed in latter session of the meeting.

Agenda item 4.3: Progress report on the Implementation of the DINRAC Activities and suggestions for the next biennium from four member states

- 29. Chinese Focal Point, Dr. Xiangbin PEI made a presentation on the implementation of the Update, Maintenance and Enrichment of the Database of Institutions and Experts on Coastal and Marine Environment (activity C), Activity L and Establishment of a Meta-database on Contaminants and Nutrients in the Coastal and Marine Environment (Activity N) in China after the 6th DINRAC FPM and his suggestions for DINRAC activity in next biennium (UNEP/NOWPAP/DINRAC/FPM 7/8-1).
- 30. Japanese Focal Point, Mr. Yoshiharu NAGAYA made a presentation on the implementation of DINRAC Activity C, L and N in Japan after the 6th DINRAC FPM and his suggestions for DINRAC activity in next biennium (UNEP/NOWPAP/DINRAC/FPM 7/8-2) including the collaboration between DINRAC and OBIS.
- 31. Korean Focal Point, Dr. Hee-Dong JEONG made a presentation on the implementation of DINRAC Activity C, L and N in Republic of Korea after the 6th DINRAC FPM and his suggestions for DINRAC activity in next biennium (UNEP/NOWPAP/DINRAC/FPM 7/8-3).
- 32. Russian Focal Point, Dr. Nikolay RYKOV made a presentation on the implementation of DINRAC Activity C, L and N in Russia after the 6th DINRAC FPM and his suggestions for the next biennium (UNEP/NOWPAP/DINRAC/FPM 7/8-4).

Agenda item 4.4 Progress Report on the Frame Work for Creation of NOWPAP DINRAC Meta-database (Activity I)

- 33. A DINRAC staff, Ms. Tong AN made an introduction of the progress of the Activity I (ongoing) (UNEP/NOWPAP/DINRAC/FPM 7/9). She first expressed appreciation to Korean FP and RCU for their continuous support. Then she briefly summarized background information, the expected objectives, functions and current status for Activity I. She noted that some problems existed in the DINRAC meta-database framework and asked the meeting to consider whether to continue the activity.
- 34. Mr. Xiaodong ZHONG commented that the results of Activity I were achieved not as anticipated. He suggested DINRAC to consider whether to continue this activity or appropriate the money to other activities. The meeting decided to have a small-group discussion on this issue and then report the result to the meeting.

Agenda item 4.5: Progress report on the Creation of Regional Internet Communication System between DINRAC and NOWPAP Member Countries (Activity L)

35. Russian Expert, Mr. Vladimir ROSTOV made an introduction of the progress of the Activity L (UNEP/NOWPAP/DINRAC/FPM 7/10). He briefly summarized pilot implementation of Activity L by Russian FP and introduced framework for the creation of Regional Internet

Communication System (RICS) between DINRAC and NOWPAP members including tasks, requirements and specification, system function, system evolution, system structure and its operational models, etc. Besides, he also demonstrated the procedures of enquiry on the pilot version of DINRAC regional Portal as well as the enquiry results.

- 36. Mr. Jianguo WANG extended his congratulation for Russian FP's excellent pilot work on implementation of Activity L, especially for the 155 information resources provided at the website. He hoped that other DINRAC member countries could cooperate and support this activity and the activity could generate more results.
- 37. Mr. Xiaodong ZHONG asked all the FPs to make a decision on whether they think the activity L should be continued. All the FPs agreed the continuation of the activity L, and Japanese FP pointed out that modification should be made to the system to make it more useful. Mr. ZHONG then indicated that the data provided in the system should be more relevant to NOWPAP or its member countries by citing some examples. He also suggested providing brief information of the targeted web pages on the websites of each member country rather than offering the link only.

Agenda item 4.6: Progress report on the Establishment of the Meta-database on Contaminants and Nutrients in the Coastal and Marine Environment (Activity N)

- 38. Japanese Focal Point, Mr. Yoshiharu NAGAYA made an introduction of the progress of the Activity N (UNEP/NOWPAP/DINRAC/FPM 7/11), especially some surveys conducted by Japan. The participants discussed the progress.
- 39. Mr. Xiaodong ZHONG first expressed appreciation to Japan FP for carrying out the activity without any budget. He then asked if any further action was needed for this activity.

Agenda item 4.7 Progress report on Establishment of the Reference Database on ICARM (Joint activity DINRAC with POMRAC)

40. Ms. Tong AN, DINRAC staff, presented a progress report on the Establishment of the Reference Database on Integrated Coastal and River Basin Management in NOWPAP Region (ICARM, Joint activity DINRAC with POMRAC) (UNEP/NOWPAP/DINRAC/FPM 7/12). She briefly introduced background information, current progress and demonstrated the procedures of on-line enquiry on the website and the results in the presentation. The Reference Database ICARM is now available at http://dinrac.nowpap.org/NowpapReferenceICARM.php3.

Agenda item 4.8 Progress report on the implementation of NOWPAP Marine Litter Activity (MALITA)

41. Prof. Yudong ZHU, DINRAC staff, made a brief report on the progress of NOWPAP Marine Litter (MALITA) Activity (UNEP/NOWPAP/DINRAC/FPM 7/16). He mainly summarized

the implementation of Activity 5 (collection and review of existing information and data relevant to marine litter in each of the NOWPAP members) and Activity 6 (collection of information on relevant legal instruments and programmes on marine litter in each of the NOWPAP members) of the MALITA Workplan by DINRAC in 2007. He also briefed the meeting about the RAP MALI Working Meeting.

Agenda item 5: Information about relevant activities of international organizations and projects

- 42. In order to share their relevant expertise on many issues related to marine environmental data and information management, the representatives of the partner organizations/institutions in the NOWPAP region, such as COBSEA, YSLME and PICES were invited to make presentation.
- 43. Dr. Durairaju Kumaran Raju, the representative of COBSEA, made a brief introduction on the development of the East Asian Seas (EAS) Knowledgebase by his organization including the briefing on the pilot phase, component and structure of this Knowledgebase as well as other activities they are undertaking in pursuing the sustainability of the project.
- 44. Mr. Isao ENDO, the representative of UNDP/GEF Yellow Sea Project, expressed his sincere gratitude towards the cooperation and support provided by NOWPAP. He briefly introduced data and information activities in UNDP/GEF Project on the Yellow Sea Large Marine Ecosystem (YSLME). He mentioned that the YSLME Project hoped to expand and strengthen the cooperation with the NOWPAP in various aspects, especially in the field of data and information management.
- 45. Dr. Toru SUZUKI, the representative of PICES, made a presentation on PICES Metadata Federation. He introduced the structure of PICES and objectives, methodology, etc. about PICES' Metadata Federation.
- 46. All the participants agreed to have a small-group discussion during the coffee break of the afternoon session of the meeting over the future development of the activity I. DINRAC Director Mr. Jianguo WANG reported to the meeting the results of the discussion: the FPs of four DINRAC member countries and RCU had reached the consensus that the activity I should be suspended and the 6,000 US\$ budget would be allocated to another activity.

Agenda item 6: Discussion on new suggested future activities in 2008-2009 biennium

Agenda item 6.1: Proposal for the Investigation on Alien Species and its Potential Damage Evaluation in NOWPAP Region

47. Mr. Jing XU, an expert from China made a presentation on the Proposal for Investigation on Alien Species and Its Potential Damage Evaluation in NOWPAP Region (UNEP/NOWPAP/

DINRAC/FPM 7/14). The participants discussed the proposal. Japanese FP, Prof. SHIRAYAMA pointed out the existence of more or less duplication with other databases such as IMO and IUCN.

Agenda item 6.2: Proposal for Collaboration with OBIS (Ocean Biogeography information system

48. Prof. Yoshihisa SHIRAYAMA, a Focal Point from Japan made a presentation on the Proposal for Collaboration between DINRAC and Ocean Biogeography Information System (OBIS) in Japan (UNEP/NOWPAP/ DINRAC/FPM 7/15). He suggested several potential steps to be taken for this collaboration including step 1: providing four-language linkage to the website of OBIS; step 2: offering four-language version of the front page of OBIS website but with the search results only in English; step 3: search results also in four-language version on the basis of step 3; and step 4: direct connection of DINRAC database to OBIS enquiry system. The participants discussed this proposal and felt it was necessary to make further discussions through e-mails.

Agenda item 6.3: New Suggested Activities in 2008-2009 Biennium and Later

49. Dr. Igor ROSTOV, Russian Focal Point, made a presentation on new suggested future activities in 2008-2009 biennium. In the presentation, he indicated that the activity L should be continued and proposed ideas to be carried out in the future. The participants discussed the proposal and agreed that usefulness/relevance should be considered as the key criteria for selecting future activities.

Agenda item 6.4: Actions for implementation of NOWPAP Regional Action Plan on Marine Litter (RAP MALI)

50. A DINRAC staff, Prof. Yudong ZHU made an introduction on the Actions for implementation of NOWPAP Regional Action Plan on Marine Litter (RAP MALI) (UNEP/NOWPAP/DINRAC/FPM 7/16) including the meaning, three goals, workplan and budget of RAP MALI.

Agenda item 6.5: New Suggested Future Activities and Budget Allocation in 2008-2009 Biennium

- 51. The Director of DINRAC, Mr. Jianguo WANG, made a brief presentation on the proposed Workplan and Budget Allocation in 2008/2009 biennium (UNEP/NOWPAP/DINRAC/FPM 7/17).
- 52. Dr. Igor ROSTOV FP from Russia, requested 1,000 US\$ extra fund to be allocated to Russia for the development of new system functions under the activity L. With reference to the suggestion made by Japanese FP and RCU in previous session (see Paragraph No. 37), all

the participants finally agreed, after a lengthy discussion, to carry out both the tasks of adding more functions to the system and improving the quality of the data input in the future.

Agenda item 7: Draft Arrangement of intersessional work

- 53. Japanese FP, Mr. Yoshiharu NAGAYA presented a renewed budget proposal for the next biennium to the Meeting. He suggested that activity N should be finished in 2008; activity Q should be discussed in the next Focal Point Meeting with participants from IMO, IUCN and other bodies to decide further actions; and that activity G should be carried out to extend the length of the 8th FPM in 2009 to longer than 2 days so more experts from other communities can be invited to contribute their proposals. The participants discussed and agreed Japan's proposal in principle. Mr. Xiaodong ZHONG noted that experts from various countries should be fully and well prepared before the FPM and submit mature proposals to the meeting.
- 54. Upon the invitation of Chairperson, the Director of DINRAC, Mr. Jianguo WANG, introduced the arrangement of intersessional work before the 8th NOWPAP DINRAC Focal Points Meeting (UNEP/NOWPAP/ DINRAC/FPM 7/18). Chinese FP, Dr. Xiangbin PEI, indicated the potential intensification of activities in the field of marine litter such as awareness raising and public education.

Agenda item 8: Venue and date of the Eighth NOWPAP DINRAC Focal Points Meeting

55. The Meeting agreed that the Eighth NOWPAP DINRAC Focal Points Meeting would be held in Beijing, China in the second week of May, 2009.

Agenda item 9: Other matters

- 56. Japanese FP, Prof. Yoshihisa SHIRAYAMA pointed out the confusion on the DINRAC Activity Q. Activity Q has been titled as "WebGIS-based electronic oil pollution incidents report in NOWPAP region in the 6th DINRAC FPM, but in the 7th DINRAC FPM, Activity Q referred to "Investigation on alien species and its potential damage evaluation in NOWPAP region".
- 57. The Director of DINRAC, Mr. Jianguo WANG explained the reasons why the Activity Q's substitution of Alien Species for Oil Pollution Incidents.
 - There is some duplication work with MERRAC's activity if it is put into action;
 - There is no extra budget to purchase the WebGIS platform software;
- The DINRAC's budget in 2008-2009 biennium has been reduced by the 12th NOWPAP IGM.

He also clarified to cancel the Activity of WebGIS on Oil Pollution Incidents and the change of the contents for the DINRAC Activity Q from the 7th FPM tentatively. The meeting understood his explanation.

Agenda item 10: Adoption of the report of the meeting

58. The draft report of the Seventh NOWPAP DINRAC Focal Points Meeting was prepared for consideration and adoption. The report was adopted by the meeting as the record of its deliberations.

Agenda item 11: Closure of the meeting

59. After the customary exchange of courtesies, the Chairperson declared the closure of the Meeting by 12:30 on Wednesday, 14 May 2008.

REPORT ON THE IMPLEMENTATION OF DINRAC ACTIVITIES IN 2007

1. Introduction

Based on the Project Proposal for Phase II of the Establishment of a Comprehensive Database and Information Management System (NOWPAP/1) and the Resolution 2 of the Fourth Intergovernmental Meeting on the NOWPAP (Beijing, 6-7 April 1999), Institutional Arrangements for Implementation of NOWPAP, "decided to designate the Regional Activity Centre, as described in Annex VII of the UNEP (Water)/NOWPAP IG.4/7", the NOWPAP Data and Information Network Regional Activity Centre (NOWPAP DINRAC) was designated to be established.

In December 2000, NOWPAP DINRAC was formally established in Environmental Information Center (EIC) of State Environmental Protection Administration of China (SEPA). The purpose of the establishment of NOWPAP DINRAC is to coordinate various regional activities relevant to DINRAC and to offer the reliable and up-to-date information services for coastal and marine environment in NOWPAP region. Especially, the Centre is currently functioning as secretariat for the NOWPAP DINRAC Focal Points Meeting, Experts Meeting, and the NOWPAP Regional Policy on Data and Information Sharing and NOWPAP Regional Marine and Coastal Meta-database with assistance from UNEP. The Centre also manages the NOWPAP DINRAC Homepages.

DINRAC has the specific objective to coordinate regional activities, as specified in the terms of reference decided at the Fourth Intergovernmental Meeting. DINRAC was established recognizing that the activities under NOWPAP produce information on a number of different topics from several sources, the need for regional harmonization of data sets and information system, development of databases and networks for linking relevant institutions in the region and providing coherent information to serve the needs of the regions, as well as the need to develop protocols on data sharing. The development of a comprehensive database and information management system for the region through activity is coordinated and implemented by DINRAC. Other priority activities included building further data management capacity in the region and developing guidelines and a regional policy on data and information sharing.

DINRAC activities are carried out in coordination with the NOWPAP RCU and consultation with the other NOWPAP RACs for efficient information exchanges.

2. Organization, Staff and Budget

DINRAC project team is managed by Policy Research Center for Environment and Economy of SEPA since August 2006. Three staff members are currently employed at DINRAC with the financial support from the government of China. SEPA sponsors all DINRAC staffs salary and facilities on a total USD \$55,000 annually. DINRAC is also funded by NOWPAP Trust Fund approved by the Tenth NOWPAP Intergovernmental Meeting on a total USD \$165,500 for 2006-2007 biennium for the DINRAC activities such as Focal Points Meeting, specific projects, MALITA, NOWPAP/2 and others.

3. Major Activities of DINRAC in 2007

1) The Sixth NOWPAP DINRAC Focal Points Meeting:

- The Sixth NOWPAP DINRAC Focal Points Meeting took place in Beijing, the People's Republic of China, from 24 to 25 May 2007, with kind support from RCU.
- The meeting reviewed the progress made in the intersessional period after the Fifth NOWPAP DINRAC Focal Points Meeting.
- The major issues such as establishment of DINRAC website as a clearing-house of NOWPAP, using the concept of switchboard accessing national website of NOWPAP members has been discussed.
- Framework and further development for the creation of NOWPAP Meta-database System had been conducted by the meeting. It is expected to finish the development as early as possible.
- Progress reports on the compilation of national and regional reports on marine and coastal biodiversity data and information, establishment of the database of marine and coastal nature reserves, compilation of the regional overview of legal aspects of the protection and management of the marine and coastal environment and establishment of the reference database on AD & RDI, NOWPAP Marine Litter programme activity 5 and 6 had been presented to the meeting.
- The proposal for establishment of the meta-database on contaminants and nutrients in the marine and coastal environment was agreed by the meeting.
- The meeting discussed DINRAC's newly expected activities and revised proposed workplan and budget for the biennium 2008/2009.
- The meeting agreed to submit DINRAC's workplan and budget allocation in biennium 2008/2009 to the 12th IGM on NOWPAP.

2) Update, Maintenance and Enrichment of DINRAC Website

As one of main DINRAC activities of 2007, DINRAC website was updated and enriched, which is now functioning as a primary source of environmental data and information for the NOWPAP region, with the ultimate goal to serve as "NOWPAP Clearing House" to provide data and information on marine environment quality in the NOWPAP region.

Data and Information resulted from NOWPAP activities by RACs, RCU, Focal Points and Working Groups of RACs are also covered, accessed and linked at the Website. In addition, related national sources and international sources on marine data and information are also included as supplement to make the website as a portal on marine data and information of NOWPAP.

Under the new framework, there are total 7 columns: About, Marine Environment, NOWPAP Databases, NOWPAP Publications, NOWPAP Meetings, Related Organizations and Links (For detail, please visit http://dinrac.nowpap.org/About.htm).

3) Framework for the Creation of NOWPAP DINRAC Meta-database

The Republic of Korea is the leading country to implement this activity. This activity has been lasted three and half years for the software development.

Bugs or problems of the Frame Work of Mate-database system still existed at the end of December, 2007.

4) The specific activities being carried out in 2007

 Activity L: Establishment of Regional Internet Communication Systems between DINRAC and NOWPAP Member Countries

Russian Federation is the leading country to implement this activity. This activity provided data and information on coastal and marine environment through national/regional websites/webpages by using DINRAC portal as "switchboard" according/in context to national laws and regulations. It established the formal linkages among relevant agencies, DINRAC and other RACs to strengthen cooperation between parties.

The Framework and Pilot version of the system has been accessed on the website of Pacific Oceanological Institute as http://pacificinfo.ru/nowpap_demo/.

The 'DINRAC Regional Portal' and 'NowpapIR' which are the main results from the DINRAC Activity L could be also accessed at DINRAC Website http://dinrac.nowpap.org/MarineEnv_NOWPAP.htm and/or http://dinrac.nowpap.org/Databases.php3 respectively.

- Activity K: Compilation of National Reports and Regional Report on Coastal and Marine Biodiversity Data and Information in the NOWPAP Region
 - It gives a general overview on the current status of marine and coastal biodiversity data and information in the region and then identifies existing gaps and needs and makes recommendations for future work so as to follow the current trend of wise marine biological management worldwide and achieve marine resources sustainability of the region.
 - The publication of the complied reports (UNEP/NOWPAP/DINRAC/Publication No.6) has been distributed in September, 2007.
- Activity M: Establishment of the Database on Coastal and Marine Nature Reserves in the NOWPAP region

P. R. China is the leading country to implement this activity. The database has also been developed (based on questionnaires) by DINRAC and now could be accessed at DINRAC website http://dinrac.nowpap.org/NowpapNatureReserve.php3.

It gives a review and understanding on the current situation of nature reserves, including the location, name, level, type, area, nature condition, social and economical situation, management, marine protected species, diversity and list of endangered species so as to promote information exchange and distribution on marine and coastal environmental protection in the NOWPAP Region.

The publication (UNEP/NOWPAP/DINRAC/Publication No.7) has been distributed in September, 2007.

- Activity N: Establishment of the meta-database or database on Contaminants and Nutrients in the Coastal and Marine Environment

 Japan is the leading country to implement this activity. Metadata of 7 surveys on contaminants in the marine environment carried out by Japanese organizations and 16 Questionnaires filled by Russian Focal Points have been submitted to DINRAC in February and March, 2008 respectively. The related meta-database is creating by DINRAC now. It will provide a general overview on the current data/information availability on chemical contaminants and nutrients gathered from late surveys in the member countries, including sea and river water, bottom sediment and in biota, and will be helpful for the public to have a general understanding on and find useful information about environmental data products relating to the contaminants and nutrients in the coastal and marine environment of NOWPAP region.
- Coordination for National Summary of NOWPAP MALITA Activity 5 and 6
 Regional Overview on Legal Instruments, Institutional Arrangements and Programmes
 Related to Marine Litter in the NOWPAP Region (MALITA Activity 6) identified barriers,
 gaps and needs in relation to the prevention, control and management of marine litter. The
 finding of this overview including suggestions and recommendations reflected in
 developing the NOWPAP regional action plan on marine litter.

The publication (UNEP/NOWPAP/DINRAC/Publication No.8) has been distributed in October, 2007.

The MALITA WebPages, as a new column of DINRAC Website is presented for review at http://dinrac.nowpap.org/MALITA Whatis.htm.

The Data & Information for the MALITA activity (MALITA 5) related contents and files provided by P. R. China, Republic of Korea and Japan can be also found at DINRAC MALITA WebPages.

- Activity O: Compilation and publication of the Updating the Regional Overview of Legal Aspects of the Protection and Management of the Marine and Coastal Environment of the Northwest Pacific Region (NOWPAP/2)

The regional overview is prepared according to the Resolution 7 of the 10th IGM and

finalized based primarily on the latest data and information provided by NOWPAP member states.

It focuses on introducing the existing national and international legal frameworks in NOWPAP member states related to environmental protection and providing useful information for people who may be interested to take a glimpse at the current situation in the region.

The publication (UNEP/NOWPAP/DINRAC/Publication No.5) has been distributed in July, 2007.

- Activity C: Updating and maintenance of NowpapExpert and NowpapInstitution databases
 It is developed to be a tool for scientists, policy-makers and anyone else who is interested
 in getting information on coastal and marine environmental experts, institutions in the
 NOWPAP region.
- The Reference Database on Integrated Coastal and River Basin Management in NOWPAP Region (ICARM Reference Database) ICARM Reference Database has been created at the early of 2008. It is a result of cooperation on database between POMRAC and DINRAC after implementation of AD and RDI Reference Databases successfully. lt could be visited at http://dinrac.nowpap.org/Databases.php3 or http://dinrac.nowpap.org/NowpapReferencelCARM.php3.

4. summary

DINRAC has been building partnerships among NOWPAP Members through conducting the designated activities in the filed of data and information sharing and exchange in the NOWPAP region with great support from NOWPAP RCU and UNEP. DINRAC has also achieved some important results through national focal points meetings and coordination of DINRAC during the bennium of 2006-2007. Especially, the Activity on Establishment of Regional Internet Communication System between DINRAC and NOWPAP Member Countries (Activity L) were important implemented in this biennium.

DINRAC would ensure more effective and efficient regional activities in the field of data and information management. In addition, closer cooperation among RACs and responsible DINRAC FPs are quite necessary.

As the scope of RACs activities was expanded by agreement of 10th NOWPAP IGM, DINRAC is responsible for providing data storage and retrieval as well as information network for all NOWPAP activities. The DINRAC website was envisioned as a primary source of environmental data and information for the NOWPAP region and also as a "switchboard" to provide links to resources available in NOWPAP member countries. It is suggested that the data resulting from other NOWPAP RACs activities (oil spills, HABs, atmospheric and river inputs of contaminants, etc.) could be also included into DINRAC database. Contributions towards implementation of global biodiversity conventions (CBD, CITES, CMS, Ramsar, etc.) and joint work with MERRAC on alien species are also suggested for future DINRAC activities.

DINRAC would operate as a portal for the whole NOWPAP system with the support of RCU and other RACs. It would strengthen data management capacity building and supervision on

Budget: USD \$25,000 for convening of the Seventh Focal Points Meeting;
USD \$25,000 for convening of the Eighth Focal Points Meeting.

(two Focal Points and one expert from each of NOWPAP Member country and one representative of other RACs will be funded by meeting budget)

5. <u>Activity H:</u> Cooperation, Communication of DINRAC activities

DINRAC will continuously carry out the activities relating to the coordination with NOWPAP RCU and RACs, UNEP and other Regional Seas.

The director or the representative of DINRAC will participate in the Intergovernmental Meetings to report DINRAC activities to the meetings.

DINRAC will also maintain contacts with other programmes for cooperation.

Budget: Travel on official business: USD \$3,000 for each year.

Publication, communication and others: USD \$5,000 for each year.

6. <u>Activity L:</u> Establishment of Regional Internet Communication Systems between DINRAC and NOWPAP Member Countries (continue)

Establishment of Regional Internet Communication Systems between DINRAC and NOWPAP Member Countries has been achieved in the biennium of 2006/2007 with website linkages with relevant agencies/institutions in the NOWPAP Members and beyond. A mechanism of 'Clearing-House' to provide links to resources is available in system. The further steps are necessary to be taken in the biennium 2008/2009 by NOWPAP Member countries.

Expected outcomes from this activity are as:

- National/institutional thematic English-language websites/WebPages will be more gathered and effective and;
- The Regional Internet Communication Systems between DINRAC and NOWPAP Member Countries will provide more access to the national/regional websites/WebPages;

USD \$18,000 has been allocated in 2007 (UNEP/NOWPAP/DINRAC/FPM 6/17).

Total USD \$24,000 is suggested to implement this Activity in 2008/2009 biennium, in which USD \$3,000 for Focal Points in each NOWPAP Member annually for further design, reorganization, maintenance and enrichment of national/institutional websites respectively.

7. Activity N: Establishment of a Meta-database on Contaminants and Nutrients in the

Coastal and Marine Environment

Japanese Focal Point was invited to act as the leading country in the implementation of Activity N by the 5th DINRAC FPM. A new proposal for this activity has been presented at the 6th DINRAC FPM (UNEP/NOWPAP/DINRAC/FPM 6/16). USD \$8,000 has been allocated in 2007 (UNEP/NOWPAP/DINRAC/FPM 6/17).

Total USD \$15,000 would be allocated to implement this Activity in 2008, in which

- a. 3,000 USD for Focal Points in each NOWPAP Member for collection and compilation of the data and formulation of its National Report.
- a,000 USD for the conversion of the data from returned Questioners to the meta-database, essential compilation, harmonization and print the National Reports and development and print of the CD-ROM.
- 8. <u>Activity O:</u> Investigation on alien species and its potential damage evaluation in NOWPAP region

Being aware of the recommendation from the First Intersessional Workshop of NOWPAP and the resolution of the 10th IGM, biodiversity data could be also considered into DINRAC database with further focus on biodiversity management. It is the contributions towards implementation of global biodiversity conventions (CBD, CITES, CMS, Ramsar, etc.).

Invasive alien species is one of important global environmental issues.

There are many factors impacting invasive alien species problem. It is also an increasing environmental hot point in the region. Therefore investigation on alien species and its potential damage evaluation in NOWPAP region is quite useful in the region.

Estimated budget for the activity is US\$ 30,000 and estimated time for implementation is in 2009.
