Introduction

- 1. At the invitation of the Government of Italy and in consultation with the President and members of the Bureau, the 88th Meeting of the Bureau of the Contracting Parties to the Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean (Barcelona Convention) and its Protocols will be held in Rome, Italy, on 21-22 May 2019.
- 2. Documentation will be provided in English and French. As per practice, pre-session documentation will not be distributed on paper. Participants are encouraged to download the documentation on their computers in advance of the session.

- 16. The Bureau is expected to discuss the progress made and provide its guidance.

- 17. The Coordinator will update the Bureau on the preparations of the 2020-2021 UNEP/MAP Programme of Work and Budget and will present its main elements for the consideration of the Bureau.
- 18. The Bureau will be invited to discuss the proposed main elements of the 2020-2021 UNEP/MAP Programme of Work and Budget, make recommendations in accordance with its Terms of Reference and provide guidance on the way forward in view of COP 21.
- (d) Roadmap for the Evaluation of the 2016-2021 Medium-Term Strategy and the Preparation of the 2022-2027 Medium-Term Strategy
- 19. The Coordinator will present the Roadmap for the Evaluation of the 2016-2021 Medium-Term Strategy and the Preparation of the 2022-2027 Medium-Term Strategy.
- 20. The Bureau members will be invited to discuss the proposed roadmap and provide guidance on the way forward.

- 22. The Bureau member from Italy, host country of COP 21, will be invited to provide information on the organization of the event and the preparations by the host country.
- 23. The Bureau members will be invited to discuss the list of COP 21 draft Decisions and the theme and structure of the Ministerial Session, and to provide guidance on the way forward for the preparation of COP 21.

(f) Preparations for Upcoming MAP Meetings: Meeting of Thematic Focal Points for Specially Protected Areas/Biodiversity, 18th MCSD Meeting

- 24. The Coordinator will update the Bureau on the preparations for upcoming MAP meetings, and especially the Meeting of Thematic Focal Points for Specially Protected Areas/Biodiversity and the 18th Meeting of the Mediterranean Commission on Sustainable Development (MCSD).
- 25. The Bureau members are expected to discuss and provide further guidance on the main themes, focus and expected outcomes of these meetings.

(g) Development of Host Country Agreements for RACs

- 26. The Coordinator will present the draft minimum common provisions to be included in the Host Country Agreements for Regional Activity Centres (RACs) to ensure their effective operation, in accordance with Decision IG.23/3 on *Governance*, and will update the Bureau on the consultations with the Host Countries of RACs.
- 27. The Bureau will be invited to discuss the draft minimum common provisions and provide guidance on the way forward.

(h) Cooperation and Partners: MoUs/Agreements, MAP Partners, Joint Cooperation Strategy

- 28. The Secretariat will update the Bureau on the efforts to contribute to regional governance and cooperation and to create and strengthen partnerships, in order to enhance the impact of the MAP-Barcelona Convention system. Reference will be made, *inter alia*, to the progress in the preparation of an MoU with UNESCO/Man and Biosphere, and to the progress in the consultations for the preparation of the Joint Cooperation Strategy.
- 29. With reference to Decision IG.19/6 on *MAP/Civil society cooperation and partnership*, the Coordinator will update the Bureau members (a) on the evaluation of the applications received by civil society organizations for accreditation as MAP Partners, and (b) on the applications received for renewal of accreditation by existing MAP Partners, for the Bureau's review and endorsement.

(i) Outreach, Information and Communication

- 30. The Coordinator will present a brief update on the information and communication activities and on the plans for the last part of the biennium in this area.
- 31. The Bureau will be invited to provide its views and considerations on this matter and to advise on how to further enhance the outreach, visibility and impact of the MAP Barcelona Convention system.
