MCSD Membership from 2020 (Proposal)

- 1. The importance of the MCSD, as the advisory body to assist the Contracting Parties to the Barcelona Convention to integrate environmental issues in their socioeconomic programmes and to promote sustainable development policies in the Mediterranean region, was once again recognized by the Contracting Parties at their 19th Ordinary Meeting (COP 19) (Athens, Greece, February 2016), when the Reform of the MCSD and Updated MCSD Constitutive Documents were adopted (Decision IG.22/17).
- 2. As a forum for debate and exchange of experiences between all interested parties in the Mediterranean region, it is crucial to involve the greatest possible variety of actors in the Commission, so as to enrich its work to the maximum extent.
- 3. At their 20th Ordinary Meeting (COP 20) (Tirana, Albania, December 2017), the Contracting Parties confirmed through Decision IG.23/3 "Governance" the composition of the MCSD for the biennium 2018-2019, as set out in Decision IG.22/17. The Contracting Parties also called upon the MCSD Members, MAP Partners and the Secretariat to mobilize expressions of interest in membership of the MCSD for the next biennium.
- 4. As per paragraph 9. II. of the Composition of the MCSD (Annex I of Decision IG.22/17), nine MCSD Members have to be considered for replacement because they will have completed three consecutive mandates by COP 21 to be held in Naples, Italy, 2-5 December 2019. The nine MCSD Members listed in the table below have therefore to be considered for replacement from 2020.

5. In September 2018, the Secretariat invited the MCSD Members, MAP Partners and Components to provide suggestions and support in engaging partners and stakeholders that could join the MCSD as new members for the next two biennia, with the possibility of extension for one biennium. The Secretariat also invited MAP Partners which are not currently a MCSD Member and are possibly interested to become one under the NGO Group¹, to send a written expression of interest, based on criteria and modalities provided for in Decision IG.19/6 on "MAP/Civil society cooperation and partnership".

¹ As per Decision IG.22/17, the MCSD Members representing NGOs should be selected from the list of MAP/NGO Partners.

- 6. At its 20th Meeting (Athens, Greece, 23-24 January 2019), the MCSD Steering Committee expressed appreciation on the applications received until November 2018 and agreed with the initial proposal for the MCSD membership from 2020, as included in document UNEP/MED WG.456/4.
- 7. Members of the MCSD Steering Committee reiterated the need to identify ways and means to maintain links with the very active MCSD Members that will leave the Commission in December 2019. Most of those members have an official status of MAP Partner and have recommended potential candidates from their own networks and areas of work. It was also suggested to offer to former MCSD Members the possibility to be invited as observers to the meetings of the MCSD, as well as to ensure that they remain involved indirectly as MAP Partners.
- 8. The table below is listing the written expressions of interest received by the Secretariat in 2018-2019:

It gathers local authorities of Albania, Bosnia and Herzegovina, Croatia, Greece, Italy, Montenegro, Slovenia, and it is open to those from Serbia. FAIC was founded in Ancona, Italy, in 1999, in parallel of the launch of the "Charter of Ancona", establishing a set of principles aiming at creating a place for intercultural dialogue and political mediation and fostering a peaceful Adriatic and Ionian community. FAIC represents a tool for economic, political, cultural and human cooperation, broadly in line with the European Union Strategy for the Adriatic Ionian Region (EUSAIR). FAIC has the following objectives: (i) evaluate cultural heritage and historical identity, and share geographic and economic peculiarities amongst people that live in Adriatic-Ionian sub-region; (ii) give a concrete contribution to the European integration, to protection of human rights, development of highest standards of security and lawfulness, as well as promotion of gender equality; (iii) support territorial cohesion between cities that belong to the Adriatic-Ionian sub-region; (iv) activate initiatives of cross border cooperation in protecting and evaluating the environment, as well as initiatives in various socio-economic and cultural sectors; (v) foster exchange between various components of civil society, with particular attention to youth and schools, sports and voluntary associations, and social entrepreneurship.

		dialogue on the country's general policy and in particular on economic and social policy guidelines, as well as to issue opinions on government bills or MPs' law proposals referred to it". At the national level, the opinions of the ESCG is mandatory on a set of topics related to growth and sustainable development, labor relations, social security, taxation, environment and the country's overall social and economic policies. ESCG participates in a network of similar organizations at the European and international level. ESCG contributed to the Voluntary National Review presented by Greece at the High-level Political Forum in 2018.

MedPAN gathers over 100 institutions and NGOs that either have direct responsibility for managing Marine Protected Areas (MPAs) or are involved in the development of MPAs in the Mediterranean. MedPAN's mission is to promote, through a partnership approach, the sustainability and operation of a network of MPAs in the Mediterranean which are ecologically representative, connected and effectively managed to help reduce marine biodiversity loss. MedPAN works in partnership with MAP Components, in particular SPA/RAC.

- 9. The Secretariat's proposal regarding the MCSD membership from 2020 is presented below:
 - <u>The Local Authorities Group:</u> the Mediterranean Commission of the United Cities and Local Governments (UCLG), the *Agence des Villes et Territoires méditerranéens durables* (AVITEM), and the Forum of Adriatic and Ionian cities (FAIC);
 - <u>The Socio-economic Stakeholders Group:</u> ANIMA Investment Network, the Economic and Social Council of Greece (ESCG), and another potential member to be proposed;
 - <u>The Non-Governmental Organizations Group:</u> the Egyptian Sustainable Development Forum (ESDF), the Network of Marine Protected Areas managers in the Mediterranean (MedPAN), and ECO UNION;
 - <u>The Scientific Community Group:</u> the *Forum Euroméditerranéen des Instituts de Sciences Economiques* (FEMISE), the Mediterranean Programme for International Environmental Law and Negotiation (MEPIELAN), and the Mediterranean Sustainable Development Solutions Network (Med-SDSN);

- 10. The 18th Meeting of the MCSD will be invited to review and discuss the proposal of the Secretariat for agreement by consensus towards submission to the Meeting of MAP Focal Points and COP 21 for decision by the Contracting Parties.
- 11. The Members of the MCSD will also be invited to provide guidance to the Secretariat to reach more written expressions of interest in the future.
