#### Introduction

- 1. In accordance with the UN Environment/Mediterranean Action Plan Programme of Work 2018-2019 adopted by the 20<sup>th</sup> Ordinary Meeting of the Contracting Parties to the Barcelona Convention and its Protocols (COP 20) (Tirana, Albania, 17-20 December 2017), and in the framework of the Cooperation Agreement between UN Environment and the Italian Ministry for Environment, Land and Sea Protection (IMELS), the Secretariat, with support from REMPEC, is organizing the Second Meeting of the Barcelona Convention Offshore Oil and Gas Group (OFOG) Sub-Group on Environmental Impact on 27-28 June 2019, at the UN Environment/MAP Barcelona Convention Secretariat premises in Athens, Greece.
- 2. The main objectives of the meeting are to:
  - (1) Review and approve at a technical level a number of documents relating to the development of Offshore Common Standards and Guidelines, the status of implementation of the Mediterranean Offshore Action Plan and possible amendments to the Offshore Protocol Annexes; and
  - (2) Support sharing of best practices and lessons learnt among the Contracting Parties to the Barcelona Convention, and other relevant international organizations, MAP partners and the private sector regarding offshore activities.
