2. Background

In May 2017, President Xi Jinping of China announced the establishment of BRIGC in the first Belt and Road Forum for International Cooperation (BRF). In April 2019, BRIGC was official launched in the Thematic Forum of the second BRF, and was listed in the deliverables of the second Forum.

3. Overview

BRIGC is an open, inclusive and voluntary international network which aims to incorporate green development into the Belt and Road Initiative, promote international consensus and collective actions on the development of Green Belt and Road and implement the 2030 Sustainable Development Goals. BRIGC will provide platforms for policy dialogue and communication, knowledge and information, green technology exchange and transfer. By May 2019, BRIGC has more than 130 partners.
