## Introduction

This note outlines a consolidated proposal for a consensual process for review by the Committee of Permanent Representatives of the United Nations Environment Assembly and its subsidiary bodies, developed by the Chair of the Committee and with the support and approval of its Bureau, in accordance with <u>UNEA Decision 4/2</u>, paragraphs 9 to 13. It will be considered on Wednesday 9 October (pm) during the 6<sup>th</sup> Annual Subcommittee, with a view to find broad agreement on the proposal by the Committee.

## **Co-facilitators**

Pursuant to paragraph 12 of Decision 4/2, the consultation will be conducted in an open, inclusive and transparent manner by the following two co-facilitators: Mr. Marcus Davies, Deputy Permanent Representative of Canada to the UN Environment Programme; and Mr. Mapopa C. Kaunda, Deputy Permanent Representative of Malawi to the UN Environment Programme

## Proposed roadmap for the consultations

Pursuant to paragraph 9 in UNEA Decision 4/2, the process for review is initiated at the 6<sup>th</sup> Annual Subcommittee, 7 – 11 October 2019, and is finalized at the 7<sup>th</sup> Annual Subcommittee, tentatively scheduled for end October 2020.

The consultation process consists of 2 phases; a <u>scoping phase</u> from October 2019 to April 2020; and one <u>consolidation phase</u> from May 2020 to October 2020. Pursuant to paragraph 13 in Decision 4/2, progress achieved under the consultations will be considered and endorsed at a Stock-taking meeting, not exceeding 2 days in duration, under the framework of the 7th Annual Subcommittee meeting (dates still TBC). Final consideration will be made at UNEA 5.

A total number of <u>around</u> 8 consultation meetings are tentatively planned, to take place in under the format of subcommittee meetings.

To allow for member States without representation in Nairobi, the meetings will allow for remote connection through established ICT solutions, and the co-facilitators will be invited to explore options for reaching out to such member States throughout the consultations.

The tentative meeting dates and agenda items for consideration at each meeting are outlined in Annex 1. The meeting dates may be subject to change, upon guidance provided by the co-facilitators in close consultation with member States.
