Dr. Sara Platto has been living in China for 13 years since 2007. Currently, she is working as the Secretary General of Biology and Science Ethics (BASE) at China Biodiversity Conservation and Green Development Foundation (CBCGDF). One of Dr. Platto main duties at CBCGDF is to develop endangered species conservation projects to assess the interaction between local/indigenous people and the animal species considered for the study. The outcomes of these projects are used to define major actions that aim to improve local economies to reduce/eliminate the impacts of humans' activities on the protected animal species. In addition, Dr. Sara Platto is helping CBCGDF to set up a marine animal's rescue centre in Liaoning province (China). Dr. Sara Platto is also Associate Professor for animal behavior and welfare at Jianghan University (Wuhan) where she developed a research project to assess Chinese farmers (Platto et al, 2020), and Chinese veterinary, and animal





sciences students attitude towards animal welfare. The results of her studies will be used to develop training programs for the farmers, and improve animal welfare education in the universities in China. In 2018, she was nominated UFAW-Link (University Federation Animal Welfare) at Jianghan University with the objective to develop an animal welfare program. As part of her scientific outreach to international scientific colleagues Dr Platto was invited to deliver a speech on "Current situation of animal welfare in Asia" at the 11th Boerhinger-Ingelheim Expert forum in Sydney in 2018. Dr Platto, in collaboration with CBCGDF, organized the first seminar in Wuhan on "Animal Welfare: the link between food safety and human health" at Jianghan University, for students and professionals. Her experience working in the field of animal welfare has given Dr. Platto the tools to understand the impact of livestock industry on the environment in China and help colleagues in Asia know that China recognizes the importance of the environment while it modernizes her agricultural industry. As a veterinarian by training, Dr. Platto has always been interested in the spread of animal borne diseases to humans, and has taken a lead in educating the general public about the severe problems caused by rabies resulting from dog bites. Beginning in Beijing in 2010, Dr Platto developed education programs for children to educate families how to mitigate contact with strange or unknown dogs, and to help them recognize dog body language to avoid accidental bites and thus increase awareness on rabies prevention. For past three years since 2017, Dr Platto has established major public outreach and campaigns for free Rabies Vaccination by involving local veterinary hospitals, pharmaceutical companies, and local communities. Recently, Dr. Platto developed a collaboration between the Global Alliance for Rabies Control (GARC) and CBCGDF for the specific purpose of translating into Chinese all surveillance, planning tools, and courses of this global rabies organization. This will allow us at CBCGDF to spread the information and to allow professionals (veterinarian and doctors /nurses from hospitals) from China to gain access to this critical information which is lacking in our communities now. A big part of Dr





Platto's work has been to deliver lectures and to train professionals at the Chinese CDCs (Centre Disease Control) on the use of Rabies Epidemiology Bulletin (GARC) and to develop innovative rabies surveillance system in China. Dr. Platto has expanded her interest in zoonosis (animal borne disease transmitted to humans) by taking a course organized by the University of Geneva, and Institute Pasteur on "Global health at the human-animal ecosystem interface". This course has helped her explain further to her colleagues and to stress the importance of the link between increased environment degradation and new emerging diseases such as the outbreak of COVID19, to name just the most recent. Dr. Platto has also worked in a variety of wildlife rescue centers in USA, and Europe where she experienced first hand the devastating effects of human activities on the environment. While completing her postdoctoral at the Chinese Academy of Sciences on animal communication, Dr. Platto has participated extensively in the efforts of the Academia to stop the decline of Yangtze finless porpoises population caused by the stress placed on these animals due to competition with humans for food and space while living in an damaged environment.

The breath and depth of her work experience in the area of animal behavior and conservation, combined with her medical knowledge of a veterinarian, has given Dr Platto a unique perspective on the complex dynamics between humans and the environment. In the recent Wuhan COVID19 outbreak, Dr. Platto decided to remain in Wuhan, the city where she lives, to support the work of China Biodiversity Conservation and Green Development Foundation (CBCGDF) and help deliver calm in a sea of worry. The decision to stay in Wuhan was made as a result of a personal risk assessment of the COVID19 epidemic and the knowledge and understanding that this would eventually result in a global pandemic, and thus far better to remain isolated at the initial stage of the epidemic. During this period beginning from 23rd January to the present, Dr. Platto has been at the forefront of providing balanced, fact based, and scientifically sound advice to the general public in





China. Her expertise and assistance was specifically recognized very early in the crisis by the Italian Embassy in Beijing (China). Dr Platto with the great assistance of the heroic volunteers of CBCGDF in Wuhan, were essential to the Italian Embassy during the rescue of an Italian teenager exchange student who was caught in the middle of the outbreak with no support systems, and left at Wuhan airport. Dr Platto coordinated with the volunteers of CBCGDF in Wuhan, to have the student rescued after being stranded and alone with no language skills and height of public panic and emergency and brought to the hospital and assisted during all the time of while he remained in the city after initially fearing infection by the virus¹. Throughout the crisis Dr. Platto she has been giving information on COVID19 to the public about the general guidelines to keep domestic animals safe during the outbreak, all the while expressing the need for calm and not panic while imparting the science behind outbreak on a variety of social forums and press through the CBCGDF platform, Chinese and major USA and Italian news agencies². In her press interview Dr Platto placed has placed emphasis on scientific facts and not blaming the animals for this problem, and that more needs to be done to keep humans and animals in harmony in our ever challenged environment. Working from her house, Dr Platto has continued coordinating her work with her colleagues at CBCGDF, including the preparation of suggestions for the new Wildlife Protection Law to present to the Chinese government. I do hope that this brief summary of dr. Platto professional experiences and background will help you in your decision to appoint her as a Regional Facilitator for the UN.
