1. Opening of the meeting by the Chair of the Committee of Permanent Representatives.

H.E. Mr. Fernando Coimbra, Chair of the Committee of Permanent Representatives, Ambassador and Permanent Representative of Brazil, is expected to open the meeting at 14:00 (GMT+3) on 26 January 2021.

2. Adoption of the provisional agenda of the 153rd meeting of the Committee of Permanent Representatives.

The Committee will be invited to consider and adopt the provisional agenda for the 153rd meeting of the Committee of Permanent Representatives, as set out in UNEP/CPR/153/1 and UNEP/CPR/153/1/Add.1.

3. Adoption of the draft minutes of the 152nd meeting of the Committee of Permanent Representatives.

The Committee will be invited to consider and adopt the draft minutes of the 152nd meeting of the Committee of Permanent Representatives held on 19 November 2020.

4. Preparations for the virtual fifth session of Open-ended Committee of Permanent Representatives.

The meeting will consider a draft structure and agenda for the virtual fifth session of Open-ended Committee of Permanent Representatives, to be held on 15 - 19 February 2021, with an aim to adjourn on 16 February 2021.

5. Preparations for the commemoration of the 50th anniversary of the creation of UNEP.

The Secretariat will present a revised draft strategic plan for the commemoration of the creation of UNEP (UNEP@50), taking into account the views and comments expressed by Member States at previous meetings. The Committee will be invited to provide further guidance to the Secretariat with a view to facilitate a meaningful UNEP@50 commemoration, including the planned kick-off at the online session of UNEA-5.

The meeting will be invited to consider three draft decisions on administrative and budgetary matters, which are expected to be adopted at the online session of UNEA-5 scheduled for 22-23 February 2021; (i) draft decision on the on the Programme of Work and Budget for 2022–2023 and Medium-term Strategy for 2022- 2025; (ii) draft decision on the management of trust funds and earmarked contributions and (iii) draft decision on date and format for the resumed session of UNEA-5 and for the resumed session of OECPR-5.
