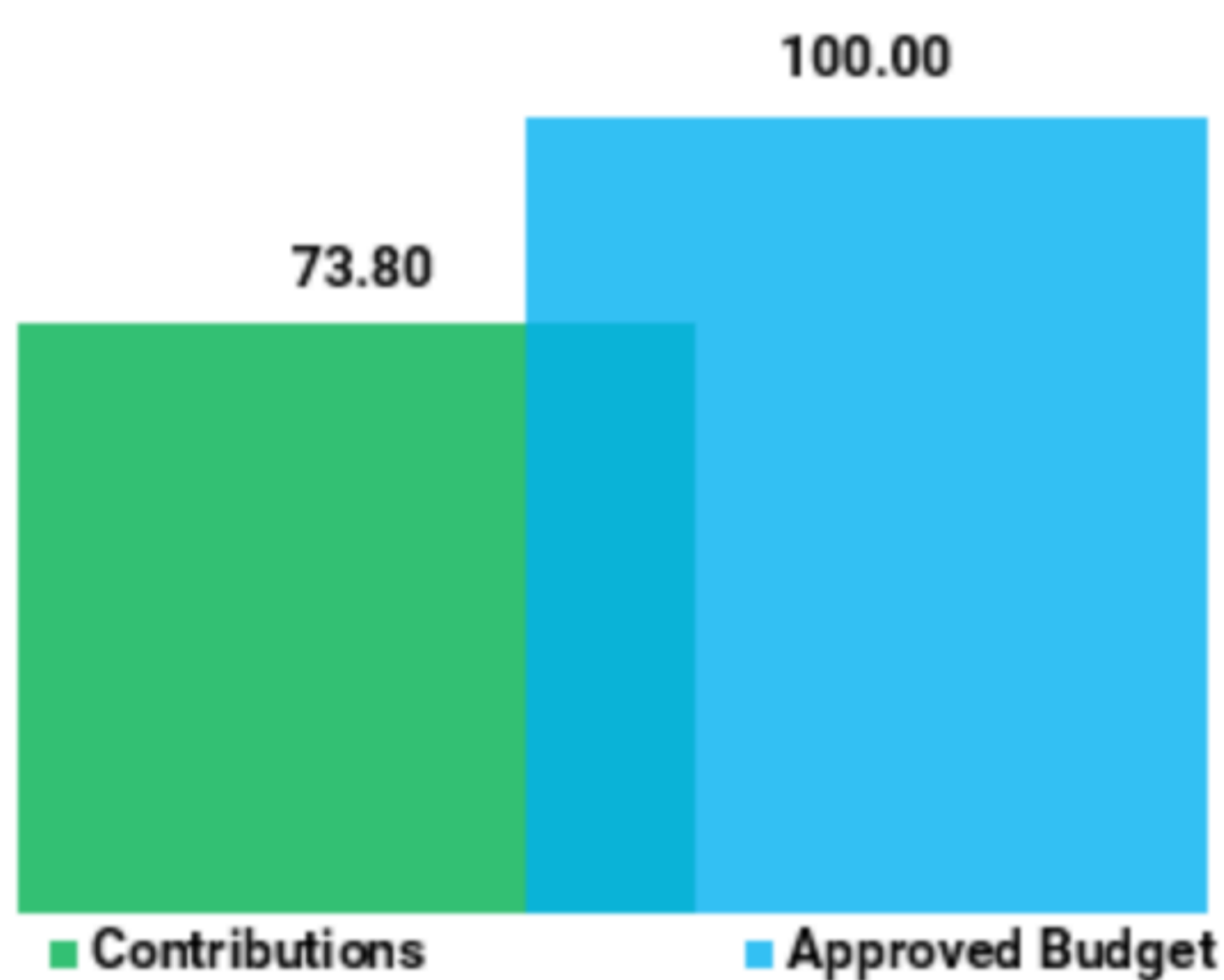

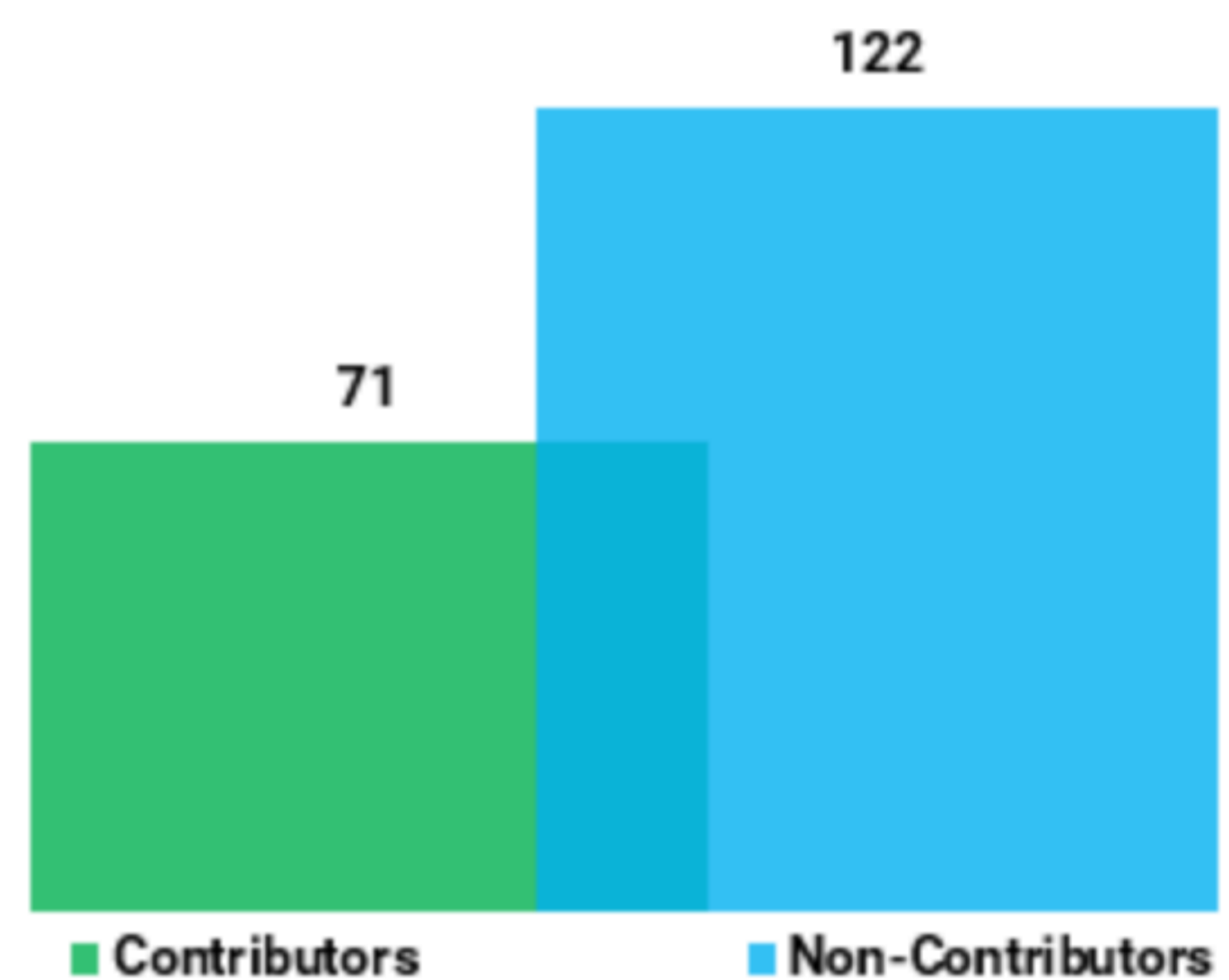

Contributions vs Approved Budget

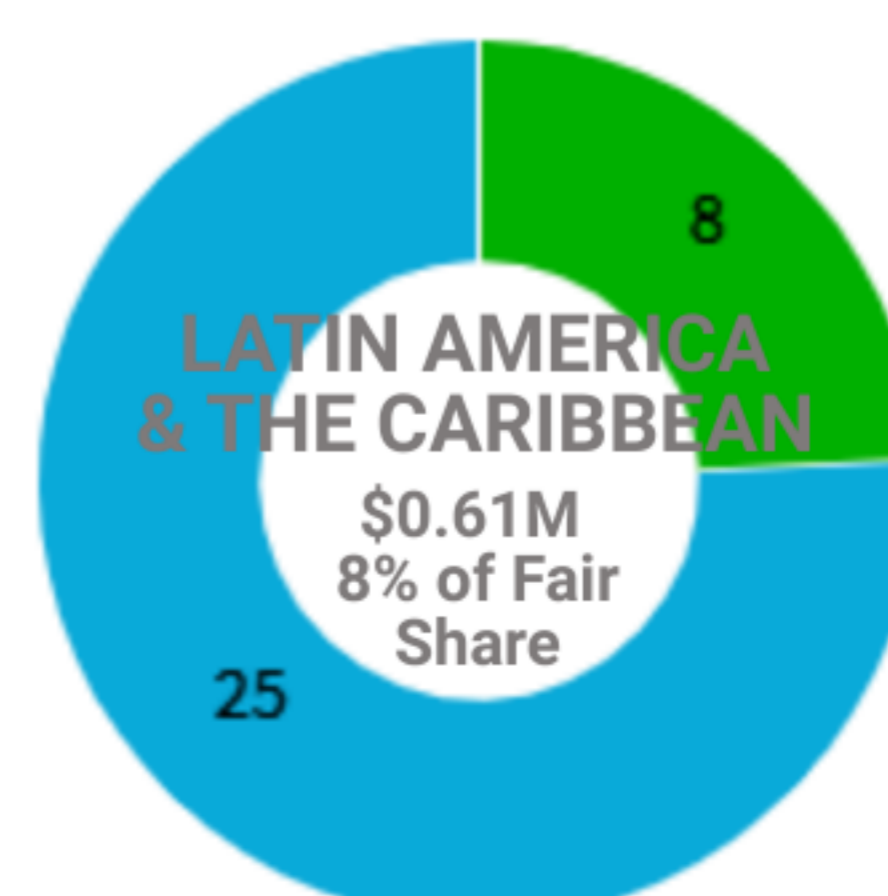
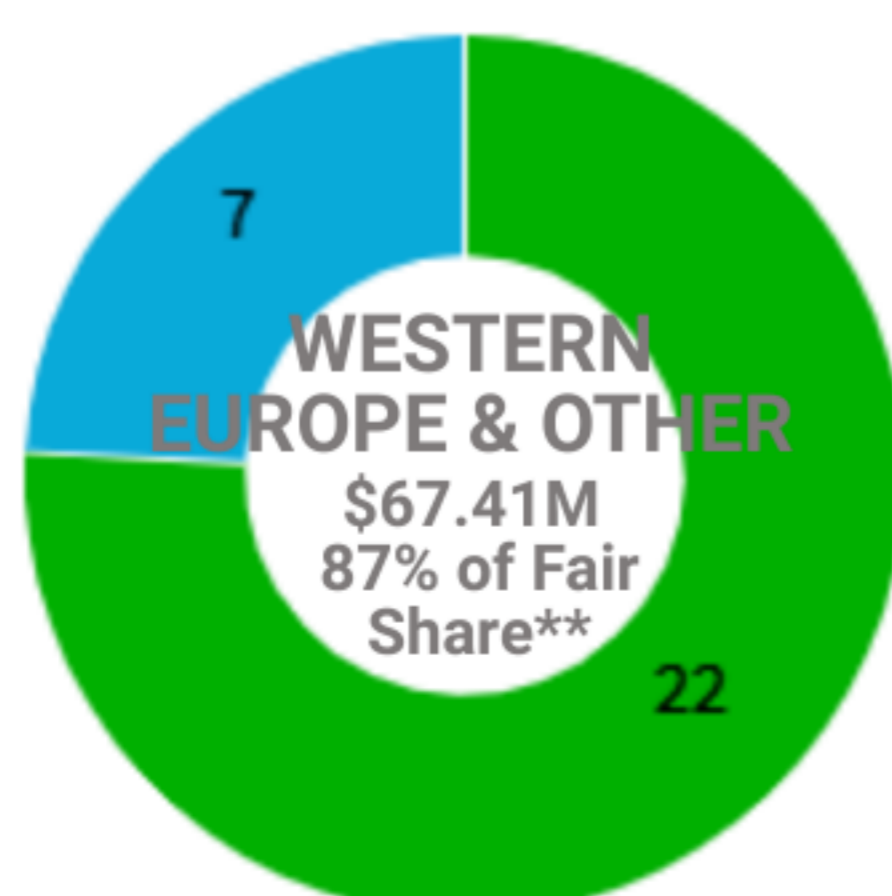
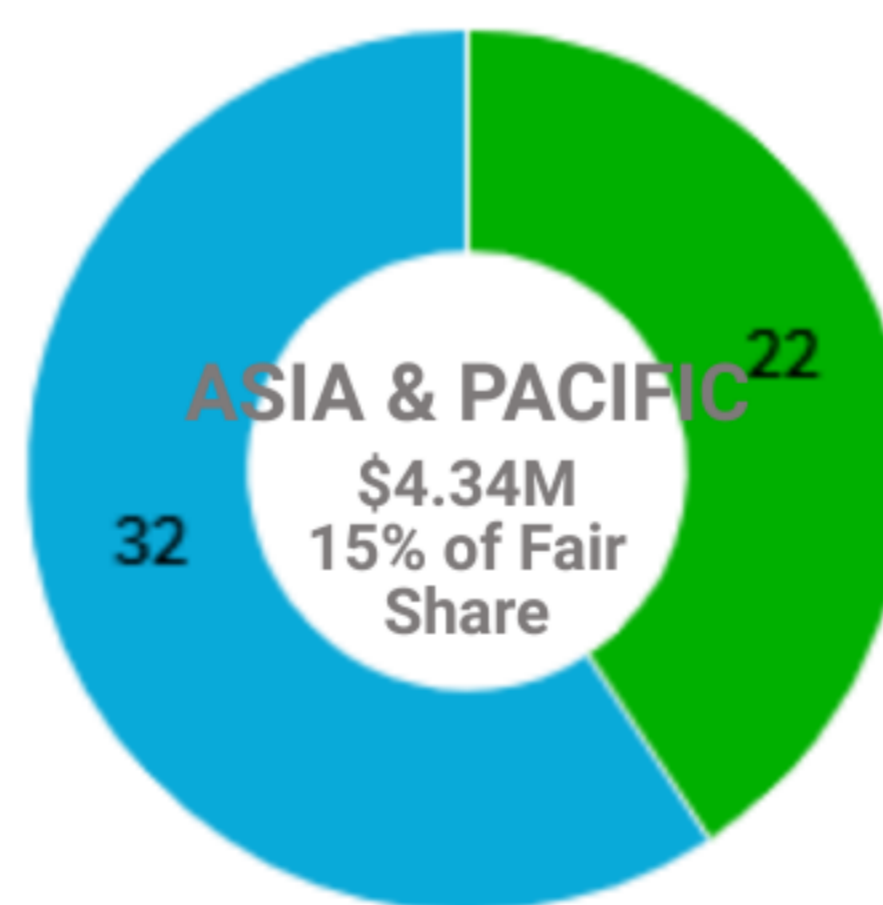
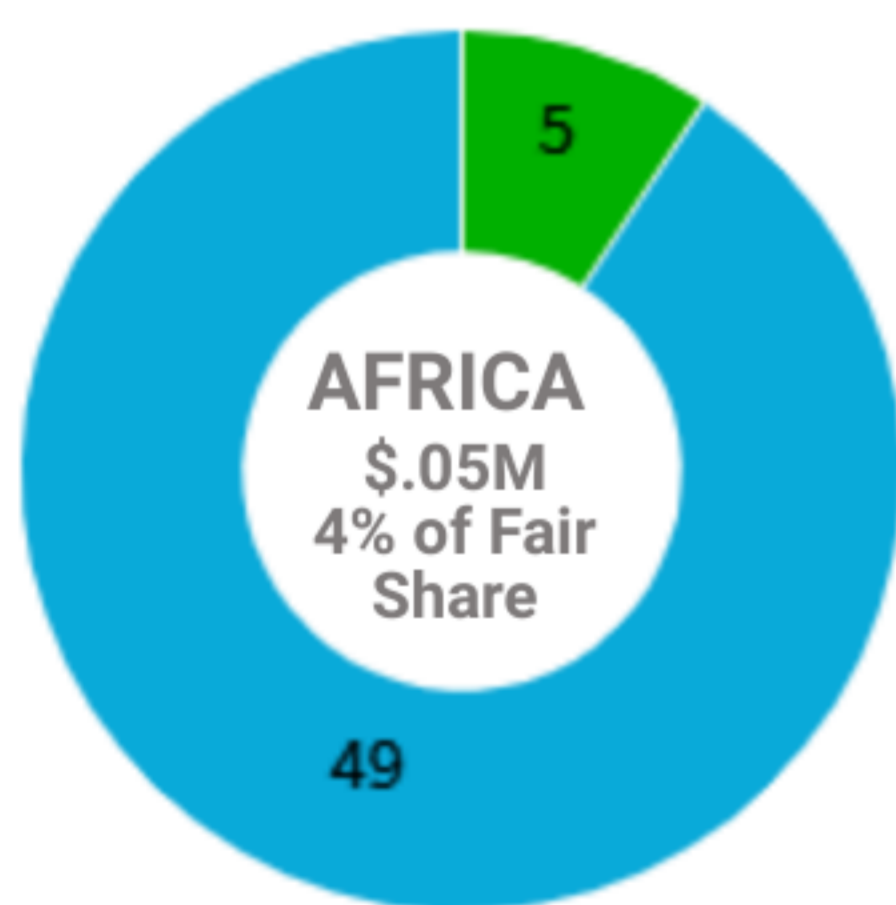


Contributors vs Other Member States
