

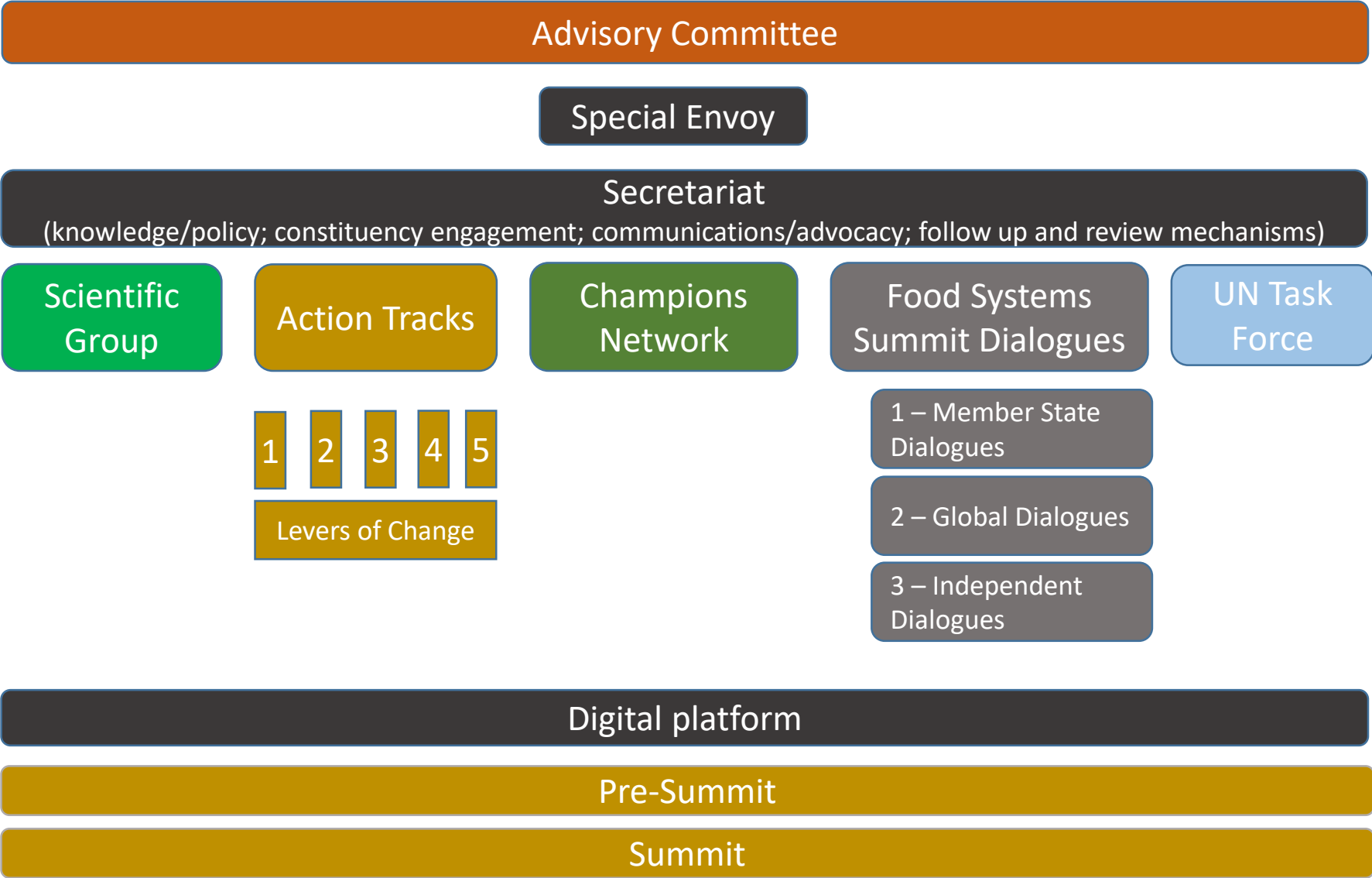

Overview of Progress: Levers of Change



For each lever of change, a “Custodian” works with a small group of experts to:

- *Help to identify game-changing ideas that are cross-cutting, but also potentially within individual tracks*
- *Ensure that the lever of change is adequately considered in the outcomes of each action track*
- *Advance a few high-priority commitments and actions by the time of the Summit by presenting mechanisms that articulate the way in which game changing solutions identified in and across the Action tracks can be made to happen*
- *Help in distilling key points/principles for use in a voluntary political outcome document.*

Overview of progress : Key objectives for the ATs in February-March



- 19th February: **initial short-list of game-changing solutions** by Action Track and across Action Tracks, developed *in collaboration with the Levers of Change, the Scientific Group, UN Taskforce, considering FSSD outcomes*
- 1st-25th February: Solutions presented and discussed with the global community by each AT during a **2nd round of public fora**, followed by **online consultations**
- February-March: coming together of **coalitions of actors** around game-changing solutions, clusters of actions
- **Short-list of solutions presented to the 4th Advisory Committee meeting in early March for discussion, and submitted for consultation to other MS fora.**

Overview of progress : Identifying “game changing solutions”

“A ‘**game changing solution**’ is a **feasible** action which can be sustained over time that would **shift** the capacity of food systems to advance global goals.”



Key criteria :

1. **Impact potential at scale** (incl. return on investment)
2. **Actionability** (politics, capacity, costs)
3. **Sustainability** (the ability to keep delivering to 2030 and beyond)

Qualifiers:

1. Have **positive effects on ensuring equitable livelihood opportunities, advancing human health, and regenerating environmental integrity**, with focus on **youth, women, marginalized and disabled populations**
2. Be a **true departure from existing practices** that **address a long-term constraint**, obstacle or trend
3. Be **ambitious and think big** with concrete pathways and actions for long term systemic change
4. Have **deliberate impact pathways** that account for/minimize/eliminate negative impacts, have co-benefits, or are mutually reinforcing on achieving the other Action Tracks' goals
5. Be **implementable at a sufficient scale** to reach a large portion of the population with **clear, timely and verifiable outcomes that produce significant impacts** by 2030
6. Be **sustainable**, in that it can persist in the medium- to long-term future
7. **Anticipate and prevent future lock-in's**
8. Promote **gender equality and women's empowerment** in food consumption and production systems

Overview of progress: Member States' engagement



Active engagement in AT teams through national technical experts:

- ✓ 42 MS and 2 regional bodies involved in the ATs
- ✓ Regular meetings between MS and AT leads
- Call for broader MS participation in ATs (esp from Africa, Asia, Latin America, Oceania)

Member States FSS dialogues:

- ✓ 30+ national convenors already nominated (as of Friday 15 Jan)
- ✓ MS dialogues underway: Russia and USA

Overview of Progress: Multi-actor Food Systems Champions



Role:

- To mobilize their networks;
- To contribute to substantive discussions, generate ideas and take action to help address the broken food systems;
- To share information to support the Summit in reaching the broadest and deepest set of food systems actors.

Champions are encouraged to work with youth and engage with other actors outside their specialist area in an effort to break silos.

- Some Champions have already organized independent dialogues
 - Farmer-consumer; Youth
- Others are in the preparatory phase
 - Dialogues with regional and gender lens

Expansion and Nomination process

- Currently with nearly 70 champions from all the regions of the world
- Network to grow and expand (100 to 200 max.)
- Champions network leadership to review nominations and provide recommendations to the Secretariat for decision by the Special Envoy
