Process to COP15

- Informal meetings of SBSTTA and SBI in February and March 2021, respectively;
- Stakeholder forum next one March 2021 on the topic of Sustainable Agriculture and Food Systems Transition: Linkages to the Post-2020 Global Biodiversity Framework;
- Bureau considering:
- SBSTTA-24 and SBI-3 in May 2021;
- WG2020-3 in August 2021, date tbd in consultation with Colombia;
- COP 15 in October 2021, date tbd in consultation with China.









Third meeting of the Subsidiary Body on Implementation (SBI3)

- Seven agenda items will support the post-2020 global biodiversity framework:
 - Agenda item 3: Review of progress in the implementation of the Convention and the Strategic Plan for Biodiversity 2011-2020.
 - Agenda item 5: Post-2020 Process
 - Agenda item 6 (a): Resource mobilization By COP decision 14/22, the SBI will review outputs of the expert panel on resource mobilization (see CBD/SBI/3/5).











- Agenda item 6 (b): Financial mechanism By COP decision <u>14/23</u>, the SBI will prepare proposals for a four-year outcome-oriented framework of programme priorities for the eighth replenishment period (July 2022–June 2026) of the Trust Fund of the Global Environment Facility for the Convention and its Protocols, aligned with the draft post-2020 global biodiversity framework.
- Agenda item 7 (a): Capacity-building, technical and scientific cooperation, and technology transfer By COP decision 14/24, the SBI will consider a draft long-term strategic framework for capacity-building beyond 2020, aligned with the draft post-2020 global biodiversity framework and the 2030 Agenda for Sustainable Development. The SBI will also undertake related work in accordance with and Nagoya Protocol decision NP-3/5.
