I. Background

The Forum of Ministers of Environment of Latin America and the Caribbean will convene its XXII Meeting on 1-2 February to decide on regional priorities of the environmental agenda and to coordinate actions and cooperation on these issues.

The last consultative meeting of Civil Society took place on 23 November 2020, coordinated by the elected Regional Facilitators Lorena Terrazas and Joseph Severe. The meeting brought together Major Groups and Stakeholders (MGS) accredited to UNEP as well as non-accredited regional Major Groups and Stakeholders partners, including participants from foundations or other relevant Stakeholders, as the main purpose was to motivate participation of all parts and bring them to a more active engagement. Based on the outcomes of the meeting, an inclusive process for the preparation of the regional statement for UNEA-5 was undertaken by virtual exchange during December 2020.

II. Objectives

The Regional Forum has these main objectives:

- To present the key messages and contributions from the Civil Society of the Latin America and the Caribbean region on key topics of the environmental agenda in the context of the Forum of Ministers of Environment of Latin America and the Caribbean.
- To share updated information on the preparation of the XXII Meeting of the Forum and the Assembly.
- To reinforce dialogue and coordination for increasing Civil Society and the Youth participation and engagement in the regional and global environmental agenda.
