Member States Survey | 2019 – 2020 Gender Equality and Women's Empowerment



INTRODUCTION

In March 2019, the United Nations Environment Assembly (UNEA) at its fourth session, adopted resolution 17 on *Promoting gender equality and the human rights and empowerment of women and girls in environmental governance* (UNEA/4 Res. 17).

To meet the requirements of the Resolution, the United Nations Environment Programme (UNEP) developed a survey for Member States and stakeholders to collect data disaggregated by, *inter alia*, sex, age, and disability and lessons learned on the progress made in achieving gender equality and empowerment of women and girls in global, national and local environmental policies, programmes and initiatives (Res. 17(2a)).

Accordingly, the survey covering the period from January 2019 to December 2020 has been ongoing since December 2020 and will remain open until 30 September 2021.

The target number of respondents for this survey is 193 countries out of which 21 countries have so far responded. This report provides the results from the 21 Member States' responses. A list of these 21 Member States can be found on page 16.

Member States that have not yet participated in the survey are encouraged to submit their responses by **15 October 2021**. Your participation is highly appreciated and enables UNEP to adequately respond to the requirements of Resolution 4/17.





Policy or guideline for gender-balanced participation in international meetings



Gender-sensitive policies, rules and regulations



38% budget for gender mainstreaming activities within the ministry and/or its projects. This suggests that gender mainstreaming goals are only partially achieved.




ENVIRONMENTAL DECISION-MAKING Age, Sex and Disability Disaggregated Data of Senior Management




Collection of data disaggregated by either sex, age or disability

Sex-disaggregated data of Senior Management Staff






Age- disaggregated data of Senior Management Staff

Only 3 of the 21 Member States reported collecting disabilitydisaggregated data of senior management staff.

One of the three that collect disabilitydisaggregated data of senior management staff does not further disaggregate the data by sex.



Delegates** to international meetings*** disaggregated by age




**Delegates are persons who represent their countries in international meetings
