H.E. Mr. Fernando Coimbra, Chair of the Committee of Permanent Representative, Ambassador and Permanent Representative of Brazil, will open and chair the meeting.

The Secretariat will present the main findings from two UNEP flagship reports; the Emissions Gap Report 2020, which was released by UNEP on 9 December 2020; and the Adaptation Gap Report 2020, released on 14 January 2021. The presentation will be followed by an exchange of views with member states.
- 3. Inputs to the 2021 High Level Political Forum**  
In accordance with the mandate provided in paragraph 3 of the UNEA resolution 3/3, the Committee will be invited to consider draft inputs of the UN Environment Assembly to the 2021 High- Level Political Forum on Sustainable Development, which will meet under the auspices of ECOSOC from 6 to 15 July 2021 under the theme “Sustainable and resilient recovery from the COVID-19 pandemic that promotes the economic, social and environmental dimensions of sustainable development: building an inclusive and effective path for the achievement of the 2030 Agenda in the context of the decade of action and delivery for sustainable development”. The draft is prepared by the UNEP Secretariat on the basis of inputs submitted in writing from Member States by 12 February 2021.  
  
This matter was considered at the online fifth meeting of the Open-Ended Meeting of the Committee of Permanent Representatives, whereby the Committee decided to defer consideration and finalization of UNEA contributions to the forthcoming meeting of the HLPF to future meetings of the CPR subcommittee, which are planned for 4, 11 and 15 March 2021. The Committee will be invited to comment on the draft with a view to finalize the contribution for submission from the UNEA President to the HLPF Secretariat by 15 March 2021 at the latest, as requested by the President of ECOSOC his [letter dated 18 November 2020](#).
