
Annotated provisional agenda

Annotation

Document E/ESCAP/MCED(7)/1 provides an analysis of the implementation of the recommendations and outcomes of the sixth Ministerial Conference on Environment and Development in Asia and the Pacific,

including those contained in the Regional Implementation Plan for Sustainable Development in Asia and the Pacific, 2011-2015, the Astana Green Bridge Initiative and the Seoul Initiative on Green Growth. The senior officials may wish to review the progress made in the implementation of these regional commitments and initiatives and provide guidance on a future course of action. The senior officials may wish to provide guidance on a future course of action, including the possible inclusion of priority issues in the draft ministerial declaration on environment and development for Asia and the Pacific under agenda item 4.

The ministers and heads of delegations are invited to deliver their formal country policy statements, outlining their perspectives on national, subregional and regional challenges, their achievements and their strategic and policy approaches.

The President of the United Nations Environment Assembly has initiated a process of consultation on a draft political declaration, addressing the theme of the third session of the United Nations Environment Assembly (2017), "Towards a pollution-free planet". Under this agenda item, the ministers and heads of delegations will have the opportunity to share their perspectives on the draft declaration. In the words of the President of the United Nations Environment Assembly, "as the world's ministers of environment, we must be determined [...] to take the bold and necessary steps to address pollution at every level – global, regional, national and local – in order to protect the health and lives of all people on this planet, the developmental aspirations of current and future generations, and the immeasurable wealth of the environment and the natural resources upon which we all depend".

(c) Policy perspectives on a pollution-free planet

Annotation

An interactive dialogue will be organized in order to initiate ministerial discussions on policy measures to address critical challenges related to the achievement of a pollution-free planet. The ministers and heads of delegations will have the opportunity to engage in an interactive dialogue with the panel to share their perspectives on how to achieve a pollution-free planet by 2030. Discussions will highlight contributions and commitments to achieving the vision reflected in the theme "Towards a pollution-free planet".

The ministers and heads of delegations will consider for adoption the draft ministerial declaration. The ministerial declaration will reaffirm the commitment of ESCAP members and associate members to promoting the sustainable management of the environment and natural resources as a core element of sustainable development. The ministers and heads of delegations may also consider any supportive initiatives designed to facilitate action on the policy measures to be taken in order to pursue the vision articulated in the declaration. The ministers and heads of delegations will subsequently consider for adoption the draft report of the Conference.
