#### Introduction

- 1. In accordance with the Rules of Procedure of the Mediterranean Commission on Sustainable Development (MCSD) and in consultation with the Members of the MCSD Steering Committee, the 19<sup>th</sup> Meeting of the MCSD is being convened on 7–9 June 2021.
- 2. Slovenia generously offered to host the meeting in the municipality of Izola. Due to travel restrictions imposed by the COVID-19 pandemic, the meeting will be held through videoconference, virtually hosted by Slovenia. Modalities for connection through electronic means will be communicated to the participants in due time.
- 3. Simultaneous interpretation in English and French will be available for the plenary sessions. Working documents will be in English and French. Participants are encouraged to download the documentation on their computers in advance of the session.

- 18. The Secretariat (Plan Bleu) will introduce key findings and messages from the SoED report, which is the most comprehensive Mediterranean assessment of its kind in a decade and which was released in October 2020 as a UNEP publication: see references in Document UNEP/MED WG.493/Inf.1. The presentation will focus on environmental issues which put the Mediterranean basin under pressure and on the identification of drivers of environmental degradation from key economic sectors. Plan Bleu will also introduce levers of action that decision-makers can 'activate' to achieve a green transition and a resilient, inclusive recovery for reversing current trajectories.
- 19. A general discussion will follow for possible recommendations to support the Contracting Parties in taking concrete steps in incorporating the SoED concerns, main finding and key messages in their environmental policies, in line with Decision IG.24/04 adopted at COP 21.
- 20. Complementing the presentation of SoED, the Secretariat (Plan Bleu) will also present the work done in 2020-2021 in the framework of the MED 2050 Foresight Study, as well as the next steps and perspectives towards the inclusion of the MCSD in this participatory exercise.

21. As invited speakers, the Coordinators of the independent network of Mediterranean Experts on Climate and environmental Change (MedECC), will present the main findings and key messages of the First Mediterranean Assessment Report (MAR1) "Climate and Environmental Change in the

Mediterranean Basin – Current Situation and Risks for the Future". They will also introduce the most recent developments and perspectives of the MedECC work.

- 22. A discussion will follow to collect general feedback and detailed comments from the MCSD towards recommendations in view of the submission, for consideration and possible endorsement, of the MAR1 Summary for Policy-Makers (SPM) by the UNEP/MAP Focal Points and by COP 22.
- 23. The MCSD is also expected to formulate conclusions on MedECC's perspectives, including in view of a long-term support to this successful regional initiative, as a recognized science-policy interface within the UNEP/MAP Barcelona Convention system and for further collaboration with the MCSD on climate and environmental matters.

- 24. The SoED and MedECC MAR1 'twin reports' warn on the hefty toll that the global triple crisis of climate change, biodiversity loss and pollution is taking on the Mediterranean region, which is not on track to achieve the SDGs, confirming the urgency of a green renaissance in the post-COVID era: unless urgent and resolute action is taken to halt current trends, environmental degradation could have serious consequences for human health and livelihoods.
- 25. Those publications during a global pandemic of zoonotic origin provide a "wake-up call" in favor of the one-health approach to bolster the region's resilience, a renewed call for "Investing in environmental sustainability to achieve social and economic development" (MSSD subtitle).
- 26. To foster discussions on a sustainable, resilient and inclusive future through a sustainable blue economy for a post-COVID green renaissance in the Mediterranean, a roundtable is envisaged gathering the following speakers: Ambassador Sergio Piazzi, Secretary General of the Parliamentary Assembly of the Mediterranean (PAM) about parliamentary diplomacy in support of regional multilateralism and solidarity for the environment and sustainable development; Julien Rochette, Ocean Programme Director, IDDRI, about regional marine governance in times of crisis; a representative of the European Commission to introduce the practical aspects and implementation of the new Agenda for the Mediterranean in the context of the EU Green Deal; Najib Saab, Secretary General of AFED, about Green Recovery plans in the Arab world; Simone Cresti, Manager of SDSN Med, about transformation hubs to achieve the SDGs and Mediterranean youth solutions for the SDGs; a representative of SCP/RAC about regional measures to support green and circular businesses in the Mediterranean; a representative of Italy on national initiatives on Sustainable Blue Economy in the context of global and regional commitments; and, a representative of the Municipality of Izola, Slovenia, about the promotion of green entrepreneurship and local cooperation in the context of the EU Strategy for the Adriatic-Ionian Region (EUSAIR).
- 27. The outcome of this panel discussions and respective reactions from the MCSD Members may represent the first elements that the MCSD may consider in view of feeding the relevant discussions at the 22<sup>nd</sup> Meeting of the Contracting Parties to the Barcelona Convention (COP 22) (Antalya, Turkey, December 2021) and in the preparation of its Declaration.

- 29. The MCSD is expected to produce opinions on the overall draft UNEP/MAP Programme of Work (PoW) for 2022-2023, which is the first biennial PoW of the forthcoming UNEP/MAP Medium-Term Strategy (MTS) 2022-2027.
- 30. This agenda item will also launch the consultation on the preparation of the draft Ministerial Declaration of COP 22: the MCSD is expected to facilitate the identification of issues of relevance to the Ministerial Session and Declaration of COP 22.
