Introduction

1. The 21st Meeting of the Contracting Parties to the Barcelona Convention, COP21, (Napoli, Italy, 2-5 December 2019), mandated the MED POL Programme to develop new National Baseline Budget (NBB) Technical Guidelines to address estimation techniques of pollutants' releases from agriculture, catchment runoff and aquaculture. In the same COP21, in line with Decision IG.24/10, the MEDPOL Programme was requested to prepare three assessment focusing on (i) state of play of agricultural practices and discharged pollutants reaching the Mediterranean marine environment; (ii) state of play of aquaculture practices in the Mediterranean and their impact on marine environment; and (iii) assessment of state of urban stormwater management in the Mediterranean.

2. Moreover, in accordance with Decision IG.22/8, COP19 (Athens, Greece, 9-12 February 2016), the MED POL Programme was requested to undertake an indicator-based midterm evaluation of the National Action Plans/Programme of Measures (NAP/PoM) after 5 years of their implementation.

3. In concordance with the Programme of Work and budget endorsed by COP21, the objectives of this meeting are to: (a) review and approve the proposed estimation techniques for loads from agriculture, catchment runoff, and aquaculture aiming to complement the NBB/PRTR Methodology for 5th Cycle of NBB; (b) review and approve the three assessment products prepared in support of the development of the new Regional Plans on Agriculture, Aquaculture and Urban Stormwater; and (c) review and approve the Midterm Evaluation of the National Action Plans implementation based on the NAP Indicators and data collected.

4. The following annotations to the Provisional Agenda were prepared by the Secretariat to assist the Meeting in its deliberations.

7. Subject to Rule 20 of the Rules of Procedure mentioned at para. 2(a), the Meeting will elect a President, two Vice Presidents and a Rapporteur from among the representatives of the Contracting Parties.

d) Organization of Work

9. The discussions are planned to be held over two days with three two-hour plenary sessions opening daily at 10:00 AM and closing at 17:30 (Athens time) as per the Meeting Timetable included at the end of the annotated agenda.

10. Simultaneous interpretation in English and French will be available for all sessions. All documentation will be in English and French. Participants are encouraged to download the documentation on their computers in advance of the session. The meeting will be recorded for future reference.

Under agenda item (3), the meeting will address estimation techniques and applied methodologies for: (i) non-point source releases from agriculture; (ii) point source releases from aquaculture; and (iii) non-point source releases from catchment runoffs. The Secretariat will present the documents UNEP/MED WG.505/3; UNEP/MED WG.505/4 and UNEP/MED WG.505/5 accordingly. The Meeting is expected to review the draft documents taking into consideration the NBB/PRTR methodologies, and comment on the possible additional elements to be included in these guidelines with the aim of submission to the MED POL Focal Points Meeting in May 2021 for their final consideration and approval.

Under agenda item 4(a), the Secretariat will present the UNEP/MED WG.505/6 "Draft assessment of state of play of agricultural practices and discharged pollutants reaching the Mediterranean marine environment," which examines the current state of play pertinent to discharged pollutants' loads, as well as applicable measures and practices for agricultural sector at regional level.

14. Under agenda item 4(b), the Secretariat will present the UNEP/MED WG.505/7 "Draft assessment of the state of play of aquaculture practices in the Mediterranean and their impact on marine environment," which examines the current state of play pertinent to discharged pollutants' loads, as well as applicable measures and practices pertinent to aquaculture sector in the Mediterranean.

15. Under agenda item 4(c), the Secretariat will present the UNEP/MED WG.505/8 "Draft assessment of state of stormwater management in the Mediterranean," assessing the practices pertinent to management of urban stormwater in the Mediterranean.

16. The Meeting is expected to review the aforementioned assessment documents taking into consideration the relevant COP21 decision aiming to facilitate the finalization of the three related Regional Plans, and to comment on the possible additional elements to be included in these assessments with the aim of submission to the MED POL Focal Points Meeting in May 2021 for their final consideration and approval.
