The UNEP Global Mercury Partnership and its Area of work on Artisanal and Small-scale Gold Mining (ASGM) will organize a webinar to discuss gender mainstreaming into National Action Plans (NAPs).

The event will present an overview of gender aspects related to ASGM, address challenges of integrating gender dimensions into the ASGM sector, share information and discuss some recommendations and best practices for considering gender when developing and implementing National Action Plans on ASGM to meet the requirements of the Minamata Convention on Mercury (Article 7, Annex C).

Initiated in 2005, the UNEP Global Mercury Partnership aims to protect human health and the environment from the releases of mercury and its compounds to air, water and land. With over 200 partners to date from governments, intergovernmental and non-governmental organizations, industry and academia, the Partnership focuses on supporting timely and effective implementation of the Minamata Convention, providing state of the art knowledge and science and raising awareness towards global action on mercury.

Pursuant to Article 7 of the Minamata Convention, each Party that determines it has in its territory more than insignificant artisanal and small-scale gold mining and processing in which mercury amalgamation is used to extract gold from ore should, amongst others, develop and implement a National Action Plan on ASGM.
