Introduction

- 1. The main objectives of the Meeting of the Mediterranean Action Plan (MAP) Focal Points, that will take place online on 10, 13, 14, 15 and 17 September 2021, are: to review the progress achieved during the 2020-2021 biennium in the implementation of the Programme of Work and of the activities approved by the 21st Meeting of the Contracting Parties (COP 21, Naples, Italy, 2-5 December 2019); and to approve a number of Draft Decisions, including on the UNEP/MAP Medium-Term Strategy 2022-2027 and the proposed biannual Programme of Work (PoW) and Budget 2022-2023, prepared by the Secretariat for submission to the 22nd Meeting of the Contracting Parties (COP 22, Antalya, Turkey, 7-10 December 2021), aiming at strengthening the implementation of the Barcelona Convention and its Protocols.
- 2. The following proposed Provisional Annotated Agenda has been prepared by the Secretariat to assist the Meeting in its deliberations.

Agenda Item 1: Opening of the Meeting

3. The Meeting will be opened at 10.00 (Athens Time, UTC+3) on 10 September 2021 by the President of the Bureau, Mr. Carlo Zaghi and the Coordinator of the United Nations Environment Programme/Mediterranean Action Plan (UNEP/MAP)—Barcelona Convention, Ms. Tatjana Hema.

2.2 Election of Officers

- 5. Subject to Rule 20 of the Rules of Procedure mentioned at para. 2(a), the Meeting of the MAP Focal Points will elect a President, four Vice Presidents and a Rapporteur from among the representatives of the Contracting Parties.

- 6. Subject to Rule 14 of the Rules of Procedure mentioned at para. 2(a), the proposed agenda appearing in document UNEP/MED WG.515/1 and annotated in the present document will be proposed for adoption by the Meeting. The Meeting will review and adopt the agenda and the proposed timetable contained in the Annex to the present document, including as appropriate any other issues suggested to be addressed under the item "Any Other Business" of the provisional agenda.

2.4 Organization of Work

- 7. Simultaneous interpretation in English and French will be available for the plenary sessions. Documentation will be in English and French.
- 10. Three 2-hour sessions are scheduled every day to allow remote simultaneous interpretation via the online platform. The 16th of September and the morning of the 17th September will be allocated for the preparation of the Report of the Meeting in English and French; therefore, two 2-hour sessions are envisaged to take place on the 17th September.

8. It is expected that the MAP Focal Points will address all items of the Agenda during their five-day Meeting. It is envisaged to close the Meeting at 17:00 on 17 September 2021 after adopting its Draft Report.

- 9. The Coordinator will present the document "Progress Report on Activities Carried Out during the 2020-2021 Biennium" (UNEP/MED WG.515/3) outlining the work done as well as the main achievements and challenges encountered in the implementation of the Barcelona Convention and its Protocols since COP 21. The Meeting will also consider the "Overall Findings from the General Status of the Progress in the Implementation of the Barcelona Convention and its Protocols: Analysis of the Information Mentioned in the National Reports for the 2018-2019 Biennium" (UNEP/MED WG.515/24). These documents are complemented by information documents providing more detailed information on the progress achieved.
- 10. The Meeting is expected to review the progress achieved on the implementation of the PoW and Budget adopted by COP 21 and discuss opportunities, challenges, and lessons learned.

Agenda Item 5: Specific Matters for Consideration and Action by the Meeting, including Draft Decisions

- 11. Under this agenda item the Meeting will consider a number of Draft Decisions addressing specific issues related to the implementation of the Barcelona Convention and its Protocols as well as strategic and programmatic documents. Sub-items have been organized following the structure of the UNEP/MAP Mid-Term Strategy 2016-2021 (MTS), encompassing the overarching, core and crosscutting themes of the MTS.
- 12. The Secretariat has prepared for each specific Draft Decision, working documents containing a Note by the Secretariat, the Draft Decision and, as applicable, Annexes to the Draft Decision. The brief introductory Note by the Secretariat contains details on the relevant mandate, background and process, objectives and substantive highlights, and links to the proposed 2022-2023 PoW outputs and budget, as appropriate.

- 13. The Coordinator will introduce the Draft Decision on the "UNEP/MAP Medium-Term Strategy 2022-2027" (UNEP/MED WG.515/4). The Meeting is expected to review and discuss the proposed Draft Decision and the UNEP/MAP Medium-Term Strategy 2022-2027, which was prepared through an inclusive process and under the guidance of the Bureau, in view of its submission, as appropriate, to COP 22.
- 14. The Coordinator will introduce elements of the Draft Decision on "*Compliance Committee*" (UNEP/MED WG.515/5).
