1. In accordance with the UNEP/MAP Programme of Work 2020-2021 adopted by the 21<sup>st</sup> Ordinary Meeting of the Contracting Parties to the Barcelona Convention and its Protocols, Naples, Italy, 2-5 December 2019, the Secretariat is organizing the 8<sup>th</sup> Meeting of the Ecosystem Approach Coordination Group, on 9 September 2021, via videoconference.

2. The main objectives of the Meeting are to:

- Provide updated information on the status of the implementation of the Ecosystem Approach roadmap since the 7<sup>th</sup> Meeting of the Ecosystem Approach Coordination Group, Athens, Greece, 9 September 2019;
- (ii) Take stock of the progress made related to the implementation of the Roadmap and the delivery of the 2023 MED QSR;
- (iii) Review and endorse as appropriate the proposed 2023 MED QSR methodology, outline, structure and contents, and the 2023 MED QSR Communication and Visibility Strategy; and
- (iv) Provide guidance, and endorse as appropriate, proposals by the CORMONs and/or MAP Component Focal Points related to technical aspects of IMAP implementation.
