## Agenda Item 2: Consultations on draft resolutions and decisions for UNEA 5.2.

This note serves as a background document for consideration of Agenda Item 2: *Consultations on draft resolutions and decisions for UNEA 5.2.* It contains a revised draft decision on provisional agenda, date and venue of UNEA-6, following consultations at the CPR subcommittee meetings on 9, 11 and 25 November 2021, which includes proposals made by Member States, as well as a new draft paragraph prepared by the secretariat that addresses the use of the acronym "UNEP" as the short form of the United Nations Environment Programme, the adjustment of the logo and visual identity of UNEP, in accordance with option 1 in the background document presented by the Secretariat at the CPR subcommittee meeting on 12 September 2019.

The draft also includes a paragraph on the endorsement of the Process for review by the CPR, as referred to in paragraphs 9-13 of <u>UNEA decision 4/2</u> and in line with the recent agreement as reflected in paragraphs 24-26 of the <u>Chair's Summary of the 8<sup>th</sup> meeting of the annual subcommittee</u>. It further includes a draft paragraph, in brackets, on the <u>action plan for the implementation of paragraph 88 of the outcome document of the United Nations Conference on Sustainable Development</u>, as prepared by the secretariat following the request outlined in paragraph 14 of UNEA decisions 4/2.

The draft currently leaves the choice of date open, to allow for further discussion and guidance from Member States on this aspect. To facilitate these discussions, the text is accompanied by a note entitled "Secretariat note on the implications of rescheduling UNEA-6", and an "implication matrix", which is the same as was presented to the Committee on 25 November. With regard to the choice of date, the draft takes into account the following guidance from previous UNEA and CPR decisions:.

- Operative paragraph 1 in decision 2/22 decided "to hold its regular sessions in odd numbered years commencing with its third session in 2017."
- Operative paragraph 3 of Decision 3/2 decided "to hold the sessions of the United Nations Environment Assembly, following the fourth session of the Environment Assembly, during the last week of February, unless otherwise decided by the Environment Assembly, at its headquarters in Nairobi, consistent with rule 4 of the rules of procedure."
- Operative paragraph 6 of the Decision of the Extraordinary meeting of the Committee of Permanent Representatives to the United Nations Environment Programme Nairobi, 23 June 2021, decided to recommend "to the fifth session of the Assembly to decide that, on an exceptional basis and without creating a precedent, its sixth session shall be held no earlier than February 2024 to ensure a full two-year term for the Presidency of the sixth session."
- The outcome of the Process for review by the CPR, as agreed at the 8<sup>th</sup> meeting of the annual subcommittee in October 2021.

The choice of date for UNEA-6 will have consequences of the scheduling of future UNEA sessions (e.g. with regard to the 2-year period between sessions and whether or not future UNEA sessions should continue to be held in odd numbered years). It will also have consequences for the approval of future UNEP Programmes of Work and Medium-Term Strategies. See the secretariat technical note (separate document) for further details.

Delegations are invited to further consider the draft decision in view of possible finalization and adoption at the resumed session of UNEA-5.

## DECISION X: PROVISIONAL AGENDA, DATE AND VENUE OF THE SIXTH SESSION OF THE UNITED NATIONS ENVIRONMENT ASSEMBLY

The United Nations Environmental Assembly,

PP1 *Recalling* General Assembly resolutions 2997 (XXVII) of 15 December 1972, 66/288 of 27 July 2012, 67/213 of 21 December 2012, 67/251 of 13 March 2013, 68/215 of 20 December 2013, 69/223 of 19 December 2014, 71/231 of 21 December 2016 and 73/260 of 22 December 2018;

*PP5 Emphasizing* that improving the effectiveness and efficiency of the existing governing bodies of the United Nations Environment Programme plays an important role in delivering on the environmental dimension of the 2030 Agenda for Sustainable Development;

PP6 NEW Recalling Decision 5/3 of the United Nations Environment Assembly, in which, inter alia, the Assembly decided to adjourn the fifth session of the Assembly, and to resume the session by convening at its headquarters in Nairobi from 28 February to 2 March 2022 to conclude the consideration of its agenda;

Also decides that, in accordance with paragraph 10 of Governing Council decision 27/2 of 22 February 2013, the sixth meeting of the Open-ended Committee of Permanent Representatives will take place from XX to XX February 202X, without prejudice to decisions on further meetings of the Open-ended Committee of Permanent Representatives, and requests the Committee of Permanent Representatives to discuss, in consultation with the Bureau of the United Nations Environment Assembly, and decide on the format and agenda of the meeting;
- 3. [Recalls that the decision to hold the sixth session of the United Nations Environment Assembly and the sixth meeting of the Open-ended Committee of Permanent Representatives shall be without prejudice to decision 2/22 that decided that the regular sessions of the United Nations Environment Assembly and the open-ended meetings of the Committee of Permanent Representatives shall be held in odd numbered years commencing with its third session in 2017;] (MOR Del) (EU, DRC Keep)

- 4. *Approves* the provisional agenda for the sixth session as follows:
  - 1. Opening of the session
  - 2. Adoption of the agenda and organization of work
  - 3. Credentials of representatives
  - 4. Report of the Committee of Permanent Representatives

  - 8. Contributions to the meetings of the high-level political forum on sustainable development and implementation of the environmental dimension of the 2030 Agenda for Sustainable Development

  - 10. Provisional agenda, date and venue of the seventh session of the Environment Assembly
  - 11. Adoption of the resolutions, decisions and outcome document of the session
  - 12. Election of officers
  - 13. Other matters
  - 14. Adoption of the report
  - 15. Closure of the session
- 5. *Requests* the Committee of Permanent Representatives, in consultation with the Bureau of the United Nations Environment Assembly, to contribute to the preparation of the annotations to the provisional agenda set out in paragraph 4 above;
- 6. *Requests* the Bureau of the United Nations Environment Assembly, in consultation with the Committee of Permanent Representatives, to define a theme for the Environment Assembly no later than X;
- 7. Strongly encourages Member States to submit draft resolutions for consideration by the United Nations Environment Assembly at its sixth session preferably at least ten weeks in advance of the sixth meeting of the Open-ended Committee of Permanent Representatives, taking into account the theme of the sixth session of the Environment Assembly and the limited time and resources available for the negotiation of the resolutions during the sixth meeting of the Open-ended Committee of Permanent Representatives and the sixth session of the Environment Assembly, without prejudice to the rules of procedure, in particular rule 44;
- 8. Endorses the outcome of the stock-taking meeting for the Process for review by the Committee of Permanent Representatives, as agreed at the  $8^{th}$  meeting of the annual subcommittee of the Committee of Permanent Representatives that took place 25-29 October.
- 9. [Welcomes the action plan for the implementation of sub-paragraphs (a)-(h) of paragraph 88 of the outcome document of the United Nations Conference on Sustainable Development and *notes* that the Executive Director will mainstream elements of the plan into future UNEP medium-term strategies and programmes of work which shall be closely monitored for impact.]
- 10. NEW Decides to adjust the logo and visual identity of the United Nations Environment Programme, in accordance with option 1 in the background document presented by the Secretariat at the Subcommittee meeting of the Committee of Permanent Representatives of 12 September 2019.
