The Chair will present the co-facilitators for informal consultations on draft resolution for UNEA 5.2, following nominations from the UN regional groups and appointments at the meetings of the joint Bureau of the United Nations Environment Assembly and of the Committee of Permanent Representatives held on 8 December and 11 January, followed by an exchange of views with Member States.

Following each presentation, delegations will be invited to present initial comments on the drafts.

- ii. Draft resolution on animal welfare – environment and sustainable development nexus, submitted by Ghana
- iii. Draft resolution on sustainable lake management, submitted by Indonesia
- iv. Draft resolution on the sound management of chemicals and waste, submitted by Switzerland.
- v. Draft resolution on a Science-Policy Panel to support action on chemicals, waste and pollution, submitted by Switzerland.
- vi. Draft resolution on mineral resource governance, submitted by Switzerland.
- vii. Draft resolution on an internationally legally binding instrument on plastic pollution, submitted by Rwanda and Peru.
- viii. Draft resolution on an international legally binding instrument on marine plastic pollution, submitted by Japan.
- ix. Draft resolution on sustainable nitrogen management, submitted by Sri Lanka.
