MINUTES OF THE THIRD CONSULTATION MEETING ON THE EVALUATION OF THE MED POL PROGRAMME

The Third Consultation Meeting on the evaluation of the MED POL Programme took place at the MAP Co-ordinating Unit's office in Athens from 3 to 5 July 1993 and it was attended by the MAP officers involved in the Co-ordination and the implementation of MED POL and by three consultants (see annex, list of participants).

The Meeting, the third of a series of Consultations held in Athens on 7-8 January 1993 (UNEP(OCA)/MED WG. 67/1) and on 17-19 May 1993 (UNEP(OCA)/MED WG. 70/1), was opened by Mr L. Jeftic, Principal Officer, who welcomed the participants and recalled the purpose of the meeting and the results expected.

Mr Jeftic reminded the participants that the meeting was the last and conclusive Consultation on the evaluation of MED POL, the first two having set the basis for the work of the consultants which had been constantly supported by MAP through provision of documents and information.

Mr Jeftic recalled that a draft document had been prepared and that the Consultants had agreed to use the days of the meeting to review it and make the final amendments.

During the days of the meeting joint and individual consultations were held between the consultants and the MAP staff to verify the factual information contained in the draft.

At the end of the meeting, the consultants informed Mr Jeftic that a limited amount of editorial work was still necessary on a number of chapters and that the final texts would reach the Unit in a week time.

Mr Jeftic, after thanking the consultants for the work accomplished, reminded the participants that the document would be transmitted to the Contracting Parties who were to meet in Antalya from 12 to 15 October 1993 on the occasion of the Eighth Ordinary Meeting of the Contracting Parties to the Barcelona Convention.
