## 1. Introduction

1. The EU-funded Marine Litter MED II Project implemented and coordinated by UN Environment Programme/Mediterranean Action Plan (UNEP/MAP) aims to support the Contracting Parties to the Barcelona Convention from the southern Mediterranean region to further expand and support the implementation of the Regional Plan on Marine Litter Management in the Mediterranean. The project's activities are coordinated by UNEP/MAP Secretariat with the support of UNEP/MAP Components (i.e. MED POL, SCP/RAC, SPA/RAC and REMPEC), in close cooperation with the beneficiary Contracting Parties (i.e. Algeria, Egypt, Israel, Lebanon, Libya, Morocco and Tunisia) and the Commission on the Protection of the Black Sea Against Pollution (hereunder referred to as BSC). The Marine Litter MED II project presents a special focus on Decision IG.24/4 on the "Roadmap and Needs Assessment for the 2023 Mediterranean Quality Status Report"; Decision IG.24/10 on the "Main Elements of the Six Regional Plans to Reduce/Prevent Marine Pollution from Land-Based Sources; Updating the Annexes to the LBS and Dumping Protocols of the Barcelona Convention"; Decision IG.24/11 on the "Regional Marine Litter Guidelines", as well as the COP21 Naples Ministerial Declaration.

- 2. The project was launched in September 2020 and aims to achieve three principal outputs:
  - Output A: Enhance national capacities on monitoring and assessing marine litter addressing pressures/sources and impacts to contribute to 2023 MED QSR with quality assured data addressing pressures and effectiveness of measures in line with COP 20 Decision on 2017 MED QSR.
  - Output B: Scale up and expand the implementation of pilot implementation of selected marine litter reduction and prevention measures at national and local level.
  - Output C: Maximize synergies on marine litter actions in the Region with a focus on the collaboration with the Black Sea Commission and GFCM, and other regional partners.

3. Since its launch, the project is progressing towards achieving the implementation of all three project outputs. The present progress report highlights the main activities carried out up to August 2021. It is prepared by UNEP/MAP for the kind consideration and review of the First Steering Committee Meeting of the Marine Litter MED II Project with the aim to review the progress achieved; provide comments and advice; and set the next steps and the way forward for the execution of the on-the-ground activities towards the timely and effective implementation of the Project.

4. The present progress report provides an overview of accomplishments made for each activity (as outlined in the project work plan). This is presented in Chapter 2 titled "Progress Table: Marine Litter MED II Project" providing detailed information for each activity and describing remaining work and arising issues preventing the timely completion of these activities. It also includes response measures taken to address the arising issues.

#### 3. Progress Report on Project Management

5. Progress in the first year of implementation has been mainly focused on the operationalization of the Project in all beneficiary countries and undertaking all necessary administrative and regulatory steps required to launch the on the ground implementation of the activities. In this respect, the budget of the Project was prepared and released in the UN financial system (UMOJA) in early December 2020. According to the General Conditions and SOP No. 5 of the ENRTP/GPGC Framework, unspent funds from 2020 were rolled over to 2021 and the respectively revised budget will be shared with the EC Task Manager for information purposes.

6. In terms of reporting, the UNEP PMU has successfully submitted the first Annual Project Progress Report of the Project, covering the period September to December 2020, including the relevant periodic ENRTP/GPGC traffic light reports.

7. The process for the recruitment of a P2 Project Manager Marine Litter MED II has progressed significantly, a candidate is selected, and the final recruitment steps are expected to be finalized by September/October 2021.

8. The preparation of the Legal Instruments for the activities to be executed by the UNEP/MAP Components that are implementing partners as per the Project Document, namely the SPA/RAC, SCP/RAC, as well as for the BSC, is close to finalization. Due to the COVID-19 situation, full/partial telecommuting arrangements of the UNEP (including UNEP/MAP) staff are currently in place. These have negatively affected the operationalization of the budget in the Umoja system in coordination with UNEP HQs. This in turn has delayed the start of elaboration of the Legal Instruments with the MAP Components. These Legal Instruments will be uploaded in the UNEP Partners Portal and are expected to be signed by both parties by September-October 2021.

9. In the absence of the Project Manager, the Secretariat has recruited a UNV expert since October 2020. The Umoja does not allow adequate access to non-UNEP staff members and this was another difficulty faced during this period. Despite the delays related to the referred Components partners, the Legal Instrument concerning the SPA/RAC is already in place and its first installment was release in June 2021.

10. The Legal Instruments with the national Implementing Partners in the seven beneficiary countries are expected to be operational by September-October 2021 when implementation of national activities can start. To this regard, due to the COVID-19 pandemic, all national administrations of the Marine Litter MED II beneficiary countries have been mostly under full/partial telecommuting arrangements. This reflected on the timetable for development of the Legal Instruments and the implementation of the national activities under the project, as well as the first phase of negotiations of the legal agreements with the beneficiary countries.

#### 4. Interlinkages and Synergies with Other Projects

11. The project ensures complementarities with UNEP/MAP Mid-Term Strategies (MTS) 2016-2021 and 2022-2027, the 2020-2021 and 2022-2023 Programme of Work (PoW). The project will also ensure that synergy and coherence are enhanced as much as possible with other relevant projects and initiatives, and in particular with other EU- and GEF-funded projects (i.e. GEF Adriatic; GEF Med Programme Child 1.1; EcAp MED III; Cooperation Agreement with IMELS; ENI SEIS-MED II; IMAP-MPA; MED PlasticBusters MPAs; INDICIT II; Water and Environment Support (WES); MED REGION; GloLitter; etc.) The reporting period (01/08/2021-15/08/2021) covers the last eight months of project implementation. Due to the delays, tangible synergies with the said projects were not achieved. More concrete input and feedback will be provided during the next reporting cycles. The Marine Litter MED II Project Steering Committee will be encouraged to review the list of relevant projects during each of its meeting.

Regarding the Fishing-for-Litter (FfL) pilots, preliminary discussions have been carried out 12. with a new EU-funded project (LIFE DREAM) for the organization of a tangible synergy pertinent to the demonstration/piloting of a pyrolytic device in the selected ports of the ML MED II project (i.e. production of energy from the collected marine litter, low carbon emission footprint; portable device). The cooperation is mainly planned through the dissemination of the results deriving from the Action E3.1 of the LIFE DREAM Project pertinent to the preparation of a Technical Protocol (LDTP) for marine litter removal and deep reefs restoration (hands-on manual), including a set of guidelines for fishermen and other stakeholders. The plan under this synergy is for the gained experience and lessons learnt from the FfL pilots and the previous and this version of the project, including the 2016 UNEP/MAP FfL Guidelines, to be integrated into the LDTP. The LDTP will: (i) represent a tool helping the decision makers in choosing the most appropriate option for managing the technical aspects connected to marine litter in the deep sea; and (ii) present an innovative and up-to-date approach that relies on an integrated evaluation of the costs/benefits associated with the removal operations. UNEP/MAP will also support LIFE DREAM project to maximize the impact of the transferability actions including those linked to the use of the prototype to selected marine parks and/or fishermen ports to demonstrate and transfer protocols and approaches developed by the LIFE DREAM Project.

#### 5. Gender aspects

13. Gender balance and equity are among the ML MED II Project's core values, and pertinent provisions are taken into account in Project's activities. Gender equality and women's empowerment are also recognized as a cross-cutting priority across all aspects of UNEP's work, including for UNEP/MAP. The Secretariat, through its core work but also through projects' implementation, promotes women and men's participation in all environmental protection and sustainable development activities.

14. Provisions for gender balanced participation is also included in correspondence between UNEP/MAP and the beneficiary Countries for the nomination of Project Focal Points, as well as in the future calls for the recruitment of experts/consultants.

15. The Secretariat is exploring ways and means to streamline gender parity and gender dimension in the Project activities from the substantive point of view based on best practices from other projects and at UNEP level.

16. For the selection of experts and executing partners at national level under the Project activities of the Marine Litter MED II Project it is also required to take into consideration the gender equality.

#### 6. Communication

17. Since the launch of Marine Litter MED II, the approved Communication and Visibility Plan is taken into consideration and the following communication, visibility and outreach activities have been undertaken.

18. An official letter was sent by the UNEP/MAP Secretariat on 8 April 2021 to the MAP Focal Points, informing them about the launch of EcAp MED III and of the other ENRTP-GPGC-funded Project Marine Litter MED II.

19. The preparation of a brochure of the Project has started in cooperation with Communication Officer at UNEP/MAP; contents are currently under internal development, and its finalization has been included in the Secretariat's procurement planning.

20. A dedicated URL link has been created under UNEP/MAP Website where dedicated information and documents are included.<sup>1</sup>
