The paradoxical negotiations of the political declaration for UNEP@50

We are celebrating the 50th Anniversary of UNEP. Among its tasks, UNEP promotes the coherent implementation of the environmental dimension of sustainable development. Over the last 50 years, a great number of legally binding and non-legally binding resolutions have been adopted to protect our environment. Despite this growing body of norms, our planet's health continues to deteriorate due to the lack of strong governance and the rule of law. Without them, environmental protection is a fantasy. This is precisely why commitments adopted under the UNFCCC, the Kyoto Protocol, the Convention on Biological Diversity, or the Convention to Combat Desertification- to cite but a few - have not been achieved thereby compromising inter e intra generational equity.

UNGA Resolution 73/333 was adopted to revert this course particularly through enhancing the implementation of existing obligations and commitments under IEL. However, the process of negotiations towards

the political declaration for UNEP@50 is worrying. It seems that several countries do not understand that the principle of common but differentiated responsibilities (CBDR) enshrined in principle 7 of the Rio Declaration with the purpose to cooperate in a spirit of global partnership to conserve, protect and restore the health and integrity of the Earth's ecosystem does not work without a robust governance and rule of law. Thus, claiming it while trying to diminish them is a paradox. The very same happens with the "human right to a healthy environment" recognized by resolution 48/13 of the Human Rights Council. Without that right, the health and integrity of the Earth's ecosystem is impossible and therefore the CBDR principle can be written thousands of times and it will still not be effective. If the right to a healthy environment is not guaranteed, Agenda 2030 and many of the SDGs' targets won't be achieved. Thus, positions against that right are equal to fighting the CBDR principle and the Agenda 2030 - yet another paradox. We cannot afford to waste resources and time anymore. Political goodwill is precisely what we lack at this point and this undermines the credibility of the institutions negotiators work.
