**2. Briefing on the preparations for the international meeting entitled “Stockholm+50: a healthy planet for the prosperity of all – our responsibility, our opportunity” (Stockholm+50)**

Following the preparatory meeting on Stockholm+50, convened by the President of the General Assembly and chaired by the co-hosts of the international meeting, held at the United Nations Headquarters on 28 March, the Secretariat will provide a briefing to Member States on the preparations, including on logistical arrangements and the outcome of the preparatory meeting, for the Stockholm+50 to be held on 2 and 3 June 2022 in Stockholm to commemorate the 50 years since the United Nations Conference on the Human Environment, followed by an exchange of views with Member States.

**3. Update on the ongoing work of the United Nations Environment Management Group**

The Secretariat will provide an update on the achievements and ongoing work of the UN Environment Management Group (EMG), including on the contribution of the UN Environment Management Group to Stockholm+50 on the basis of a highlight report. The Committee will be invited to take note of the information and to provide inputs and guidance to the work of the EMG, as appropriate.

**7. Initial evaluation of the resumed fifth session of the United Nations Environment Assembly (UNEA 5.2) and the first special session of the United Nations Environment Assembly on the commemoration of the fiftieth anniversary of the establishment of the United Nations Environment Programme (UNEP@50)**

The Secretariat will present a preliminary analysis of the online survey on the resumed fifth session of the UN Environment Assembly (UNEA-5.2) and the first special session of the UN Environment Assembly on the commemoration of the fiftieth anniversary of the creation of UNEP (UNEP@50). The presentation will be followed by an exchange of views with Member States and stakeholders on lessons learned, in view of a more in-depth assessment at the next scheduled subcommittee meeting in May 2022 and final consideration at the 158th meeting of the Committee of Permanent Representatives on 26 May 2022.
