Draft Summary of the Meeting of the Bureau of the UN Environment Assembly

Agenda Item 1: Opening of the meeting and adoption of the agenda.

1. The President of the fifth session of the United Nations Environment Assembly, H.E. Mr. Espen Barth Eide, Minister of Climate and the Environment of Norway, opened the final meeting of the UNEA-5 Bureau, expressing his deep appreciation to all fellow Bureau members including to the Chair of the Committee of the Whole, for their hard work and leadership. A list of meeting participants can be found in the Annex.
2. After introductory remarks of Ms. Inger Andersen, Executive Director UN Environment Programme, the agenda was adopted.

Agenda Item 2: “Preparations for resumed fifth session of the United Nations Environment Assembly”

3. Under this broad agenda item, the Bureau addressed several important sub-items, as follows:

I. Outcome of the Committee of the Whole

4. H.E. Minister Andrea Meza, in her capacity as the Chair of the Committee of the Whole, provided an update on the status of negotiations on the draft resolutions and decision. Minister Meza indicated that as a result of the consultations held by the three contacts groups from Monday to Tuesday evening, ten finalized draft resolutions and one decision have been recommended for adoption by the Environment Assembly. Further consideration of one draft resolution should continue on an informal basis with a view to presenting a consensual text for consideration and possible adoption by the Environment Assembly.
5. The Secretary informed that the final versions of the draft resolutions as endorsed by the Committee of the Whole are available in the papersmart portal. The President welcomed the outcome and commended Minister Meza for her excellent work as the Chair of the Committee.

II. Update on the draft ministerial declaration for UNEA-5.

6. The President informed that following several bilateral meetings, a slightly amended final version of the draft Ministerial Declaration had been made available in paper smart portal for adoption by the Assembly.

III. Credentials report for UNEA-5.2.

7. Mr. Stadler Trengove, Principal Legal Advisor, presented the draft credentials report. The Bureau of the United Nations Environment Assembly examined the credentials as presented and agreed to submit its report to the Assembly, in accordance with rule 17 of the UNEA Rules of Procedure.
8. With regard to Myanmar, the Bureau decided to recommend that the UN Environment Assembly defer any action on their credentials pending further guidance from the Credentials Committee of the UN General Assembly.

IV. Election of the UNEA-6 Bureau

9. The Secretariat provided an update of nominations for the Bureau of the 6th session of the United Nations Environment Assembly, as follows:

10. H.E. Ms. Leila Benali, Minister of Environment of the Kingdom of Morocco, as President of the sixth session of the United Nations Environment Assembly; and H.E. Mr. Abdou Karim Sall, Minister of Environment and Sustainable Development of Senegal, as Vice-President, nominated by the African States Group.
