Introduction

- 1. At the kind invitation of the Government of the Republic of Turkey and in consultation with the President and members of the Bureau, the 92nd Meeting of the Bureau of the Contracting Parties to the Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean (Barcelona Convention) and its Protocols will be held in Istanbul, Turkey on 24-25 March 2022.

- 13. The Secretariat will present an update on the status of ratification of the Barcelona Convention and its Protocols. The Bureau is expected to discuss ways to further promote ratification of the Barcelona Convention and its Protocols.
- 14. The Secretariat will also provide an update on the status of implementation of Decision IG.23/1 on *Revised Reporting Format for the Implementation of the Barcelona Convention and its Protocols*, and of Decision IG.24/1 on *Compliance Committee*.
- 15. The Bureau is expected to discuss these issues and provide its guidance.

- 16. The Secretariat will inform on the progress mainly on the processes and on the actions taken as well as to the next steps for their efficient delivery.
- 17. The Bureau members will be invited to discuss, and provide guidance on the way forward, considering also the text of the relevant COP 22 Decisions and of the Antalya Ministerial Declaration.

(c) Collaboration and Partners

18. The Secretariat will update the Bureau on the efforts to contribute to regional governance and cooperation, as well as to create new partnerships and strengthen and update existing ones, in order to enhance the impact of the MAP-Barcelona Convention system. With reference to Decision IG.19/6 on MAP/Civil society cooperation and partnership, the Secretariat will present to the Bureau members the outcome of the evaluation of the application received by a civil society organization for accreditation as MAP Partner, for the Bureau's review and possible endorsement.

(d) Outreach, Communication and Advocacy

19. The Secretariat will report on the information and communication activities and on the plans for the current biennium in this area, in the context of the UN Ocean Conference, UN CBD, UNFCCC, etc. The Bureau will be invited to provide its views and considerations on this matter and to advise on how to further enhance the outreach, visibility and impact of the MAP – Barcelona Convention system including on the outcome of COP 22.
