### Introduction

- 1. In accordance with the UNEP/MAP SPA/RAC Programme of Work 2022-2023 adopted by the 22<sup>nd</sup> Ordinary Meeting of the Contracting Parties to the Barcelona Convention and its Protocols, Antalya, Turkey, 7-10 December 2021, the SPA/RAC is organizing the Meeting of the Ecosystem Approach Correspondence Group on Monitoring (CORMON) for Biodiversity and Fisheries, on 28 and 29 March 2022 via videoconference. All the SPA/BD Focal Points, and/or Ecosystem Approach Coordination Group Members and the relevant partners for IMAP implementation, as appropriate, have been invited to designate their representatives to the CORMON meeting. The relevant intergovernmental or non-governmental organizations have been invited to designate their representatives to the meeting as observers.
