#### b) UNEA resolution 5/3: Future of the Global Environment Outlook

This background document has been developed by the Secretariat to inform the Committee of Permanent Representatives on overall progress made in the implementation of UNEA resolution 5/3: Future of the Global Environment Outlook. More specifically, it includes detailed information on the following aspects of the GEO-7 process:

- Status update on establishing the Intergovernmental and Multi-stakeholder Advisory Committee (IMAG), meant to advise the ED on the GEO-7 process.
- Status update on convening of the first open ended expert meeting on GEO-7 (19-22 September, online), which focused on procedural matters.
- Status update on convening of the second open ended expert meeting on GEO-7 (17-20 October, in person), which will focus on scoping of GEO-7, and the related first meeting of the IMAG.
- Outline a roadmap and present planned next steps after the September and October meetings.

The nomination process for the Intergovernmental and Multi-stakeholder Advisory Group (IMAG) has been completed and the Secretariat has proposed a membership of the IMAG which respects disciplinary and gender balance and ensures geographic balance across UN regions, as requested in the resolution.

Member States are invited to provide guidance to the Secretariat on the further implementation of this resolution.

## Progress made in implementation of UNEA resolution 5/3 on the Future of the Global Environment Outlook and next steps

1. Following the briefing on the implementation of <u>UNEA resolution 5/3 Future of the Global Environment Outlook</u> to the Committee of Permanent Representatives provided at its meeting of the subcommittee on 16 June 2022, the Secretariat has facilitated the nomination process for the Intergovernmental and Multi-stakeholder Advisory Group (IMAG) and the nominations for the two inaugural meetings of an open-ended expert group on GEO-7, with the aim of establishing the procedures and time frame for preparing GEO-7 and define its scope.

## The Intergovernmental and Multi-stakeholder Advisory Group

2. In response to the request for nominations to the IMAG from the Executive Director to Member States and accredited stakeholders dated 17 June 2022, the Secretariat received 52 nominations from Member States and 37 nominations from accredited stakeholders for positions on this advisory body. Table 1 outlines the regional and gender distribution of nominees from Member States.

3. Based on these nominations and a thorough review of their CVs, as well as informal consultations with chairs and representatives of the UN regional Groups in Nairobi, a proposal has been prepared by the Secretariat which would select 25 Member State experts (five per UN region) to be represented in the IMAG. Table 2 provides an overview of the geographic and gender distribution of the proposed composition of the IMAG.

4. Further, the Secretariat has received nominations from experts from accredited Major Groups and Stakeholders to fill 10 seats within the IMAG. Following a thorough review by the Secretariat, 10 Stakeholder experts have been selected, taking into account balance across different Major Groups relevant to the GEO, geographic balance, and gender balance. See Table 3.

### Open ended expert meetings for GEO-7

- 6. In mid-June the Executive Director issued a request for nominations of experts to attend the first two open ended expert meetings for GEO-7 by Member States and stakeholders. In addition, UNEP proceeded to invite dedicated experts form academia to support the meeting, in particular experts in the areas energy, food and waste/circularity systems as well as climate change adaptation experts.
- 7. These nomination process resulted in 258 experts nominated for the first meeting focusing on procedural matters to take place online 29-22 September, and 246 experts nominated for the in-person (hybrid) meeting of the open-ended group scheduled for 17-20 October to consider and approve the scope of GEO-7.

10. The high interest from Member States and Stakeholders to be represented at these expert meetings will ensure insightful discussions and thorough consideration of the matters at hand.

## $\frac{\textbf{Possible outcomes and next steps after the open-ended meetings if experts in September and}{\textbf{October}}$

- 11. <u>The Secretariat will provide an oral update at the 159<sup>th</sup> meeting of the Committee of Permanent Representatives on the Outcome of the first open ended expert meeting for GEO-7 scheduled for 19-22 September focusing on procedural matters.</u>
- 12. The plan for the open-ended expert meeting in October is to convene expert dialogues with the aim to review and approve a scoping document for GEO-7. This is meant to inform Member States about a solutions-focused approach for GEO-7. The expert dialogues are also meant to elicit key policy questions that Member States would like GEO-7 to answer. An online questionnaire, in all UN languages, will also be distributed prior to the meeting to obtain feedback on key questions that GEO-7 should attempt to answer.
- 13. It is anticipated that a scoping document will be approved at the October meeting, allowing the Secretariat to initiate a call for expressions of interest from collaborating centres with specific areas of expertise to support the GEO process. In addition, the Secretariat expects to establish the profiles of expertise required for each of the chapters of the GEO-7, following approval of an annotated outline following the scoping meeting planned for 17-20 October. From these profiles, a call for expressions of interest will be sent to Member States, institutions, and groups of experts to seek interest in contributing to the GEO-7.
- 14. The call for expressions of interest are expected to open in early November 2022 and close by the end of the year. From these expressions of interest, a group of authors will be selected to attend a first GEO-7 author's meeting, tentatively planned to take place from 6-10 March 2023 in Bangkok, Thailand.
- 15. From the call for collaborating centres, the Secretariat will select organizations that have the required expertise and interest to partner with UNEP during the production of GEO-7. Member States will be kept informed of any outreach to institutions in their countries in this regard.
