Addendum to the existing information that might assist policy makers

1. Table 1 presents an updated and expanded non-exhaustive listing of information that might assist policy makers in the negotiations on an international legally binding instrument on plastic pollution, including in the marine environment. This document builds on the information provided to the ad hoc open-ended working group in information document UNEP/PP/OEWG/1/INF/3¹. Relevant existing information listed in table 1 of the present note can be found among the various resources in [the platform](#). The platform facilitates detailed searches by sorting of information according to tags such as for the relevant subparagraphs of UNEA resolution 5/14 as well as tags referring to relevant sectors, stages of the plastics life cycle and pathways from source to sea. This approach allows for a dynamic, up-to-date listing of information through a “living” knowledge resource where information is shared as presented by relevant stakeholders on a continuous basis.
