Stakeholder dialogue at the first session of the intergovernmental negotiating committee to develop an international legally binding instrument on plastic pollution, including in the marine environment

I. Introduction

Pursuant to paragraph 3 (1) of United Nations Environment Assembly resolution 5/14, entitled "End plastic pollution: towards an international legally binding instrument", the instrument would include provisions to encourage action by all stakeholders, including the private sector, and to promote cooperation at the global, regional, national and local levels. To facilitate an additional opportunity for the committee to exchange views with stakeholders participating in the first session of the intergovernmental negotiating committee (INC-1), the secretariat is organizing a stakeholder dialogue in the afternoon of Tuesday, 29 November 2022, from 3 p.m. until 6 p.m., local time, GMT-3. The session will be in a hybrid format, with simultaneous interpretation provided in the six UN languages.

II. Focus and Objectives

- 1. The objective of the stakeholder dialogue is to:
 - Support the committee to effectively consider stakeholders actions, as well as needs and interests in the intergovernmental negotiations.
 - Further facilitate a two-way dialogue between Member States and stakeholders to allow for a diversity of voices during the negotiations on the historic resolution to develop a legally binding instrument.
 - Provide a space to share ideas with the committee on the future of the multi-stakeholder forum and dialogue as well as on how to initiate a multi-stakeholder action agenda.
- 2. The stakeholder dialogue will build upon the key outcomes of the Multi-stakeholder Forum, taking place in conjunction with the INC-1 on 26 November 2022. The key outcomes and messages from the Forum will be summarized at the opening of the dialogue's session.
