Informative document for the 2nd Meeting of the UNEP Working Group on Nitrogen.

Note on the *ad hoc* Task Team to examine the possible Terms of Reference for an Interconvention Nitrogen Coordination Mechanism (INCOM)

Summary: At the first meeting of the UNEP Working Group on Nitrogen, it was agreed to establish an *ad hoc* Task Team to examine the possible Terms of Reference for an Interconvention Nitrogen Coordination Mechanism (INCOM) as described in NWG Briefing-1 /Inf. Doc. 2. It was originally envisaged that the Task Team would report back to the 2nd meeting of the Nitrogen Working Group ahead of the fifth session of the UN Environment Assembly (UNEA-5). The Task Team met seven times, allowing it take into consideration experience from UNEA-5, and reflect on both UNEA resolutions 4/14 and 5/2. This note summarizes the approach and membership of the Task Team. The report prepared by the Task Team is submitted in an accompanying document to the 2nd meeting of the UNEP Working Group on Nitrogen.

Approach taken by the Task Team

- 1. The Task Team adopted the approach as set out in the document, NWG Briefing-1/Inf. Doc. 2, ¹ with some refinements according to need:
 - a. Membership was established as agreed, representing a range of expertise on international conventions and programmes including from interested Member States to consider the options for establishing possible Terms of Reference (ToRs) for an Interconvention Nitrogen Coordination Mechanism (INCOM).
 - b. The work of the Task Team was conducted over a longer period than originally anticipated, which allowed for the incorporation of valuable findings linked to engagement at UNEA-5.2.
 - c. The establishment document noted that the Task Team may make proposals for consideration by the Nitrogen Working Group. In the light of experience from UNEA-5.2, the group agreed to focus on further consideration of <u>options</u> "for facilitating improved coordination of policies across the global nitrogen cycle" (UNEA resolutions 4/14 & 5/2), to inform consensus development by the Working Group.
 - d. The Task Team worked using e-meetings and email from June 2020 to December 2022, including seven e-meetings over this period.
 - e. The Task Team was chaired by the Director of the GEF/UNEP project "Towards the establishment of an international nitrogen management system" (INMS), benefiting from the project funding as part of its work under INMS Component 4.
 - f. In addition to contributions to the Task Team from the UNEP Law Division, the INMS funding enabled the expert legal involvement of Tallavey Sustainability in preparing the group report.
