Introduction

The UNEA Monitoring and Reporting Portal is a dedicated platform for **monitoring** and **reporting** of progress in the implementation of UNEA resolutions, decisions and declarations.

Background

15 March 2019: UNEA adopted Resolution 4/22 on the Implementation and follow-up of UNEA resolutions.



27 February 2020: CPR agreed on reporting framework, which constituted the development of the UNEA Monitoring and Reporting Portal



16 October 2020: UNEP launched the first version of the portal and presented it to the CPR meeting.



25 October 2022: UNEP Presented portal updates and encouraged Member States and Stakeholders to using the portal.

Dedicated - Reports to CPR as per relevant agenda items

PPR - Updates through annual and biennial PPR

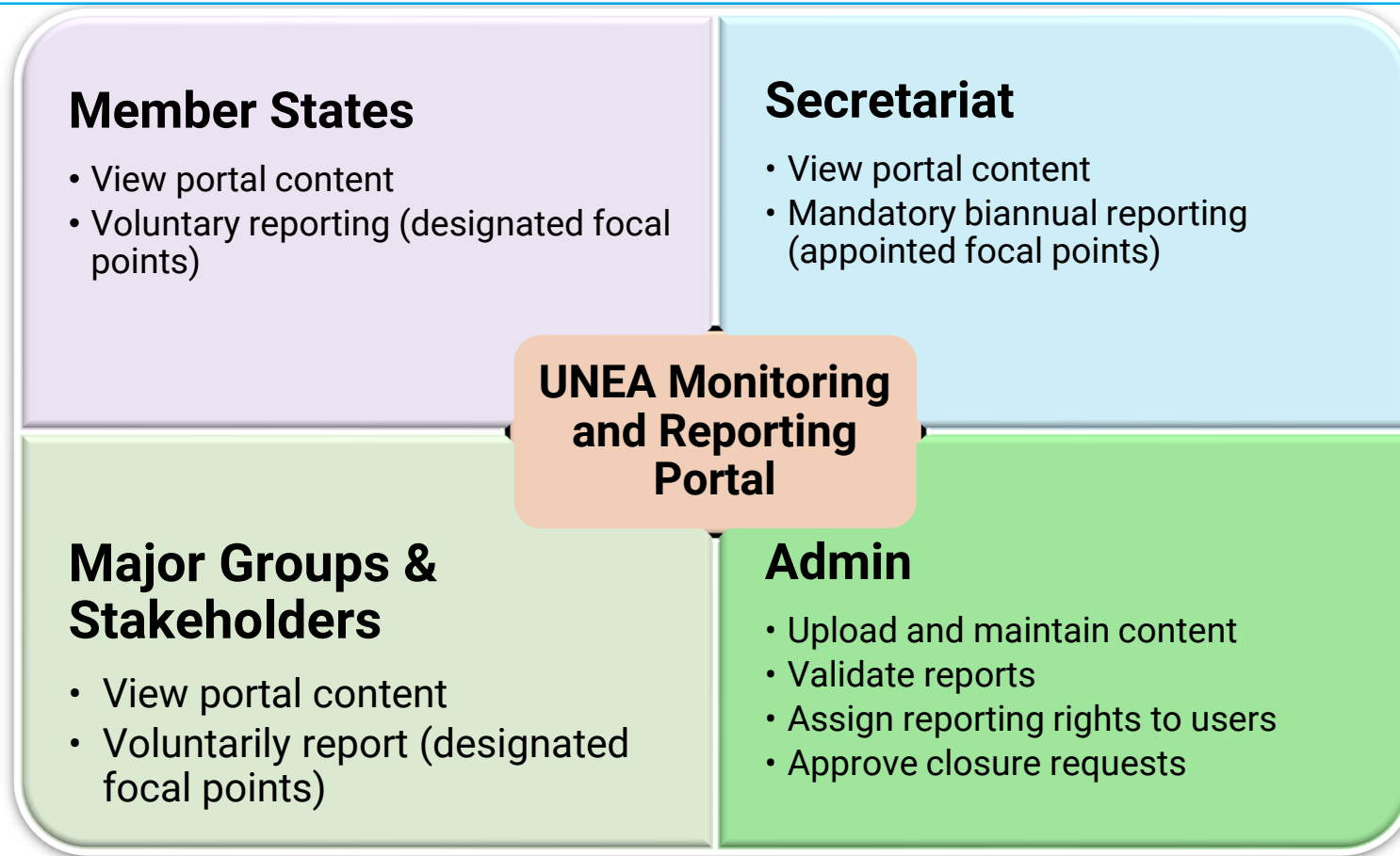

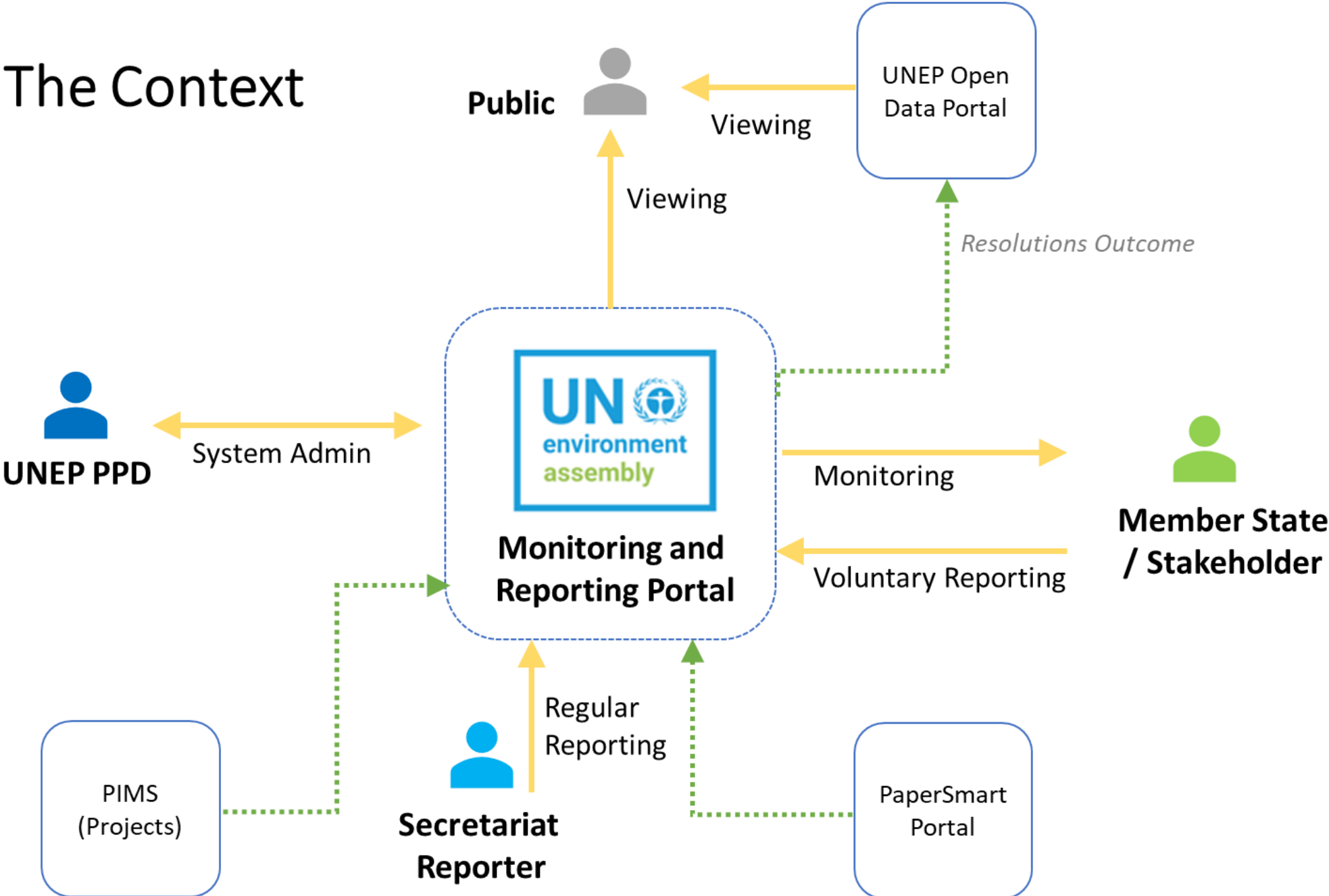


Designating Reporting Focal Points

- Users who already have access and wish to report can send a Note Verbale to unea-monitoring-support@un.org, confirming their roles as reporters for their delegation.

Registration Procedure

- The portal is publicly accessible. For reporting, you are required to log in.


Next steps after registration

- Once your registration is processed, you will receive confirmation from unea-monitoring-support@un.org with necessary instructions to login.

UNEP Open Data Portal

➤ Reporting, however, remains restricted to ensure that only authorized focal points submit reports on behalf of their entities.
